Los Angeles County Land Acknowledgment

1. Commissioner 'Reports on Detention Facilities. (23-2435)

Commissioner Joahanna Terrones and Commissioner Mary Veral

 Men's Central Jail (MCJ), 441 Bauchet St., Los Angeles, CA. 90012, June 19, 2023

Commissioners Terrones and Veral reported that there were at least three open fires in the 4-person cells in 2400 and that the entire module smelled like a campfire. They also noted the smoky air made it difficult to breathe. The row and area around the deputy desk smelled like smoke and nothing was being done about this safety issue, including no alarms or deputy intervention. Commissioners were on the row for a significant period of time and no deputies walked the row during our time there. This issue was reported at the time of the inspection and the administrators/supervisors indicated they were already aware of the problem. Additionally, the discipline (DRB process) was discussed as it appears people are being given punishment without proper due process.

5. Discussion and Action on the EBI Survey Results (Commissioner Dr. Cheryl N. Grills). (23-2439)

Commissioner Dr. Grills reported that the Education Based Incarceration (EBI) Survey which was conducted by the Sybil Brand Commission (SBC) at the direction of the Los Angeles County Board of Supervisors (BOS), was completed and submitted to the BOS Justice deputies. Six months has passed without any response from the Justice deputies regarding what was done with the report.

Chairperson Clayton - Johnson recommends that the SBC send a letter to the Justice deputies and the LASD to determine what actions, if any were taken regarding the EBI program.

By Common Consent, the SBC agreed to sending a letter to the Justice deputies and the LASD regarding actions taken relative to the EBI program.
