## I. ADMINISTRATIVE MATTERS

## II. DISCUSSION

**3.** Discussion about finalizing the recommended list of survey questions to be included in the listening session reference guide. (23-4559)

Commissioner Peña opened the floor for discussion regarding finalizing the recommended list of survey questions to be included in the listening session reference guide.

Discussion ensued and Executive Director Tiara Summers reminded Commissioners that the YEC will provide the general questionnaire, while the Commissioners of each Supervisorial District will provide specific questions during their listening sessions.

Commissioners made the following suggestions:

- Questions regarding demographics should be changed to remove "race" and retain "ethnicity."
- Offer an option under "gender" to disclose if the youth is a member of the LGBTQ+ community under an "other" prompt, rather than a primary question.
- Include location such as: City, SPA, or Supervisorial District.
- All acronyms should be spelled out.
- Specify that Foster Care falls under the Department of Children and Family Services.
- Include a prompt for "Entertainment/Extra Curricular Activities."
- Include a question regarding aspects of healing with a list of possible activities such as poetry, yoga, etc.
- Each District can decide to include specific questions in their questionnaire, such as involvement in Commercial Sexual Exploitation of Children (CSEC).

Executive Director Summers reiterated that the collected data is meant to inform the work for the following year, so that data collected in 2024 will be utilized toward the work in 2025. The finalized document will be presented to the full Commission for their approval.
