1. Call to Order, Roll Call, and Land Acknowledgement. (24-3395)

II. DISCUSSIONS

3. Discussion about upcoming Listening Sessions. (24-3581)

Chair La'Toya Cooper reported that the Third District Listening Session is scheduled for Saturday, September 14, 2024 from 11:00 a.m. to 3:00 p.m. and will be held at Valley College.

Chair La'Toya Cooper and Commissioner Clarissa Peña expressed their enthusiasm for the event and recommended those listening to attend.

4. Discussion about planning for the YEC End-Year Event in October and current survey results. (24-3586)

Chair La'Toya Cooper opened the floor to discussion regarding the planning of the YEC End-Year Event (Event). She reported that the Event will be held on October 26, 2024, from 11:00 a.m. to 3:00 p.m. at the Department of Mental Health building located on Vermont Avenue.

Two sample agendas were presented, and a discussion ensued regarding the information that will be shared during the District Presentation and the YEC Data Presentation. After the discussion, Commissioners agreed that the YEC will compile the data into a PowerPoint Presentation for Commissioners to report at the Event.

Tiara Summers, Executive Director, Los Angeles County Youth Commission (YC), advised that staff will prepare a presentation draft prior to the YC meeting in September. She also provided insight on how the data collected for their report is structured, highlighting that the report can guide their PowerPoint Presentation. Final data obtained from the YEC survey will be provided to the Commissioners after the Third District Listening Session.

Additional discussion ensued regarding the agenda items and structure, and Commissioners agreed to update the itinerary by including breakout sessions.

5. Discussion about revising the YEC survey questions for 2025. (24-3649)

Chair La'Toya Cooper opened the floor to discussion regarding revising the Youth Engagement Committee (YEC) survey for 2025 based on feedback received from the 2024 Listening Sessions.

The following revisions were proposed:

- **On question No. 2: Change the word “negatively” to “challenging” and change the verbiage to read: “What systems did you have challenges with?”**
- **On question No. 3: Change the verbiage to read: “What systems supported you best?”**

Tiara Summers, Executive Director, YC, added that the purpose of revising the survey is to ensure that the data collected is targeted to a specific system.

A discussion ensued regarding rephrasing the questions and possibly introducing a new survey. Commissioners agreed to continue the discussion at the next YEC meeting.
