Roll Call. (24-3697)

Chairperson Raymond Regalado called the meeting to order at 9:16 a.m. Followed by the reading of the LA County Land Acknowledgement. A quorum of in-person members was confirmed. Commissioner Joahanna Terrones arrived at 9:23 a.m. Commissioner Puja Bhatia left the meeting at 12:27 p.m.

I. REPORTS

1. Commissioners Reports on Detention Facilities. (24-3698)

Commissioner Eric J. Miller reported out on the MCJ inspection noting that there has been improvement in the way the LASD monitors conditions by removing non-jail tv screens. Concerns during the visit included leaks throughout, consistent flooding, mold present in 1750 and 5900, black mold in 1750s vent walls, rats in vent system, holes in the walls, 5900 showers are scalding hot, and water fountains were putting out hot water.

Commissioner Broder reported that due to overcrowding there were mattresses on the floor which were reported to the Watch Commander who acknowledged a policy of no mattresses on the floor and stated he would

address the matter. 8000 has no wheelchair accessible transportation, the Watch Commander stated that is not the case and would follow up. The SBC requested that the disabled incarcerated people take a bath instead of a shower. People had burns from the scalding hot showers. Tenting was reported due to a lack of privacy and suggested education on tenting could be helpful for the units on why tenting operations occur.

Commissioner Miller raised the sanitary issues that plague the MCJ such as rat feces and urine in the food in 5000 and 5900. Fish Kits for personal hygiene are lacking in 5900. And noted that personal hygiene overall is a big issue.

Commissioner Broder noted that there is a big group of transgender women requesting to move to CRDF. A comprehensive list of medical concerns was sent to Dr. Henderson and the Watch Commander who answered that the requests were received. Medical and health issues are inadequate such as hormone shots, not getting prescriptions refilled or receiving the wrong dosage.

Commissioner Veral noted that an intimidation tactic was used by the Deputy in 1750, where he followed them throughout during their inspection. The Deputy was reported to the Watch Commander who asked the Deputy to back off. Security checks are not being done, and there is a staffing issue due to a lack of deputies. Additionally, security checks are not happening, and complaint forms are not being addressed. A complaint box at 9000 had about 20 forms that had not been addressed.

Commissioner Miller reported on 9000 and 5900. Noting that both support triple bunking and lack the capacity to adequately house people. And that some parts of the jail are overcrowded, and others are underutilized.

Commissioner Broder stated that earthquake and fire safety continues to be an issue. And noted that 8000 has alarms that beep 24/7.

Commissioner Broder reported on the Lakewood Sheriff Station noting that everything was running smoothly. Except for an issue with a broken toilet in which Sheriff's personnel indicated would be repaired. And an issue concerning the transportation of the incarcerated people to jail.

Chairperson Regalado and Commissioner Veral discussed the issues at CRDF. Commissioner Veral reported that the elevators are consistently inoperable which causes operational problems. 2600 dorm houses around 79 inmates and has only one Deputy stationed there, and cleanliness being an issue. Those housed in 2600 have expressed interest in attending a

constructive program while serving time. And noted that those housed do not seem to be receiving adequate outside time, and many suffer from mental health issues which leads to behavioral issues that then lead to lockdowns. Medical alert buttons go off but are not being addressed. And feminine products although available are reliant upon Deputies to access them.

Chairperson Regalado noted that transportation is an issue and is impacting the incarcerated people's ability to appear to court dates, impacting jails and courthouse schedules.

Commissioner Broder asked the question of whether they noticed a lack of feminine products? Chairperson Regalado indicated that his understanding is that when there is a lack of product at the warehouse it becomes an issue with inmate distribution. This is across modules 1300, 21 and 26.

Chairperson Regalado and Commissioner Terrones discussed the Avalon Station inspection. Commissioner Terrones indicated it was a good visit. And that it is a small facility with not a lot of activity. There is one Deputy and one jailer with the Courthouse being close by.

Chairperson Regalado noted that the fire gear they use was in working condition but expired.

Assistant Sheriff Paula L. Tokar introduced herself then discussed the personnel concerns and sked the SBC that when there is a personnel issue to provide the LASD with pertinent employee information, name, date, time, location so that they can take the appropriate action. She informed the SBC that she has taken on Tenting and that there are clothing exchanges, and the exchanges are documented in the Uniformed Daily Activity Log (UDAL). She reported that once the budget is approved in October, the LASD plans to implement a tv dinner pilot program in 2100, and 2300 as early as the start of the year to address the food concern. She agreed that overcrowding is an issue and that a reduced population for the LASD to make positive changes to the environment. Regarding the transgender women who want to go to CRDF the LASD has a gender responsive review board and a process, and provided their names they can check if they are on the board and or the reason. She apologized regarding the escorts, but that some oversight boards to want escorts such as the OIG. And reported that the elevators at CRDF are being addressed. And will get the 2600 EBI information to the SBC. She informed that there is a settlement agreement with the Department of Justice (DOJ) that stipulates people need to get out of their cells, and that there are audits on this that get sent to the DOJ. She reported that that buses are being ordered and hope they arrive in January to address the transportation issue and impact on

missed court dates. And discussed the people that refuse to go to court, and therefore the LASD plans to start using body cams which are arriving at MCJ in the next couple of months to use as a record. She confirmed that the ADA transfers are a problem, and that one of the issues is the accommodations at the state. The feminine products order at CRDF has been tripled to address the shortage. And the Air packs at Avalon got funded and will be replaced.

Commissioner Veral expressed the supervision issue at MCJ is not happening and asked Assistant Sheriff Tokar if she can assist with this matter. And that a replacement for MCJ would not fix any of the issues. Lastly, asked not to refer to inmates as bodies, they are people.

Commissioner Miller raised the issue of the LASDs culture administering the jails. There are two cultures, 1. Culture of punishment, 2. Care First culture which is very much the minority. And part of the culture is the consistent dehumanization of individuals who are incarcerated and the constant reference of “bodies” and encourage the LASD in getting back to basics under Title 15 to rehumanize individuals. The SBC is prohibited from visiting the jail no more than twice a month, and not everyone has clearance from the Sheriff’s Department. And there is a culture of retaliation instead of formal discipline. And that due to provisions, the SBC cannot follow up immediately and rely on the Sheriff’s to do so.

Assistant Sheriff Tokar agreed with Commissioner Miller and asked that the SBC provide pertinent information so she can investigate, and if you want the employee held accountable, the SBC will need to cooperate with their investigative processes. Further that she will make every effort to not use the word bodies. She asked the SBC to copy the Captain and Watch Commander when sending correspondence. Commissioner Miller reiterated that at the conclusion of their inspections they discuss their observations with the Watch Commander and provide names and booking numbers of the individuals who have raised concerns. And identify deputies that cause concern.

A discussion ensued on reports and tracking to address bigger issues. Including the look at historical data, to compare locations and similar issues and treating it as a living document.

Chairperson Regalado expressed his thanks to Assistant Sheriff. Tokar on attending and asked if she’d be willing to come to future meetings. She could not commit to attending future meetings on a consistent basis but will have a representative from the Sheriff’s Department attend.

2. Discussion with Los Angeles County Assistant Sheriff Paula L. Tokar, Custody Operations. (24-3699)
 - Updates on the Conditions in the Jails
 - Updates on the Sheriff’s Department Report Backs to the SBC as directed by the Board of Supervisors.

Assistant Sheriff Paula Tokar addressed this matter during item 1. Additionally, Assistant Sheriff Tokar informed the SBC that some of the responses to their questions may take longer than others due to the nature of the concerns. However, she can provide responses for those that are ready or can provide a response once the report is ready and that she can accommodate as best as she can.

Commissioner Broder indicated that the last time they were at Men’s Central Jail the spreadsheet was given to Captain Marcello to provide responses to issues and asked Assistant Sheriff Tokar if she has the updated version. Assistant Sheriff Tokar indicated it is complete and that she will get what Sheriff Luna held up in the board room during the meeting today.

A discussion ensued on when the SBC can expect report backs from the LASD, in which the LASD agreed to get immediate report backs pertaining to the reports provided to the Watch Commander as that information does not make it into the reports.

3. Los Angeles Sheriff’s Department (LASD) explanation on delayed Written Report Back pertaining to the Board of Supervisors June 25, 2024 Board Motion “Conditions at Men’s Central Jail, Reaffirm the County’s Commitment to Care, and Respond to Support Those in Our Care.” (24-3700)

Commissioner Broder clarified that this item was placed on the agenda because it appears that the LASD does not seem to have the SBCs email address resulting in delayed reports.

Assistant Sheriff Tokar said the spreadsheet will be sent to the SBC directly, and that the report back was sent using their process. The SBC expressed clarified that although that may be the case, that they the report per the Board motion was supposed to be provided to the SBC so that they may provide a report back to the board. And that because of

the delayed response and delay in receiving the report the SBC was unable to provide the Board with a response.

Commissioner Miller expressed his disappointment regarding the responses provided by the LASD. The report submitted to the Board of Supervisors on August 2, 2024, by the LASD did not provide concrete solutions to the issues. And therefore, gives the SBC nothing to report on, because there is no substance.

A discussion ensued on the insufficiencies of the report back and lack of communication from the LASD in which the SBC agreed to draft a letter that would address those concerns in which Commissioner Miller and Vice Chairperson Broder agreed to compose it and have it ready for the SBCs review at the next meeting.

Commissioner Miller noted that the Board was worried about 1. The report from MCJ, 2. There is an inadequate Mental Health screening in MCJ, especially where people are being sent to disciplinary segregation. 3. that the reports the SBC submits require the LASD to evaluate and opportunities to address ongoing challenges to care. And to identify opportunities.

The SBC expressed interest in a list of challenges and opportunities as referenced in the Board motion, in which they did not receive from the LASD. And that it would be helpful to know the timeline of the investigation. And if there is nothing to report on it should be stated as such.

A discussion ensued regarding training in which the SBC expressed that training personnel is useless if personnel are not using their training during a time of need. And that the issue of training can be supported by allocating funding in the budget for mental health. Additionally, 40 hours of training is provided to personnel for medical and mental health issues and is not enough. Also, that training something that should not be fully relied upon.

Other concerns to be included in the letter are ongoing concerns with the LASD culture, and lack of care. And this should be an advocating document for closing MCJ and reinforce that. And in the letter include that the LASD provide the SBC with the conclusion of the investigation mentioned in the report.

On motion of Commissioner Eric J. Miller, seconded by commissioner Mary Veral, the SBC approved a letter to be drafted by Commissioner Miller and Vice Chairperson Haley Broder that discusses the insufficiencies of the LASDs report back, lack of communication from the LASD, address the

LASD culture, and advocate for the closure of MCJ and have it ready before the next SBC meeting to be shared with the SBC, and if approved, sent to the Los Angeles County Board of Supervisors with the following roll call vote:

7. Discussion and SBC next steps on the Board of Supervisors July 9, 2024 Board Motion, “People Over Profit: Fairness and Equity in Commissary Prices for the Los Angeles County Jails”. (24-3704)

Chairperson Regalado indicated that a list of products and prices was received.

Commissioner Veral expressed concerns about the ongoing increase in prices for food and products and wants to understand why it is happening.

Chairperson Regalado indicated that a Report Back was expected from within 45 days from the LASD, and that they have not received one.

A discussion ensued on the selection of vendors, and how they get their products from. And how an incarcerated person can get money to purchase commissary items.

Commissioner Miller expressed that if the discussion is on cultural issues, some of that has to do with the food served based on religious and cultural preferences, or requirements. The Commission has consistently noted that the food is not nutritious, and inmates go hungry. Also noted the presence of rodents and cockroaches in the food. And that people want to buy literature. Inmates are running scams on other inmates to rob people of their commissary items and the jail does not treat that as a problem. And the Commissary provider should be responsible for it and should be investigated to see how widespread it is. The other problem is that dispensers are not adequately stocked.

Chairperson Regalado indicated that some items are simply overpriced, such as Chunk Light Tuna at \$8.58. A discussion ensued which led to the recommendation to review the commissary vendor.

And noted that the LASD report back was due 45 days from the July 9, 2024 Motion. Lieutenant Gonzalez confirmed that the LASD will provide a response by September 16, 2024. Lastly that once they are in receipt of the LASD report back they could coordinate an implementation plan.

This item was continued to the next SBC meeting.

14. General Condition Complaints the American Civil Liberties Union (ACLU) of Southern California received the month of August 2024 from Century Regional Detention Center (CRDF), Men's Central Jail (MCJ), North County Correctional Facility (NCCF), and Twin Towers Correctional Facilities (TTCF). (24-3711)

Commissioner Broder expressed that if the LASD wants documentation in a timely manner it won't always be easy to condense everything into one spreadsheet. Commissioner Broder stated that for now documentation will be sent separately as it has been to get it to Dr. Henderson in a timely manner.

Chairperson Regalado asked if the information can be given to the Watch Commander, or if their internal team can give the information to Dr. Henderson. What is the plan on getting it to them in a timely manner?

The SBC raised concerns about Dr. Henderson requesting medical concerns be submitted right away, however when submitted right away there was a focus on compiling the list of medical concerns as opposed to getting them to CHS real time. And the other concern is not getting a response and or status from CHS. Furthermore, the Watch Commander made it clear that the LASD and CHS are two different departments, and it is best to provide the information to all necessary parties. After discussion the SBC agreed to continue their process to email and inform the Watch Commander as they have been doing and continue to email Dr. Henderson and provide him with the booking numbers for those in need of medical services.
