I. ADMINISTRATIVE MATTERS

1. Call to Order and Roll Call.

Vice Chair Terry called the special meeting to order at 10:05 a.m. Executive Director Wendelyn Julien conducted the roll call:

2. Approval of the May 8, 2025 regular meeting minutes.

By Common Consent, (Commissioners Meredith and Mundo being absent), the POC agreed to table discussion and possible action on the May 8, 2025 meeting minutes for discussion at the June 23, 2025 POC meeting.

II. DISCUSSIONS

3. Discuss and take possible action on the implementation of the Los Angeles County Probation Department's Depopulation Plan. Discussion will include the following:
 - i. Progress on preparation of facilities and plans for/movement of youth.
 - ii. Progress on compliance with BSCC.
 - iii. Progress on implementation of Judge Espinoza's directives to the Department in the Order to Show Cause hearing.
 - iv. Updates on the notification process to families and communication with Community Based Organizations and county programs and services providers impacted by the relocations.
 - v. Takeaways from DYD's Community Dialogue Events.

- vi. Response to POC Depopulation Solutions (1) regarding the process by which youth are assessed at intake for eligibility for release and opportunities for improvement in detention reports, recommendations, and (3) improvements to the intake process that would reduce the length of stay of youth who do not pose a risk to public safety.

Jocelyn Roman (Acting Deputy Director – Juvenile), Cesar Mayorquin (Probation Director – IDC and CDP), and Angela Walker (Senior Director – Juvenile Special Services) from the Los Angeles County Probation Department introduced themselves.

Executive Director Julien clarified the differences between the Global Plan and the Depopulation Plan.

Acting Deputy Director Roman gave a verbal report on agenda 4, subitems i, ii, iii, and iv and responded to Commissioners' questions and concerns.

Senior Director Walker gave a verbal report on agenda item 4, subitem vi related to the POC's Depopulation Solution (1).

Director Carroll gave a verbal report on the takeaways from DYD's Community Dialogue events noting that they will produce a public summary and DYD's ongoing collaboration with the Probation Department.

Commissioner Jackson proposed a motion, seconded by Commissioner Kakani, to table discussion and possible action on agenda items 4 and 5 to the June 23, 2025 POC meeting.

Ten (10) public commenters addressed the POC.

Commissioner Prater left the meeting at 12:00 p.m.

Commissioner Jackson and Commissioner Kakani asked that the POC and Probation Department collaborate to create a list of action items (such as construction, status upgrades, staffing levels, programming, and stakeholders) specific to each juvenile facility that needs to be completed to reach BSCC compliance.

On motion of Jackson, seconded by Commissioner Kakani, unanimously carried, (Commissioners Meredith, Mundo, and Prater being absent), the Los Angeles Probation Oversight Commission (POC) agreed to table agenda items 4 and 5 for discussion at the June 23, 2025 POC meeting:
