II. PRESENTATION/DISCUSSION

5. Presentation and Roundtable discussion on Medi-Cal and CalAIM Benefits for Transition Age Youth.

Dr. Edward Liao, Medical Director, Department of Children and Family Services Minsun Meeker, Assistant Executive Director, Office of Child Protection (25-3466)

Minsun Meeker, Assistant Executive Director, Office of Child Protection (OCP), and Dr. Edward Liao, Medical Director, Department of Children and Family Services (DCFS), provided a presentation on Medi-Cal and CalAIM Benefits for Transition Age Youth (TAY), and led a roundtable discussion regarding recent Board Motions related to implementing new benefits available under Medi-Cal. The following was presented:

- Background on Board Motions (includes directives to the Youth and LGBTQ+ Commissions).
- Medicaid (National Public Health Insurance Program)
- CalAIM (California's version of Medicaid) 14.1 million Californians are enrolled
- Key Implementation Partners
- Medi-Cal Overview of two programs:
 - o Medi-Cal Managed Care (MMC) 85% of Californians under Medi-Cal are enrolled in MMC
 - Fee for Service (FFS) 15% of Californians under Medi-Cal are in enrolled FFS (Two Thirds of youth in foster care are enrolled in FFS, one third are in MMC)

Discussion ensued and Dr. Liao and Ms. Meeker responded to questions posed by Commissioners as follows:

Cal AIM is only under MMC, and the Enhanced Care Management (ECM) is available under MMC. It is the biological parents or foster parents who make the determination as to which coverage their child will receive. Dr. Liao also clarified that the ECM age eligibility is up to age 26. However, there are other services available to adults over age 26 through Medi-Cal and through community resources

The MMC plan providers have lists of all eligible youth that they contact to advise of services provided under ECM. They also work off referrals from DCFS case workers, social workers, and other community resources.

- It was suggested that youth are in the best position to assist other youth in learning about Cal AIM, MMC and the services under ECM, and that going to Short-Term Residential Therapeutic Program homes and/or displaying information posters where youth congregate would be useful.
- Trusted service providers who are already in the space of child welfare services are collaborating with DCFS in providing support to TAYs. The MMC providers are held accountable through provisions of their contracts, which includes a complaint response process. The Ombudsperson is the source to resolve complaints for FFS. Dr. Liao will provide the Youth Commission with a list of the MMC providers.
- Once a TAY becomes an adult (age 18), the individual can make a change for themselves from FFS to MMC, the process would be handled through DCFS or through the community support provider directly.
- It is important to have conversations with youth regarding insurance, the level of care of specific providers and available services at regular intervals while they are in care.

Ms. Meeker presented a series of questions for the Commissioners consideration. Discussion ensued and Commissioners provided their personal thoughts. In response to additional questions posed by Commissioners Dr. Liao and Ms. Meeker provided the following:

- DCFS has internal workgroups along with MMC providers, and consultants such as Health Management Associations and Public Works Alliance, as well as other County departments that provide outreach to youth.
- The workgroup currently does not have members with lived experience.
 He was then encouraged to include youth with lived experience in the
 internal workgroups and to also include Youth Commissioners as
 participants.
- It was suggested that DCFS take a look at low access barriers for systems impacted youth. It was also suggested to give youth a greater hand in determining their own insurance and services and be appropriately informed along with markers of success.

In conclusion, Ms. Meeker indicated that she would like to create an ad hoc work group that includes both the LGBTQ+ Commission, Youth Commission, and individuals with lived experience.

The LGBTQ+ Commission is considering spearheading an ad hoc committee to focus on youth issues. If formed, there will be an opportunity for Youth Commissioners to participate in the work of the ad hoc committee.

9. Operations Committee update by Committee Chair Joshua Elizondo and Recommendation to Approve the Nomination of At Large Youth Commission Candidates. (25-3469)

Commissioner Joshua Elizondo, Chair, Operations Committee (OPS), reported that the following:

- The next OPS meeting is scheduled for July 21, 2025. The meeting will center on videos and reflection conversations.
- Encouraged Commissioners to consider mentoring new onboarded commissioners to assist with their learning about the Commission and community resources. The OPS will consider mentoring new commissioners as part of their duties.
- There are three vacancies for Commissioners at-large, he outlined the process for recruiting, interviewing, and securing three nominees.

OPS Chair Elizondo shared the qualifications for At-Large Candidates Josh Boykin, Joseph Roa, and David DeLeon and recommended approval to submit to the Board of Supervisors for appointment.

Members of the public, Josh Boykin and Joshua Roa, addressed the Commission.

10. Youth Engagement Committee update by Committee Chair Sherrie Bradford. (25-3471)

Commissioner Sherrie Bradford, Chair, Youth Engagement Committee (YEC), opened the floor and called upon Commissioner Evelyn K. Rodriguez to provide an update. Commissioner Rodriguez reported that the First Supervisorial District's Listening Session scheduled for Saturday, June 26, 2025, was cancelled in consideration of public safety due to the threat regarding constitutional rights. She then spoke on the response of the community and how people are helping each other with groceries, rides to appointments, and monetary. Commissioner Martine Jones added her thoughts regarding the community's response and all the action being taken to support families. She encouraged Commissioners to be mindful of selfcare, civic engagement, and support monetarily.

YEC Chair Bradford requested the Commissioners to consider October 18 or 25, 2025 for the Year End event.
