- **3.** Presentation and Roundtable Discussion on the Youth Engagement Committee 2025 End-Year Report including but not limited to the following stakeholders:

Commissioner Sherrie Bradford, Chair, Youth Engagement Committee, opened this item and thanked all stakeholders for attending. She began the presentation with a self-introduction highlighting her experience, then led a Round Table Discussion on the Youth Engagement Committee's 2025 End Year Report. She outlined the Youth Commission Goals and Purpose, and Demographics Data collected.

Commissioner Amanda Hernandez provided a self-introduction and discussed her areas of interest. She then facilitated a Question-and-Answer Session for the Stakeholders based on the following Question: What do you think the most popular focus areas for youth are? Various stakeholders voiced their responses. She then reviewed the advocacy priorities as provided by 881 survey respondents.

The results were as follows in order of importance:

- Mental Health
- Education
- Employment
- Entertainment
- Housing

Discussion ensued regarding the priorities. The attendees were then directed to *Activity 1: Five Corners Activity*.

Commissioner Joseph Roa provided data on the Entertainment Category and the results of what type of entertainment youth are most interested in, in order of importance:

- Music
- Sports
- Art
- Boxing
- Dancing

He then introduced Guess Speaker Chase Gibson, Founder of Fighting Chance, and Pro Fighter who addressed the attendee's providing information regarding his lived experience and challenges in the juvenile justice system. He spoke about how mixed martial arts (MMA) provided him a way out of the system.

Mr. Gibson introduced Fighter and Coach, Jeffrey Munoz. Mr. Munoz shared a poem that he authored and spoke about his lived experience in the child welfare and juvenile justice systems. He also disclosed his challenge with mental health issues and highlighted how MMA fighting provided him a way out of the system and into mainstream society. Mr. Gibson and Mr. Munoz then led a group exercise.

Executive Director, Tiara Summers, introduced Dr. Erica Reynoso, Department of Mental Health (DMH). She spoke about the new office for Transitional Age Youth (TAY) Division, and the need for mental health services and trauma informed therapy. She also discussed the new Behavioral Health Services Act. Kanchi Tate, DMH, addressed the Commission and encouraged Commissioners and youth in attendance to become involved.

The meeting was recessed at 1:05 p.m. for lunch and reconvened at 2:07 p.m.

Commissioner Joseph Roa reviewed the Mental Health Data Results and facilitated a group exercise, *Activity 2. Barriers to Solutions Scenario*. The purpose of the exercise was to strengthen and improve the support systems for youth by better understanding their challenges and needs, and included stories, a Public Service Announcement still shot, and a short film. The exercise included a Question-and-Answer Session with stakeholders.
