

People had to place old food cartons and other materials at the base of their cells to stop the rats from entering their cells at night. Nearly every person we spoke to raised the issue of rats in the module and that it has been a problem for months. Clearly, the jail staff knows it's a problem (they had laid the traps). Given how filthy it was, it does not seem like a liveable place for people until the rat situation is fixed.




