We heard multiple instances of the same deputies names shared across multiple modules, which is in line with names we have heard and reported to LASD at previous inspections in the past months. We also spoke with an individual who shared her story of rape by a deputy and the retaliation she has faced since -- and the lack of any services provided to her.

122. Narrative Report

Major Concerns:

1. PREA Complaints and Allegations -- these were shared verbally on the phone with Captain Martin. There were multiple complaints shared with the SBC against multiple LASD staff members for sexual harassment, observation of women in showers, and rape. As we have shared after visits to CRDF over the last 6 months, we are hearing lots of concerning reports of specific deputies watching women showering and then asking to see their body parts when doing their walks later. There are fears of retaliation.

2. Extreme Filth -- the module was covered in trash in the day room and individual rooms. There were flies/gnats around, including near the grievance form box and the sink in the day room. There was old food on the tables, visible mold in the showers, and cobwebs/layers of dirt and filth on cell doors and on the floor.

3. Water Quality and Conditions -- As SBC continues to raise, we observed water coming out of the tap that was brown in color. We observed rust in showers, mold, and small black flies (dead) on the floor of the shower and around the drain. Request: Provide free water bottles to the women if the water is undrinkable.
