## Major Concerns

1. Continued dirt/trash/filth, smell of fire throughout the jail, with reports of rodents and bugs. This included a giant leak (full-size trash can already full of water and water going out into the hallway near 3700).
2. Many cells without running water or both hot/cold water.
3. Reports of no follow-ups to grievances submitted and reports of very slow medical follow-up.

## Medical Follow-Up Needs

1. Mark Nunez, 7135833, needs mental health support and follow-up following an assault for chest pain
2. Anthony, 6211321, needs dental for a broken tooth emergency; needs lead testing
3. Rafael Avila, 7078031, needs an optometrist/glasses -- cannot see
4. William Branscomb, 7129503, needs re-evaluation for mental health care and needs albuterol for asthma
5. Jesse Randle, 7075606, needs urgent medical follow-up for kidney stones
6. Errol Jones, 6268950, needs back brace and thumb brace, along with glasses
7. Damioni Johnson, 7017851, needs dentist
8. 7109675, Errice Lewis (Ivy) needs trans services and abilify/suboxone
9. Requests in K6G dorm for regular trans women clinic checks every 6 weeks

- Very dirty escalator (stairs) leading up to 5000

## 9400

- Not enough chairs for the very full dorm (only seating for 28 out of 142)
- Need cleaning supplies
- Need additional trash cans
- 2 TVs not working, one missing cord entirely
- Vending machine access removed? Requests return, or return of funds if vending is on account and now cannot access vending
- Phones not working
- Very cold -- request for additional blankets
- Toilets broken (5 out of the 10 total for 142 people)
- Concerns about cameras facing showers and lack of privacy with cross-gender shower viewing
- Visible mold on ceiling
- No drain covers in showers
- Requests for bras and panties provided to trans women
- Medical request forms are available only outside of the dorm (along with grievances) -- difficult to get
- Specialized diet meals are not regularly received and people are reporting hunger.
- Request for FISH kits
- Observed a few mattresses without plastic
- Reports of rats eating into special diet food bags, milk coming lukewarm, bread coming with mold

We observed the new body cameras in action across the jail. We heard some positive reports about the new dinner service (coming warmer!), but still concerning reports of moldy food for the other meals.
