3. Ensuring Reliable and Consistent Public Safety in Los Angeles County Parks

4. Increasing Awareness of “Alert LA County” Warning System to Keep Residents Apprised of Local Emergencies

Recommendation as submitted by Supervisors Kuehl and Hahn: Approve an appropriation adjustment that reflects an increase of \$1,000,000 in appropriation in the Department of Consumer and Business Affairs (DCBA) budget unit offset by a corresponding increase in Federal revenue from the Coronavirus Aid, Relief, and Economic Security (CARES) Act Coronavirus Relief Fund (CRF) to fund media campaign programs; approve an appropriation adjustment that reflects an increase of \$12,545,000 in appropriation in the Non-Departmental Special Accounts budget unit offset by a corresponding increase in Federal revenue from the CARES Act CRF to fund computing devices and digital support that will be provided by the Los Angeles County Office of Education (LACOE) to support probation youth and students who are unable to access digital resources or participate in remote learning during the COVID-19 pandemic; approve an appropriation adjustment that reflects an increase of \$25,000,000 in appropriation in the Department of Workforce Development, Aging and Community Services (WDACS) Assistance budget unit offset by a corresponding increase in Federal revenue from the CARES Act CRF to fund various food and nutrition programs; and take the following actions: (Relates to Agenda No. 1-D) **4-VOTES**

Approve an appropriation adjustment that reflects an increase of \$25,000,000 in appropriation in the Chief Executive Office's budget unit offset by a corresponding increase in Federal revenue from the CARES Act CRF to fund various food and nutrition programs;

Approve an appropriation adjustment that reflects an increase of \$10,000,000 in appropriation in the Economic Development budget unit offset by a corresponding increase in Federal revenue from the CARES Act CRF to fund small business assistance programs to be administered by the Los Angeles County Development Authority (LACDA);

execute, amend and, if necessary, terminate, agreements, including sole source, necessary to support the County's continued efforts to assist and address the health, safety and welfare of County residents during the COVID-19 pandemic and in compliance with requirements of the Federal or State funding source for such agreement;

Authorize the Acting Chief Executive Officer and the Acting Directors of Consumer and Business Affairs and Workforce Development, Aging and Community Services, in consultation with County Counsel, to enter into, execute, if necessary, amend, subrecipient agreements or any related agreements, including sole-source, when necessary, with any community-based organizations and public agencies including, but not limited to, nonprofit, joint powers authorities and cities, necessary to implement the above directives and comply with the requirements of the CARES Act not to exceed the following:

\$25,000,000 to the Chief Executive Office to provide grants to community-based organizations for food-related programs to food-insecure populations;

\$1,000,000 to DCBA to support hyper-local and ethnic media outlets to provide communities with targeted messages about the COVID-19 pandemic and where to find resources/information related to prevention, mitigation, quarantine and isolation, infection control measures and other COVID-19-related services offered by the County; and

\$25,000,000 to WDACS to support expansion of the Elderly Nutrition Program providing meals to seniors, through current contractors, non-profit organizations, vendors and restaurants; and

Authorize the Acting Chief Executive Officer to execute subrecipient agreements, and any necessary amendments, with LACOE, LACDA and the Los Angeles Homeless Services Authority (LAHSA) to effectuate the Spending Plans and establish the parameters by which LACOE, LACDA and LAHSA will utilize the funding in accordance with the CARES Act CRF and the Spending Plans not to exceed the following:

\$12,545,000 to LACOE to provide digital support to individuals and communities disproportionately impacted by the COVID-19 pandemic;

\$10,000,000 to LACDA for a small business grant program, including administrative costs, in partnership with DCBA, and through a grant

program for small businesses that have been impacted and have suffered economic hardship due to COVID-19 due to closures and restrictions from County Health Officer Orders; and

\$2,000,000 to LAHSA for the added costs, as a result of COVID-19, of keeping most Winter Shelter Program sites open for 24-hour operations from April through October 2020 (instead of closing) and for maintaining 24-hour operations from November through December (instead of 14-hour/day operations). Instruct the Acting Executive Director of the Los Angeles County Development Authority and Acting Director of Workforce Development, Aging and Community Services to conduct an assessment on the ability to provide eligible housing and community-based services to mitigate the loss experienced by those impacted by the Fires;

Instruct the Registrar-Recorder/County Clerk to suspend all fees for copies of real property records recorded with the Registrar-Recorder/County Clerk for any individuals who lost such records as a result of the Fires and direct the Acting Chief Executive Officer to reimburse the Registrar-Recorder/County Clerk for said suspension of fees;

Request the Assessor and instruct the Treasurer and Tax Collector to inform affected property owners of the importance of filing a Misfortune and Calamity Claim, including the impact to the deferral of the first installment property taxes due December 10, 2020;

Instruct the Treasurer and Tax Collector to ensure that payment is deferred, without penalty or interest, for those affected by the Fires until the Assessor reassesses property in accordance with State law; and report back to the Board in 90 days on the number of affected property owners who filed Misfortune and Calamity Claims, as well as the number of property owners that requested a cancellation of late payment penalties;

Instruct the Acting Director of Consumer and Business Affairs to conduct outreach to residents impacted by the disaster and provide information regarding price gouging and consumer best practices, tenant protections and business recovery resources;

Find that public interest and necessity demand immediate emergency action to repair and harden public infrastructure including public roads, bridges, roadway drainage, water supply facilities and flood control facilities; remove sediment at debris basins, debris dams and major dams and reservoirs; construct temporary and permanent debris mitigation measures and structures; and find that these emergency actions cannot be delayed by a formal competitive solicitation for bids;

Authorize the Director of Public Works, on behalf of the County, and acting as the Road Commissioner, Chief Engineer of the County Flood Control District and County Engineer, to carry out the following emergency activities:

Coordinate with the National Forest Service and any other property owner, as needed, to restore and modify damaged infrastructure, including the construction of temporary and permanent debris mitigation measures, required as a result of the fire;

Trim or remove fire-damaged trees adjacent to any County roads, bridges, flood control facilities and water supply facilities within the fire area and, if any of the trees are within Significant Ecological Areas, work with the Director of Regional Planning to secure permits or exemptions, if applicable, for said work, with particular emphasis on addressing impacted Joshua Trees;

Restore damaged road and flood control infrastructure, and construct temporary and permanent debris mitigation measures required as a result of the fire;

Conduct outreach to impacted residents and provide engineering advice on mitigation of impacts from potential debris flows;

Develop strategies and action plans for potential mudflow events, including maintenance and road closure plans;

Analyze and map debris flow hazards and develop strategies and action plans for potential mudflow events, including maintenance and road closure plans;

Acquire the necessary rights-of-way and permits, and enter into agreements including, but not limited to, cooperative agreements with the United States Forest Service, as necessary to conduct these emergency actions;

Submit grant applications and conduct any necessary actions, including negotiating and executing grant agreements and signing requests for reimbursements to the Natural Resources Conservation Service, the Federal Emergency Management Agency, the California Department of Transportation, the Federal Highway Administration and the California Office of Emergency Services, in order to secure Federal and State funds for emergency infrastructure repairs and rehabilitation, and debris flow protection measures, as necessary;

Fully utilize existing resources, and apply increased resources as necessary, to assist property owners in the reconstruction of structures damaged or destroyed by the fire; the Departments of Regional Planning, Public Health, Fire and Public Works assistance will include streamlined coordination, plan review and permit issuance for project compliance with County's building codes and all building requirements and assistance will also include enhanced community outreach to affected property owners through local information workshops and one-on-one consultation;

Supplement and extend for up to 12 months existing professional service contracts, such as geotechnical, design, inspection, environmental and survey, by up to an additional \$2,000,000 each, not to exceed a maximum additional aggregate amount of \$35,000,000 to support the Department of Public Works' emergency recovery activities, and up to an additional \$1,500,000 each, with a not to exceed maximum additional aggregate amount of \$20,000,000 for other existing support service contracts, such as field security, debris removal and disposal, haul-truck services and operated heavy equipment contracts, to support emergency repairs to County facilities and construction of temporary and permanent debris mitigation measures required as a result of the Fires; and

Supplement the existing road emergency repair contracts by up to an additional aggregate amount of \$5,000,000 to support emergency repairs to County facilities and construction of temporary and permanent debris mitigation measures required as a result of the Fires;

Find that the proposed removal of sediment from debris basins, debris dams, and major dams including Cogswell, Morris, San Gabriel, Santa Anita, Sawpit, and any additional dams which may be impacted by the Bobcat Fire, the construction of rail and timber structures and other temporary flood control facilities, and any other directly related and immediate action, including maintenance and repairs required to prevent or mitigate the emergency, are exempt from the California Environmental Quality Act;

Authorize the Director of Public Works to perform force account work, to negotiate and amend existing emergency and as-needed contracts on behalf of the County, in an amount not to exceed an aggregate total of \$30,000,000 for the necessary equipment, services and supplies, in order to repair road facilities damaged by the Fires;

Instruct the Director of Public Works to report back to the Board on a regular basis, as required by Section 22050 of the Public Contract Code, on what actions have been taken and verify the need to continue these emergency actions;

In place of such suspended housing, health or safety standards, the County's additional public facilities that are made available for temporary housing for homeless persons during the declared shelter crisis will be

subject to health and safety standards set forth in the emergency housing provisions of the Los Angeles County Building Code (LACBC), as approved by the Board, to be operative during the housing emergency consistent with ensuring minimal public health and safety, notwithstanding the foregoing, the Director of Public Works, in consultation with the Acting Chief Executive Officer, the Director of Public Health, the Fire Chief and other pertinent County Departments, as applicable, is delegated authority to opt out, in whole or in part, of the emergency housing provisions of the LACBC with respect to a County facility designated for use as an emergency shelter, and to determine alternative minimum site-specific standards for any such facility, consistent with ensuring minimal public health and safety; and

Authorize the Acting Chief Executive Officer to take any other actions consistent with and/or necessary for the implementation of the shelter crisis declaration and foregoing actions. (20-5566)
