3. Hearing on Annexation and Levying of Sewer Service Charges within Unincorporated Territories and Cities

Hearing on the annexation of 20 parcels into the Consolidated Sewer Maintenance District (Parcel Nos. 10-18, 1-19 through 4-19, 201-19, 1-20 through 2-20, 101-20 through 105-20, 201-20 through 206-20 and 4671 Worth Street (201-21) within the unincorporated areas of Agoura, Altadena, Athens, Castaic and Quartz Hill and the Cities of Carson, Diamond Bar, Duarte, Industry, Los Angeles, Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, San Dimas and Santa Clarita (All Districts); levying of sewer service charges within the annexed parcels for Fiscal Year 2023-24; adopt a resolution approving and accepting negotiations that there will be no exchange of property tax revenues, as a result of the annexation; and find that the annexation and levying of sewer service charges are to meet operational expenses to maintain service within the proposed annexation areas and are exempt from the California Environmental Quality Act. 5. Instructed the Director of Public Works to file the statement of boundary change with the State Board of Equalization and the County of Los Angeles Assessor's Office.

Hearing on an ordinance for adoption amending County Code, Title 4 - Revenue and Finance, to allow the recovery of costs associated with Chapter 8 Agreement Sales of tax-defaulted properties to public agencies or qualified non-profit organizations and update the Treasurer and Tax Collector fees and codify a new fee to allow the recovery of costs associated with conducting the title search, statutorily required party of interest notification, publication of notice of auction and personal contact for a tax defaulted secured property subject to the Tax Collector's power to sell. This ordinance shall take effect October 27, 2022.

6. Hearing on Appeal of Project No. 2016-002560-(3) for a New Single-Family Residence in the Santa Monica Mountains Planning Area

Hearing on appeal of Project No. 2016-002560-(3), Major Coastal Development Permit No. RPPL2017006101, to authorize the construction of an 18-foot-tall, 2,957 sq ft single-family residence, a two-vehicle carport with roof mounted solar panels, a 950 sq ft workshop, a confined animal facility consisting of a 942 sq ft barn and 3,900 sq ft of fenced animal enclosure, an on-site wastewater treatment system, a pool with pool deck, hardscaping and landscaping, and 6,492 cubic yards of total grading of which 3,571 cubic yards is for existing slope remediation, 2,323 cubic yards is for the finished slope, and 598 cubic yards is for the construction of the residence and accessory structures located at 570 Schueren Road in Malibu within the Santa Monica Mountains Planning Area, applied for by Winnie Lam; and find that the project is exempt from the California Environmental Quality Act. 12. Supplemental Paid Leave for Monkeypox and COVID-19

Recommendation as submitted by Supervisors Solis and Kuehl: Instruct the Acting County Counsel, in consultation with relevant Departments, to report back to the Board prior to the October 18, 2022 Board meeting with options to provide supplemental paid sick leave, including retroactive options and considerations for potential costs, for resident workers with suspected or confirmed monkeypox infection; direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, and the Los Angeles County Advocates in Sacramento, to respectfully urge Governor Gavin Newsom to sign Assembly Bill 152, legislation which would extend California's COVID-19 supplemental paid sick leave through the end of 2022 while providing relief to small businesses that are incurring the costs of such leave; and instruct the Acting County Counsel, in consultation and collaboration with the Director of Personnel, the Chief Executive Officer, through the Budget and Employee Relations Divisions, and the Directors of Economic Opportunities and Consumer and Business Affairs, to report back to the Board in writing prior to the October 18, 2022 Board meeting, with options to provide supplemental paid sick leave for new and emerging infections that may require isolation and guarantine, with the report back to include criteria that could be used to qualify the need for supplemental paid leave. Coordinate with the Chief Executive Officer's Real Estate Division to inventory all available County, excluding the Men's Central Jail site, and State-owned property, as well as available private property for lease or purchase, which could meet the siting requirements for beds and programs for the P3-4 population inclusive of both rehabilitating existing facilities and new construction;

Instruct the Acting County Counsel, in collaboration with JCIT/ATI, the Executive Officer/Clerk of the Superior Court, the District Attorney, the Public Defender, the Alternate Public Defender, the Sheriff, the Director of Health Services, through its Director of Correctional Health Services, the Alliance for Health Integration, and the Director of the Office of Diversion and Re-Entry, to report back to the Board in writing in 90 days with a legal opinion of all applicable penal and Welfare and Institution Codes, and any other applicable regulations that permit the transition of the P3-4 population out of jail custody and into secured mental health care facilities;

Instruct the Acting Director of Mental Health and the Director of Health Services, as co-leads, in collaboration with the JCIT/ATI, the Alliance for Health Integration, the District Attorney, the Public Defender, the Alternate Public Defender, the Director of Health Services, through its Directors of Correctional Health Services and the Office of Diversion and Re-Entry, the Acting County Counsel, and the Executive Officer/Clerk of the Superior Court, to:

Report back to the Board in writing in 90 days with a holistic plan to develop secured, non-correctional mental health care facilities needed to serve the P3-4 population, which would rely on both new contracted as well as new County-operated (respectively, via lease, purchase, and/or construction) bed/program capacity, and include recommended design(s) of secured, non-correctional mental health care facility beds and programs to meet the behavioral health care needs of the P3-4 population, and ensure the safe transition from jail, including a review of comparable mental health care facility programs currently operated and/or contracted for by the County, considerations for patient and staff safety, and measures to ensure that patients receive the appropriate levels of care, and in keeping with State and Federal regulations; and with the Chief Executive Officer, estimate corresponding one-time and ongoing funding needed to carry out this plan, and define the DMH's role as the specialty mental health plan for the County to leverage all eligible local, State, and Federal funding. A private right of action for prospective renters, or their representatives, with attorneys' fees, implementing penalties for violations of the ordinance to encourage adherence to the provisions of the proposed ordinance, discourage discriminatory and/or arbitrary landlord screening practices, and otherwise strengthen the enforceability of the ordinance;

Instruct the Director of Consumer and Business Affairs, in consultation with the Acting County Counsel, to return to the Board in 30 days with an ordinance amending County Code, Title 8 - Consumer Protection, Business and Wage Regulations, Chapter 8.52 - Rent Stabilization and Tenant Protections, and Chapter 8.57 - Mobilehome Rent Stabilization and Mobilehome Owner Protections, to do the following:

Establish an affirmative defense to evictions for nonpayment of rent that rental debt owed must exceed a monetary threshold amount equal to one month of fair market rent for the Los Angeles-Long Beach-Glendale, CA United States Department of Housing and Urban Development (HUD) Metro FMR Area (FMR), set annually by HUD, for 0-4 bedroom rental units, dependent on the type of rental unit occupied by the tenant; and

Amend Chapters 8.52 and 8.57 to add or amend tenant protections including, but not limited to, temporarily capping the allowable rent increases for Rent Stabilization Ordinance units at 3% annually through December 2023;

Instruct the Director of Consumer and Business Affairs, in consultation with the Chief Executive Officer, to report back to the Board in writing in 45 days on the following:

Opportunities to provide financial support to low-income tenants and mom-and-pop landlords who incur one-time rental arrears, including the encouragement of a repayment plan, with the analysis to include potential funding streams and mechanisms to distribute the funding including, but not limited to, existing programs such as the Mortgage Relief Fund and Stay Housed LA;

Recommendations on a framework to require relocation assistance or other tools to support tenants displaced due to unaffordable rent increases;

Assessing the need to reevaluate the current cost recovery model for possible increases in necessary programmatic services and duties in support of these changes; and

A plan to support incorporated cities interested in creating and adopting their own permanent tenant protections including, but not limited to, the following:

A Countywide tenant protections summit hosted by the Department of Consumer and Business Affairs in 2023;

A Policy Toolkit for Rent Stabilization and Tenant Protections; and

Assessing the feasibility of providing support to incorporated cities, with the exploration to include estimated costs that fall outside of the current recovery costs for programmatic services and duties, the identification of potential funding streams, and required staffing;

Authorize the Director of Consumer and Business Affairs to enter into agreements with consultants/contractors, as needed, to develop a plan supporting incorporated cities interested in creating and adopting their own tenant protections;

Direct the Chief Executive Officer, in consultation with the Director of Consumer and Business Affairs, and the Acting County Counsel, to identify overall proposed cost and funding sources to implement the directives above and report back to the Board during the Fiscal Year 2023-24 Recommended Budget; and

Recommendations on leveraging existing tenant and legal assistance programs, such as Rent Habitability, Rent Registry, and Self Help Legal Access Centers, to provide seamless services to constituents and proactively refer between programs;

Outlines growth protections for expanding the Stay Housed LA program to meet tenants' increasing needs, with the plan to achieve a universal access to counsel for eviction legal services by 2027; and

Develop and include an implementation budget to make the Stay Housed LA program permanent;

Direct the Chief Executive Officer to report back to the Board during the FY 2023-24 Recommended Budget phase with funding recommendations including, but not limited to, the feasibility of utilizing existing funding sources intended for prevention of residents becoming unhoused and supporting housing stability, to make the Stay Housed LA program permanent; and Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to support proposals that provide State and/or Federal funding for the Stay Housed LA program, such as access to counsel for eviction legal services to address current and projected growth (per the above); and support legislative proposals requiring the court system to share unlawful detainer data between local court systems and agencies that provide eviction prevention and defense services to tenants and individuals at-risk of homelessness.
