### 2. Stand with the Banned: Digital Library Cards for California Teens

Revised recommendation as submitted by Supervisors Horvath and Hahn: Instruct the County Librarian to report back to the Board in writing in 30 days with a plan to establish a program which makes digital library cards available to all residents and teens in California to be launched during Banned Books Week, October 1 through 7, 2023, including working with the Chief Executive Officer, as well as the Center for Strategic Partnerships, to establish a funding source for purchasing the eBook collection, including commonly banned books, and promoting the program; where funding sources may include American Rescue Plan Act funds or other one-time funding sources; and in consultation with County Counsel, the report back should include an assessment of the following options, if necessary, to ensure that these services are fiscally sustainable:

An annual fee for digital library cards for residents residing outside of Los Angeles County, with consideration for a fee that is assessed after a limited number of uses;

For residents residing outside of Los Angeles County, restricting the service to just teenagers;

Metering the content for non-teen, non-Los Angeles County residents; and

# 3. Support for Assembly Bill 957 (Wilson): The Transgender, Gender-Diverse, Intersex Youth Empowerment Act

### 4. Facilitating Implementation of One-Time Flexible Family Supports for Children and Youth in Home Based Placements

# 5. Research, Evaluation, and Data Analytic Services to Support and Inform Child Welfare Projects

Recommendation as submitted by Supervisor Hahn: Authorize the Executive Officer of the Board to execute a no-cost memorandum of understanding (MOU) for a three-year term with The Children's Data Network (CDN), University of Southern California (USC) and University of North Carolina-Chapel Hill (UNCC) to provide research, evaluation, and data analytic efforts that utilize administrative data available at the County level and supplemental data (i.e., State- and Federal-level administrative data holdings, data gathered from families) for research and evaluation projects that will help inform child welfare policies, programs, and practices for the Office of Child Protection (OCP), the Department of Children and Family Services (DCFS), and other child and family serving County entities; exercise options to extend the term for two one-year periods by written notification to CDN/USC/UNC-CH, contingent upon the Executive Officer notifying the Board and the Chief Executive Officer in writing in advance of such execution; negotiate and execute amendments with CDN/USC/UNC-CH for changes that pertain to the general project and tasks/deliverables needed to meet the child welfare research and evaluation needs of County entities, with the approval of County Counsel being obtained for any of the situations prior to executing any amendments, and the Executive Officer notifying the Board and Chief Executive Officer in writing in advance of the execution of such amendment; and assign or delegate her authority to execute amendments to another County Department Head, with approval of County Counsel being obtained prior to any assignments, and the Executive Officer notifying the Board and Chief Executive Officer in writing in advance of the assignment of the no-cost MOU. ### 6. Refugee Employment and Acculturation Services Capacity Enhancements

### 10. Alfred J. McCourtney Juvenile Justice Center

### 12. Creation of Sexual Assault Council Within the Los Angeles County Department of Public Health's Office of Violence Prevention

Revised recommendation as submitted by Supervisors Solis and Horvath: Adopt the Chief Executive Officer's recommendations for creating a Sexual Assault Council within the Department of Public Health's Office of Violence Prevention to promote equitable services, prevention programs, law enforcement and other investigatory responses, and justice-system involvement for adult survivors of sexual violence across all demographics and to analyze data to determine and fill gaps in services, programs, and responses, and adopt recommendations regarding staffing and composition of the Sexual Assault Council, including the Chief Executive Officer determining allocation of positions and staffing levels and developing a model of compensation for at least one member position on the Sexual Assault Council with lived experience to amplify survivor voices and enhance the healing process; and take the following actions:

Instruct the Sexual Assault Council, once established, to focus on improving systems, practices, and policies to assist all survivors, with a particular focus on vulnerable populations with unique barriers, including immigrants, undocumented individuals, limited English speakers, individuals who have a history of victimization, those experiencing homelessness, justice-involved individuals, adult victims of commercial sexual exploitation and human trafficking, disabled people, industrial, custodial and domestic workers, elderly people in home care/facilities, cisgender males, Black, Indigenous, and People of Color people of color, LBGTQ, and Native Americans; and report back to the Board semi-annually on the implementation of sexual assault related programming centered around a public heath framework, an examination of sexual assault funding, and the creation of data dashboards that both provide a clearer picture on how to center survivors in L.A. County's care-based service model and identify gaps where enhanced services are required, such as, the investigation and justice outcomes, including consistent filing standards, timely forensic analysis, monitoring standards for investigating sexual assault charges, and identifying gaps in services and programs based on data analysis that examines the number of victims by type of sexual crime, the type of services being accessed, and the percentage of the recurrence of sexual assault; and

Direct the Chief Executive Officer to report back to the Board during the 2023-24 Supplemental Budget phase on the availability of funding to establish the Sexual Assault Council. (23-2371)

# 13. Supporting the Expansion of Forensic In-Patient Stepdown and High Observation Housing Dorm Units in the Los Angeles County Jails

Recommendation as submitted by Supervisor Solis: Request the Sheriff and instruct the Director of Correctional Health Services, Department of Health Services, to continue to expand rapidly the number of Forensic In-Patient (FIP) Stepdown and High Observation Housing (HOH) Dorm pods at the Twin Towers Correctional Facility (TTCF) and Central Regional Detention Facility (CRDF), to a total of 20 pods by March 30, 2024, a total of 28 pods by March 30, 2025, and 30 pods by June 30, 2025, and report back to the Board bi-annually in writing on the status and progress of the expansion; and take the following actions:

Request the Sheriff and instruct the Director of the Correctional Health Services, Department of Health Services, to continue to recruit volunteer Mental Health Assistants, including through recruitment and training initiatives, such as the Merit Masters program, at least two times per year, more if needed; and

For purchases of goods, including supplies, equipment, and services necessary to expand FIP Stepdown and HOH Dorm pods within the County Jails, increase the delegated purchasing authority of the Sheriff and the Director of Health Services to \$50,000, and to the extent legally permitted, authorize the Sheriff and the Director of Health Services to enter into, amend, or terminate agreements, including work or purchase orders, and other services or commodities, without adhering to the requirements of the County's Sole Source Policy, or any other competitive procurement requirements, provided that the Department has a good cause justification in that the action implements or is in support of the expansion of FIP Stepdown/HOH Dorm units, this increased delegated purchasing authority are intended to supplement, not replace, Departments' existing streamlined and delegated authority and shall remain in place until June 30, 2025 or until rescinded by the Board. ### 15. Making Strides Against Breast Cancer Los Angeles Event

Instruct the County Department Public Information Officers to promote and distribute materials, in multiple languages, related to the *Making Strides Against Breast Cancer Los Angeles* event and promote the American Cancer Society's "Get Screened" campaign with special efforts to reach communities that have been historically marginalized; and

Direct all County Departments' Wellness Coordinators to promote the 2023 *Making Strides Against Breast Cancer Los Angeles* event and encourage colleagues to participate and support it. (23-2373)

### 16. Implementing Further Countywide Expansion of Mentorship Programs Serving Black Girls and Other At-Risk Children

Recommendation as submitted by Supervisors Mitchell and Barger: Authorize the Director of Mental Health to execute an amendment to the Friends of the Children Los Angeles contract, to extend the term through June 30, 2026, with one extension option, for the continued provision and Countywide expansion of professional mentoring services, with a Total Contract Amount (TCA) of \$13,593,663 for the term of the contract, fully funded by Mental Health Services Act funds; and take the following related actions:

Execute future amendments to the contract to revise the boilerplate language, revise and/or replace the fee schedule, shift unspent funds to future years, add, delete, modify, or replace the statement of work, and add or reflect Federal, State and County regulatory and/or policy changes provided that the County's total payment will not exceed 10% of the Board-approved TCA, and sufficient funds are available;

Terminate the contract in accordance with the contract's termination provisions, including termination for convenience; and

Instruct the Director of Mental Health, in collaboration with the Director of Children and Family Services, to report back to the Board in writing in 90 days, and biannually thereafter, on the selection criteria, the program's progress, and outcomes. (23-2354)
