II. PUBLIC HEARING 1**1. Hearing on Appeal of Project No. 2015-01232-(2), Vesting Tentative Tract Map No. 073082, Conditional Use Permit No. 201500052, and Environmental Assessment No. 201500089**

Hearing on an appeal of Project No. 2015-01232-(2), including Vesting Tentative Tract Map No. 073082 (RTM-TR073082) to create one multi-family lot developed with 88 attached condominium units within one five-story building on 1.84 gross (1.77 net) acres with the Restricted Business - 5,000 Sq Ft Minimum Lot Size (C-1) Zone; Conditional Use Permit No. 201500052 to authorize a single-family residential development within the C-1 Zone and in a designated Hillside Management Area, with two modification requests to exceed the height limit of 35 feet for a total maximum height of 65 feet, and to reduce the front yard setback area from 20 to 15 feet. The project is located at 5101 South Overhill Drive within the unincorporated community of Ladera Heights/View Park - Windsor Hills within the Westside Planning Area. The project site will be accessible from two points of ingress/egress along Overhill Drive, and includes a fire turnaround, 198 vehicular parking spaces, 53 bicycle parking spaces, pedestrian walkways, an outdoor swimming pool, and community and exercise rooms. The project also includes 10 dwelling units voluntarily set aside for moderate-income households with incomes no greater than 120% of the Average Median Income. The Board will also consider Environmental Assessment No. 201500089, including a Final Environmental Impact Report, concluding that no significant and unavoidable impacts would occur due to the project with the implementation of mitigation measures pursuant to the California Environmental Quality Act reporting requirements. The six areas of environmental impact identified as less than significant with mitigation incorporated include Aesthetics, Air Quality, Biological Resources, Cultural Resources, Noise, and Tribal Cultural Resources. III. ADMINISTRATIVE MATTERS 2 - 10**BOARD OF SUPERVISORS****2. Extending Price Gouging Protections for Housing**

Recommendation as submitted by Supervisor Horvath: Effective February 28, 2026 extend for 30 days, through and including March 29, 2026, the protections of California Penal Code Section 396, subdivisions (b), (c), (d), (e), and (f), to limit price-gouging for applicable goods and services and in the housing rental market, in hotels and motels, and to continue the protections of County Code, Chapter 8.09, pursuant to Penal Code Section 396 subdivision (g). The Board finds that this extension is necessary because of complaints of price gouging which are continuing, and have been increasing, and that such an extension will protect the lives, property, and/or welfare of the residents of the County. Authorize a specified price increase of the rental price for housing not rented and not offered for rent within one year prior to the proclamation or declaration of emergency as defined in Penal Code Section 396 subdivision (j)(11)(B) as follows: for the County, increase the rental price formula for such housing from 160% of the fair market rent established by the United States Department of Housing and Urban Development to 200% to more accurately reflect rental market conditions in the County. All other provisions of Penal Code Section 396 subdivision (j)(11)(B) shall remain unchanged. (26-1319)
