REPORT BACK ON PATHWAYS TO ECONOMIC RECOVERY FOR WOMEN, COMMUNITIES OF COLOR, AND THE CARE ECONOMY (ITEM NO. 34 AGENDA OF JUNE 22, 2021)

On June 22, 2021, the Board of Supervisors (Board) directed the Chief Executive Office (CEO), in consultation with, the Directors of Department of Consumer and Business Affairs (DCBA), Los Angeles County Development Authority (LACDA), and the Department of Regional Planning (DRP) to identify County-owned and leased properties, as well as vacant property offered by the faith-based community, that could serve as future childcare facilities and report back in 90 days with recommendations.

CEO Real Estate Division consulted and met with representatives from DCBA, LACDA, and DRP (Team) to develop an approach to collect the data and evaluate the findings. With the Team's assistance, we were able to create the attached two lists. The first list is an inventory of County-owned and leased properties that could potentially serve as future childcare facilities. Pursuant to the County's sovereign immunity, DRP can review and approve childcare facilities on County-owned and leased properties, including those in incorporated cities. However, each potential site must be reviewed for cost and suitability before a final decision can be made. The second list is an inventory of faith-based community owned properties in unincorporated communities. The list does not include properties in incorporated cities because the County's sovereign immunity does not apply to faith-based community owned properties, so DRP can only review and approve childcare facilities on these properties in unincorporated communities. The criteria used to identify these properties was the County Assessor's Use Code for a faith-based structure, such as church. Unfortunately, we were unable to use Assessor's Use Codes or other resources to identify vacant properties, but many of these properties could be partially vacant or underutilized (e.g., they have more parking than needed to meet Zoning Code requirements).

SUBJECT: **PLAN AND FRAMEWORK FOR IMPLEMENTING A COMPREHENSIVE EARLY CARE AND EDUCATION WORKFORCE DEVELOPMENT STRATEGY AND POLICY RECOMMENDATIONS FOR UNMET NEEDS FOR THE EARLY CARE AND EDUCATION WORKFORCE (ITEM 34, BOARD AGENDA OF JUNE 22, 2021)**

This is in response to the June 22, 2021 motion by the Board of Supervisors instructing the Director of the Office for the Advancement of Early Care and Education (OAECE) in the Department of Public Health (Public Health), in consultation with the Policy Roundtable for Child Care and Development Commission (Roundtable Commission), the Child Care Planning Committee (Planning Committee), the Directors of Workforce Development, Aging, and Community Services (WDACS), the Department of Public Social Services (DPSS), the Department of Consumer and Business Affairs (DCBA), the Los Angeles County Development Authority (LACDA), the Women and Girls Initiative (WGI), the Chief Executive Officer (CEO), and other relevant departments to:

1. Develop a plan and framework for implementing a comprehensive early care and education workforce development strategy equipped to support new and current workers in the field through educational and job training opportunities.
2. Report back on policy recommendations for unmet needs of the early care and education workforce in Los Angeles County with information related to compensation needs for the early care and education workforce who serve different ages of children in a variety of settings and proposed financial models to increase the wages for licensed early care and education centers and family child care homes based on best practices from other jurisdictions.

1. Plan and Framework for Implementing a Comprehensive Early Care and Education Workforce Development Strategy

OAECE, in coordination with the Roundtable Commission, the Planning Committee, the Directors of WDACS, DPSS, DCBA, LACDA, WGI, and the CEO, developed the following plan and framework for a comprehensive early care and education (ECE) workforce development Strategy. The process was rooted in the County of Los Angeles Unified Strategic Plan for Early Care and Education – 2020-2025 (Strategic

Plan), which was created by the OAECE, in partnership with the Roundtable Commission and the Planning Committee. The Strategic Plan focuses on four priority areas: 1) access to early care and education, 2) early care and education quality, 3) early care and education workforce supports, and 4) family and community engagement in early care and education issues. Grounded in the Strategic Plan's priority on early care and education workforce supports, OAECE conducted individual interviews with local experts from Child Care Resource and Referral Agencies (R&Rs), the Los Angeles County Office of Education (LACOE), institutions of higher education, WDACs, Child360, First 5 LA, and SEIU to understand the current issues facing the ECE workforce, the existing infrastructure and strategies in place, and system gaps affecting the ECE workforce. In addition to the interviews, OAECE conducted an extensive review of current research and recommendations from national, state, and local reports to inform recommendations. The following recommendations build out a comprehensive workforce development system and are organized by the six specific directives from the Board motion.

- a) **System Stabilization:** *An approach to stabilize licensed early care and education providers that are open during COVID-19 recovery and re-engage early care and education providers who have closed during the pandemic.*

Throughout the pandemic, ECE programs have remained open and serving families. Unfortunately, during COVID-19, ECE programs experienced a dramatic decrease in revenue combined with increased costs. Over the course of the pandemic, ECE providers have had to operate under public health restrictions that limited the number of children that could be enrolled. This, coupled with families' concerns about potential exposure to the virus as well as their own loss of income from the pandemic, has resulted in a dramatic loss of income for ECE providers. While income has been reduced by half, on average, expenses have also increased because of public health requirements (e.g., cleaning/sanitation, personal protective equipment). For many providers, particularly family child care home businesses, this has meant cutting their own salaries, taking on personal credit card debt, and temporarily or permanently closing their doors. As of September 1, 2021, 25 percent of the LA County ECE system remain closed and many that are open are in a financially fragile position.

Recommendation (a1): Provide operations grants to center-based early care and education and family child care providers to stabilize the system and prevent further closures.

Implementation Status:

- In Fall 2020, LA County DCBA, LACDA, and OAECE, in partnership with the LA County ECE COVID-19 Response Team¹ provided \$10 million of CARES Act funding through operations grants to 113 ECE centers and 349 family child care providers to help ECE programs re-open or have the ability to remain open.
- On July 27, 2021, LA County appropriated an additional \$10 million to LACDA through the American Rescue Plan Act to launch in Fall 2021 a second round of stabilization grants to support ECE programs to remain open and help re-open more programs. OAECE and the LAC ECE COVID-19 Response Team have been talking with ECE providers throughout the pandemic and would like to support those who have closed to reopen, as well as to help ECE providers that are economically fragile to remain open. With this in mind, OAECE

recommends increasing the child care operations grants by an additional \$10 million. With this increase in American Rescue Plan Act funding, LA County would provide resources to approximately 900 ECE providers.

- To ensure that family child care providers are operationally stable, OAECE also recommends partnering with LACDA, DCBA, and community partners like the Non-Profit Finance Fund to provide business technical assistance through a community of practice, coaching, trainings, and tools. This strategy is based upon key findings from the 2020 Los Angeles Early Care and Education Provider Financial Analysis. Due to the economic impact of the pandemic, there is even more urgency to provide business best practices to family child care homes. With an American Rescue Plan Act investment of \$5,000,000, the project would serve up to 500 family child care providers over a two-year period.

- b) ***Improved Qualifications and Career Pathways: A plan to support early care and education professionals to improve their qualifications and advance along the California Early Learning Career Lattice. Strategies may include but not be limited to support for Family, Friends, and Neighbors (FFN) to become licensed family child care homes, career and college advisement, apprenticeships, and financial incentives to increase completion of training, college coursework, degrees, and Child Development Permits.***

Prior to COVID-19, Los Angeles County's ECE system was facing a diminishing supply of licensed child care as well as a teacher shortage. The supply of licensed child care has been declining for over ten years in Los Angeles County, with home-based family child care providers leaving the field at an alarming rate. In fact, the supply of licensed family child care is at its lowest point in over 20 years. Recruitment and retention of qualified educators is a persistent challenge for the ECE field and a direct result of stagnant low compensation and challenging working conditions now exacerbated by the added stress and health risks associated with COVID-19. For these reasons the quantity of the ECE workforce has reached a crisis point.

Research has demonstrated that having a teacher with specialized knowledge and skills is associated with better child outcomes, particularly for those children most at risk for school failure. However according to the ECE Workforce Index, in California just under half (49 percent) of early childhood teachers in centers have a bachelor's degree and that figure is even lower for family child care home providers. While many current ECE workers lack formal preparation and education, they may have extensive experience and can demonstrate the competencies that ensure children in their care receive a high-quality experience. Understanding the various education and training requirements for different settings, how prior education units may or may not transfer, knowing which courses are needed and where to find them has often been cited as barriers and discourages individuals from pursuing or completing their degrees. College and career advisement programs have proven to be successful to help students and current providers navigate the educational requirements for working in ECE settings; however, these programs are scarce and can only serve a limited number of students. The majority of ECE providers earn a low wage making it more difficult to have the resources needed to participate in trainings and pursue a formal education to deepen their knowledge and competencies to better serve young children. This has often been cited as a significant barrier by providers.

Competency-based education pathways allow candidates to shorten the time it takes to get a degree while still ensuring they have the knowledge, skills, and abilities to be effective educators. Apprenticeships are another avenue to increase the qualifications of the workforce by allowing individuals currently in the field or new to the field to pursue a degree while working. There are also

a number of barriers to accessing and navigating the preparation and professional development system for early childhood in Los Angeles County. Significant investment in professional development pathways and supports that acknowledge competency, degree, and practice-based qualifications, as well as additional investment in compensation for the ECE workforce are needed to ensure there is a sufficient and ongoing supply of qualified educators.

Recommendation (b1): Increase early educators' participation in professional development through financial incentives and college and career advisement.

Implementation Status:

- Through the \$2.4 million California Department of Social Services (CDSS) Workforce Pathways grant, DPH-OAECE provides financial incentives to early educators to improve their qualifications. In FY 20-21, OAECE provided stipends to 1,219 early educators who completed 21 hours of professional development, college coursework, a degree, or their first child development permit.
- OAECE will continue to provide financial incentives to the ECE workforce this year in addition to launching a new college and career advisement program. Although advisement is being piloted, additional funding of \$3,000,000 over four years is needed to reach all early educators in need of this support service.

Recommendation (b2): Align and expand supports to strengthen family child care businesses, expand family child care services, and support FFN providers to formally enter the workforce.

Implementation Status:

- In FY 20-21, OAECE launched a financial incentive program for FFN providers who completed core ECE training or obtained a family child care home license. This strategy partners with the State funded Child Care Initiative Project (CCIP) to maximize resources for family child care providers. In FY 21-22, the program will expand to reach additional providers and pilot an advisement program for participants that will be funded by the CDSS Workforce Pathways grant.
- In July 2021, LA County dedicated an additional \$10 million of American Rescue Plan Act funding to this effort. WDCAS, LACDA, DBCA, and OAECE will partner with State funded programs like the CCIP and SEIU to align resources to expand the scope and scale of support for family child care providers.
- In September 2021, First 5 LA approved a Home-Based Child Care Strategy which will access the assets and challenges faced by ECE providers, as well as the needs of families. The landscape anyway will inform future investments in home-based ECE programs.

Recommendation (b3): Pilot competency-based pathways that allows the workforce to demonstrate skills to earn credit toward degrees.

Implementation Status:

- To diversify the ECE workforce, there is a need to develop college on-ramps to expedite the degree process based on competency-based testing. To address the increasing shortage of qualified ECE providers, LA County can partner with Partnerships in Education, Articulation, and Collaboration through Higher Education (PEACH), Unite-LA, and the Learning Policy Institute to design, pilot, and evaluate a competency-based education model for the ECE workforce. A total of \$2,000,000 over 4 years is needed for this effort.

Recommendation (b4): Invest in innovative “earn and learn” strategies, such as apprenticeship programs, to recruit, and train an effective workforce.

Implementation Status:

- Apprenticeships serve as an entry model for the ECE workforce that provides training, while earning wages. LA County WDACS is supporting the Child Care Resource Center (CCRR) and the Early Care and Education Pathways to Success (ECEPTS) apprenticeship pilot this fiscal year. WIOA funding in the amount of \$154,000 has been set aside for three cohorts, totaling 24 participants. WDACS, in partnership with OAECE, is seeking to leverage ARP funds and create a high road training partnership (H RTP) as part of its \$9 million multi-industry H RTP programming.
- c) ***System Coordination: Maximize partnerships with outside organizations and colleges such as Quality Start LA, the Los Angeles County Office of Education, First 5 LA, R&Rs, Alternative Payment Program agencies, Child360, and PEACH, and the California ECE Workforce Registry to leverage systems alignment, training and educational opportunities.***

Los Angeles County is home to a rich network of ECE programs administered by many different agencies and home-based child care businesses funded by numerous federal and state funding streams. Similar to this patchwork of programs, there are multiple efforts to support different aspects of the ECE workforce. However, there are few long-term and stable funding sources that target ECE workforce development programs. The strategies implemented are often disconnected and limited in scope and scale and the short-term funding for workforce development initiatives has resulted in the implementation of many strong programs ending when the funding ends. The lack of alignment and resources to coordinate services across a plethora of organizations that support the ECE workforce was emphasized in both the interviews and the literature review. Coordination and collaboration across the multiple systems that support the ECE workforce is essential to ensure the sustainability of a comprehensive workforce system.

Recommendation (c1): Establish and convene an ECE workforce collaborative to coordinate, align, and maximize resources.

Implementation Status:

- In FY 20-21, OAECE launched the Workforce Pathways LA Joint Committee on Workforce Systems Improvement which assessed the LA County ECE professional development landscape. In June 2021, the committee released “Learning from Today, Preparing for Tomorrow: An Early Care and Education Professional Development Analysis for Los Angeles County” and convened a forum to discuss next steps in building a better system. Based on the work forged by this effort led by the OAECE, the Quality Start LA Workforce Development Committee, and the Planning Committee Workforce Workgroup, this strategy needs \$1,000,000 over four years to expand, convene, and coordinate a countywide ECE workforce collaborative.
- The California ECE Workforce Registry (Registry) is an essential tool for tracking ECE workforce data such as demographics, qualifications, and compensation information and communicating with early educators and policy makers to inform decision-making. The Registry was instrumental in conducting recent ECE professional development system assessments in real-time. An investment of \$2,000,000 over four years is needed to refine and sustain the long-term data collection and management of the Registry.

- d) **Facility Development:** *Consult with relevant ECE stakeholders to provide recommendations to reduce fees, streamline the permitting process and review child care as a permitted use in certain zones to catalyze the opening of new child care providers in Los Angeles County.*

The FY 21-22 California budget includes \$250 million for Child Care Infrastructure Grants. These grants will provide support for the acquisition, construction, development, and renovation of child care facilities in primarily child care deserts. ECE providers serving LA County who receive these infrastructure grants will need technical assistance and support to navigate the various local licensing, zoning, permitting, and other regulatory processes that pose barriers to the development of new child care facilities and the expansion of existing facilities. In 2018, to address the unmet need for ECE services in the County, the Board of Supervisors adopted a motion in consultation with the Roundtable, OAECE, Internal Services (ISD), and Public Works (DPW) to explore whether unused County-owned property and County-owned buildings could be used to build new or house existing ECE facilities in accordance with state and local regulations. Although the process failed to identify county-owned properties, it did uncover and highlight the numerous hurdles that early care and education providers face when seeking to open or expand facilities and ultimately affirmed that there is not a system of support related to facilities for providers to utilize in Los Angeles County. Based on the report back to the Board of Supervisors on June 14, 2019, several policies and programs were identified to address these barriers including: (1) creating a “one-stop” website with informational resources for providers, including user-friendly summaries of state and local code requirements and permitting processes; and (2) Offering technical assistance and free one-on-one guidance to help providers navigate the development process from beginning to end.

Recommendation (d1): Expand ECE facilities by supporting ECE providers in navigating licensing, zoning, permitting, and other regulatory processes that pose barriers.

Implementation Status:

- In September 2021, the Low-Income Investment Fund (LIFF), in partnership with OAECE, First 5 LA, and the Planning Committee, launched a roundtable series to cultivate ECE facilities champions in LA County.
 - In addition, OAECE has dedicated \$100,000 to support the design of an on-line facilities development toolkit with informational resources for ECE providers. OAECE is currently having planning conversations with Public Counsel and the Department of Regional Planning to prepare for the launch of this project.
 - As a final piece of the implementation plan, OAECE recommends that a dedicated position be created in the Department of Regional Planning to support ECE facility navigation. In order to take the first steps in developing a facilities support system for ECE services, action is needed to create an LA County staff position to provide support and technical assistance to ECE providers opening new facilities or expanding existing facilities. Approximately, \$800,000 over four years would be needed to support facility navigation staff.
- e) **Philanthropic Partnerships:** *Identify funding to capitalize early care and education providers who were forced to close between March 2020 to present to spur re-opening.*

Partnering with philanthropy enables the public sector to leverage the knowledge, resources, and flexibility of philanthropic organizations that share the same goals. LA County is fortunate in that the Country’s largest private foundations, family foundations, First 5 LA, and other key government agencies who are focused on improving outcomes for young children come together under the leadership of the LA Partnership for Early Childhood Investment (LA Partnership). The mission of

the LA Partnership is to invest in and promote innovations that advance the lifelong health and well-being of LA County children, ages 0-5.

Recommendation (e1): Work with LA Partnership for Early Childhood Investment to align public and private resources.

Implementation Status:

- Although public and private funders have invested resources in ECE workforce development, there have been limited conversations on how to align resources. The LA Partnership has invited OAECE as well as representatives from the Offices of Supervisor Holly J. Mitchell and Supervisor Sheila Kuehl to present the recommendations in this motion and possible roles for the philanthropic community.
- f) **Funding Approach:** *Identify any staffing needs and costs that would be required to implement the comprehensive workforce development strategy along with identification of any potential funding sources.*

LA County has a deep history in supporting ECE workforce development. As one of the four priority areas in the Strategic Plan, several ECE workforce initiatives have secured funding and are either in the planning phase or underway. As shared earlier in this report, action is taking place in core ECE workforce development areas including operations grants to stabilize the ECE industry, financial incentives to improve the qualifications of the ECE workforce, programs to support family child care providers, and initiatives to increase and/or improve ECE facilities. Although there are numerous ECE workforce strategies being implemented throughout LA County, the planning effort for this report affirmed several gaps that still need to be addressed. OAECE recommends the following investments to address some of these prominent ECE workforce development system gaps.

Recommendation (f1): Secure funding to support the following components of the Comprehensive ECE Workforce Development Framework

Implementation Status:

- **System Stabilization: Expand Operations Grants for ECE providers**
 - Amount Needed: \$10,000,000 over 1 year.
 - Potential Funders: American Rescue Plan Act
- **System Stabilization: Support Family Child Care Homes with Business Technical Assistance**
 - Amount Needed: \$5,000,000 over 2 years
 - Potential Funders: American Rescue Plan Act, Partnership for Early Childhood Investment
- **Improved Qualifications and Career Pathways: Expand College and Career Advisement for Early Educators**
 - Amount Needed: \$3,000,000 over 4 years
 - Potential Funders: LA Partnership for Early Childhood Investment
- **Improved Qualifications and Career Pathways: Develop and Pilot Competency-based College Credit Pathway for Early Educators**
 - Amount Needed: \$2,000,000 over 4 years
 - Potential Funders: American Rescue Plan Funding, LA Partnership for Early Childhood Investment
- **System Coordination: Strengthen ECE Workforce Development Systems Coordination**

- Amount Needed: \$1,000,000 over 4 years
- Potential Funders: American Rescue Plan Funding, First 5 LA, LA Partnership for Early Childhood Investment
- **System Coordination:** Fortify Workforce Data Infrastructure through the ECE Workforce Registry
 - Amount Needed: \$2,000,000 over 4 years
 - Potential Funders: LA Partnership for Early Childhood Investment
- **Facility Development:** Establish LA County ECE Facilities Development Navigation:
 - Amount Needed: \$800,000 over 4 years
 - Potential Funders: American Rescue Plan Funding, LA Partnership for Early Childhood Investment

2. Policy Recommendations for Unmet Needs for the Early Care and Education Workforce

The reasons for the decline in the number of ECE workers are complex and interconnected, but at the heart of the issue is low compensation and lack of benefits. While the average annual salary of a kindergarten teacher in LA County is \$66,000 including benefits, the ECE sector earns, on average, just above the minimum wage. In fact, 50 percent of ECE worker households are “low income” and a high proportion of these households are on some form of public assistance. While the wages for the industry overall are low, disparities within the field also exist depending on funding source, ages of children served, organization, and type of care provided. There is also significant racial disparity in wages. According to the [2020 Early Childhood Workforce Index report](#), Black women and educators who work with infants and toddlers are paid thousands of dollars less than their peers. Investments in wages and the professional development of the ECE workforce would not only reduce the need for providers to rely on public assistance but would make the field more attractive to new and higher skilled workers. According to a UNITE-LA report, “every \$1 invested in higher wages (both for existing and potential ECE workers) would yield a 1.9 multiplier effect across the economy in terms of output and a corresponding 1.3 multiplier effect for additional labor income in LA County.”

Recommendation (2a): Provide financial relief to individuals in the ECE workforce through, for example, stipends, bonuses, tax credits, education loan forgiveness, home buying assistance, and local increases to child care vouchers.

Implementation Status:

- Based on an April 2021 agreement between the State of California and California Child Care Providers United, providers who served children receiving subsidies from the following programs in March 2021 are eligible for a \$600 per-child stipend:
 - CalWORKS Stages One, Two and Three
 - Alternative Payment Programs including Migrant Alternative Payment Programs
 - General Child Care and Development Programs
 - Migrant Child Care and Development Programs
 - Family Child Care Home Education Network
 - Child Care and Development Services for Children with Special Needs
 - Emergency Child Care Bridge Program for Foster Children (Bridge Program)
- Although one-time stipends are an excellent resource, they are a short-term benefit. A sustainable strategy is needed to lift a significant portion of the ECE workforce out of poverty. Currently, State subsidized early educators who accept child care vouchers through the Alternative Payment program are only reimbursed for child care services at the 75th

percentile of the 2018 market rate. In both San Francisco and Riverside County, local government has increased the compensation of early educators by blending local and state funding.

- In this time of COVID-19 recovery, LA County has the opportunity to increase the compensation of early educators by braiding local and State funding. Based on the success of the LA County CARES Act Child Care Vouchers, OAECE recommends augmenting LA County child care vouchers through the Alternative Payment program with local funding to 100 percent of the 2018 market rate.

Recommendation (2b): Re-envision the State ECE reimbursement system to cover the true cost of quality care.

Implementation Status:

- Historically, ECE providers who care for low-income children through State subsidies are reimbursed by two different rates, the Standard Reimbursement Rate and the Regional Market Rate. In FY 20-21, the Board of Supervisors took a position of support on State legislation SB 246 that proposed restructuring the reimbursement system for ECE providers. As a result of statewide advocacy, the spirit of SB 246 was incorporated into the FY 21-22 California budget by:
 - Raising the Regional Market Rate from the 75th percentile of the 2016 Regional Market Rate survey to the 75th percentile of the 2018 survey effective January 1, 2022.
 - Transitioning direct service contractors from a reimbursement based on the lower Standard Reimbursement Rate to the higher Regional Market Rate ceiling.
 - Establishing the reimbursement rate for license exempt providers (Family, Friends, and Neighbors) to receive a State subsidy equivalent to 70 percent of the licensed family child care home rate ceiling.
- Although this is the beginning of a transformation of the reimbursement system for ECE providers, there is a great deal of policy work that needs to continue. This moment in time presents a unique opportunity for LA County to sponsor or support legislation to increase the State ECE reimbursement rate to a level that covers the true cost of care for young children and would raise much of the ECE workforce out of poverty.

Recommendation (2c): Develop and endorse LA County ECE salary scale/compensation standards that outline the qualifications and minimum salary/benefits for different levels of the workforce using the living wage/self-sufficiency standards as the floor and parity with Transition Kindergarten – 3rd grade educator salaries for lead teachers with bachelor's degree and Child Development Permit, regardless of setting.

Implementation Status:

- The Center for the Study of Child Care Employment has identified the development and use of wage scales as a necessary strategy for improving compensation. A wage scale is intended to be used to inform cost-estimate modeling for expanding access to high-quality ECE and to provide a guide for fair and just compensation. Salary scales have been built in Minnesota, Illinois, North Carolina, Oregon, and Washington.
- In LA County, this work began in 2005 when the CEO and OAECE first published the Model Compensation Scale for Child Care Workers Study. In 2020, LA County released a Comprehensive Fiscal Analysis of the Los Angeles County Early Care and Education System, which provides a new wage analysis.
- LA County is well positioned to lead the promotion of a wage scale for the ECE workforce. OAECE recommends that the salary scale in the Comprehensive Fiscal Analysis of the Los

Angeles County Early Care and Education System be used as an advocacy tool that the Board of Supervisors could endorse and elevate in a campaign for increased ECE provider compensation.

Recommendation (2d): Explore the feasibility of a local ongoing revenue source to subsidize compensation for early care and education providers.

Implementation Status:

- In 1987, a children's agenda was passed by the San Francisco Board of Supervisors which set the stage for several ballot initiatives for children, including an initiative to support child care wages. In 2020, Alameda County implemented a tax to support ECE and San Joaquin County has implemented a cannabis tax to support children and youth.
- Throughout the COVID-19 pandemic, there has been a spotlight at the State and Federal levels on the critical importance of early care and education. OAECE recommends that LA County build on this momentum by identifying a local revenue source to increase compensation that meets a defined wage scale for the ECE workforce.

OAECE will continue to update you on significant developments related to this plan. If you have questions or need additional information, please let me know.

SUBJECT: **PATHWAYS TO ECONOMIC MOBILITY FOR WOMEN, COMMUNITIES OF COLOR AND THE CARE ECONOMY (ITEM NO. 34, AGENDA OF JUNE 22, 2021)**

The COVID-19 pandemic exacerbated inequities in employment and wages for women and communities of color. While the federal government's massive stimulus spending has attempted to address and mitigate those widening inequalities, there remain important differences in unemployment and wage rates for men and women, as well as for different racial and ethnic groups. These persistent gaps highlight the continued need for workforce strategies targeted to uplift these populations.

This report describes key strategies being implemented or under development to address the barriers women - especially women of color - encounter while (a) when attempting to enter, re-enter, and maintain standing in the labor force and (b) in finding employment in high growth industries. The key strategies include better leveraging and promoting existing business and employment incentives; upskilling and/or retraining workers; creating or expanding High Road Training Partnerships (HRTPs) and/or employment in pandemic responsive industries that tend to attract women; and providing enhanced supportive services to overcome pandemic-related barriers to employment.



BACKGROUND

On June 22, 2021, the Board of Supervisors (Board) adopted a motion by Supervisors Holly J. Mitchell and Sheila Kuehl, directing the Department of Workforce Development, Aging and Community Services (WDACS), in consultation with the new administration of Economic and Workforce Development, to report back within 60 days to identify opportunities to incentivize the rapid re-employment of women through the Los Angeles County Works Initiative and establish a framework for female focused HRTPs.

INCENTIVES FOR THE RAPID RE-EMPLOYMENT OF WOMEN

The L.A. County Works Initiative convened approximately 100 industry leaders and surveyed 1,893 LA County businesses during the first several months of the COVID-19 pandemic. Based on the information gathered through this outreach, WDACS identified key takeaways and provided specific recommendations to support economic recovery and rapid re-employment.

Two (2) of the top five (5) County services requested by businesses were incentives for hiring: subsidized wages and tax credits. Reducing the cost of hiring while businesses are struggling to recover is key to encouraging rapid re-employment. Currently, the County offers several programs that offer such incentives, including on-the-job training (OJT), which previously subsidized up to 50% of wages while training a new worker, and transitional subsidized employment and Youth@Work (Y@W) that provides full, but temporary subsidies.

In response, and to both enhance and supplement these existing programs, WDACS is developing and marketing the following employer supports to incentivize hiring:

- On-the-Job Training (OJT). To support struggling businesses and encourage hiring, WDACS successfully pursued a temporary waiver from the State where OJT subsidies will be increased to 90% for businesses with fewer than 50 employees. This waiver is approved through June 2022 and applies to Workforce Innovation Opportunity Act (WIOA) funding. American Recovery Plan (ARP) funding, which will also be used for OJT, does not require a waiver process and will continue beyond the current June 2022 WIOA waiver expiration. WDACS released the policy for American Job Centers of California implementation and plans to market its availability beginning in early 2022.
- Work Opportunity Tax Credit (WOTC). The WOTC offers businesses a tax credit for hiring from specific populations, including justice-involved individuals and the long-term unemployed. WOTC is currently available and WDACS is assisting interested and eligible businesses.
- Incumbent Worker Training. Provides funding for upskilling current employees in order to create economic mobility and vacancies for training participants to backfill.
- Homeless Hiring Tax Credit. Beginning in January 2022, the public workforce system will be able to offer businesses a tax credit for hiring individuals recently experiencing homelessness.

While these incentives can be leveraged to encourage the rapid re-employment of women, none of them specifically target women because Proposition 209 prevents the creation of incentives based on sex. WDACS is leveraging the Anti-Racism, Diversity, and Inclusion (ARDI) resources to identify disproportionately impacted communities and target outreach efforts to these communities and

businesses. Additionally, we will work with the Department of Consumer and Business Affairs (DCBA) and Los Angeles County Development Authority (LACDA), including teams newly transferred to the Economic and Workforce Development Branch at WDACS, to match grant recipients that are women-owned, as well as businesses in industries that primarily attract women to these incentive programs. And, as part of our developing Fair Chance expansion campaign, we plan on additional targeted outreach to increase hiring commitment to justice-involved individuals, with a strong focus on women. We will work with County Counsel in the implementation phase to ensure Proposition 209 compliance while still ensuring underrepresentation and adverse impacts are considered in our outreach and service prioritization effort.

FRAMEWORK FOR WOMEN-FOCUSED HRTPs

The California State HRTPs model centers around convening employers, workers, and unions with the explicit goal of improving economic mobility for workers while reducing the skills gaps identified by the business community. This model prioritizes a) job quality; b) climate resiliency; and, importantly, c) links regional industry strategies to a statewide skills agenda. A recent report by the University of California, Los Angeles Labor Center found that HRTPs offer a more inclusive definition of industry leadership, build collective power, place systemic issues like racial inequity at the forefront, and importantly, advance women's representation in traditionally male-dominated fields.¹ The California Employment Development Department notes that there are over 200 nontraditional occupations in California. Women make up 25 percent or less of the workforce for these jobs, which typically have a higher rate of pay than jobs traditionally held by women.²

WDACS' framework for HRTPs targeting women will focus on high wage, high growth sectors in which women have traditionally been under-represented. Key examples of industries that meet this definition are (a) technology, (b) advanced manufacturing, and (c) construction. WDACS is working on an HRTP in advanced manufacturing that cuts across manufacturing sub-sectors and builds on existing manufacturing workforce training programs. This model focuses on getting women and people of color into this high-growth industry while creating a scalable framework for replication within other sectors. The framework includes convening key stakeholders to establish priorities, aligning training pipelines, recruiting from target populations, placing participants in jobs in the sector, and upskilling employees to create economic mobility and additional vacancies for placements. As one indication of this HRTP's promise, the Los Angeles County Workforce Development Board (WDB) is preparing to fund a sector intermediary in advanced manufacturing.

The contract will be for \$200,000 a year for two (2) years. Additionally, WDACS was awarded \$9 million in ARP funds to design an inclusive HRTP framework and begin implementation in several sectors, including Film & Digital Media and Healthcare. Our manufacturing and film and digital media programs will support more than 80 internships and jobs. These numbers will increase as we expand our sectoral

partnerships. We will be monitoring our success in getting women, especially women of color, into these pathways and will adjust our strategies accordingly.

There are existing models of how HRTPs can be linked to enhanced supports to meet the specific needs of targeted populations. The County's Career Center at the Century Regional Detention Facility provides participating women with pre-apprenticeship construction training, mentorship, and supportive services through Women In Non-Traditional Employment Roles (WINTER) and then allows those participants to transition on to a union apprenticeship in their construction field of choice. The holistic model of occupational training and case management support has proven successful for women in nontraditional fields as they mitigate systemic and personal barriers to employment access and stability. We will apply these best practices to ensure women are properly supported as they seek career opportunities in these industries that are predominately male.

As we engage businesses in HRTPs, we will ensure our Y@W programming benefits from these HRTPs and interested young women are guided towards these opportunities as well. For example, Y@W has a program focused on getting women into nontraditional occupations called Women in Technology. This initiative aims to place women between the ages of 14 and 24 into information technology (IT) work experience within a County department. The first step provides 100 hours of paid work experience in an IT position at a County Department. Step 2 provides a 12-month paid internship in IT with a County Department, further advancing knowledge, experiences, and skillsets. One of the ultimate outcomes the program aims to achieve is placement of participants into entry-level IT positions in the County, which essentially guarantees them a career a civil service. As we identify H RTP partners and hiring businesses, the Y@W program will be introduced as an opportunity to engage young women and introduce them to career opportunities through future placement and/or inspire them to pursue higher education.

ENHANCED SUPPORTIVE SERVICES

To successfully diversify these industries, HRTPs will place emphasis on supportive services, such as early care and education (ECE) supports and mentorship. In addition, these partnerships and resources will be effectively marketed to women, and particularly women of color.

Childcare remains a significant barrier to rapid re-employment for women. A March 2021 Kaiser Family Foundation survey found that the number one reason why women dropped out of the labor force during the COVID-19 pandemic was access to quality and affordable ECE services^{3 4}. WDACS is working closely with the Department of Public Health's Office for the Advancement of Early Care and Education (OAECE) to support their ongoing workforce strategies to increase the supply of quality, affordable childcare. The County's WDB has supported a home visitation training partnership/apprenticeship in the Antelope Valley that commits to long-term skill development for careers in early education. This model will help inform the development of an ARP funded project under H RTP funding to help upskill ECE

workers and is part of OAECE's strategic plan to uplift the industry. WDACS is also working with LACDA to identify opportunities for care infrastructure.

WDACS received \$1 million in ARP funds for our developing Worker Equity Fund (WEF) program. These funds will expand on our current supportive services model by allowing flexibility and provide immediate funds to address urgent needs. For example, because women tend to be primary caregivers (of children and elderly family members), the WEF funds can be used to cover emergency care, housing supports, and other emergency needs that can be extra barriers to employment. WEF will require ARP approval and we target the release of the WEF in early 2022.

CONCLUSION

WDACS will continue to build pathways to economic mobility for women and communities of color by promoting hiring incentives, which promote rapid re-employment, by increasing access to HRTPs in both the care economy and non-traditional sectors, and through the increased use of supportive services via the WEF. These approaches focus on in-demand industries with family sustaining wages and pathways to advancement.

PLAN AND FRAMEWORK FOR CREATING AN ENTREPRENEURSHIP ACADEMY AND RECOMMENDATIONS FOR A COMPREHENSIVE STRATEGY FOR A COUNTYWIDE ECONOMIC MOBILITY INITIATIVE (ITEM NO. 34, AGENDA OF JUNE 22, 2021)

On June 22, 2021, your Board adopted a motion directing the Department of Consumer and Business Affairs (DCBA), in consultation with the Chief Executive Officer (CEO), the Directors of the Workforce Development, Aging, and Community Services (WDACS), the Los Angeles County Development Authority (LACDA), the Office for the Advancement of Early Care and Education (OAECE), the Women and Girls Initiative (WGI), the Department of Public Social Services (DPSS), the administration of the upcoming Economic and Workforce Development Department (EWDD), and other relevant stakeholders, to report back in writing within 60 days with a plan and framework to establish an Economic Mobility Initiative (Initiative) that supports women and people of color by:

1. Creating a Community Impact Entrepreneurship Academy (Academy) to stabilize and grow businesses owned by women and people of color through additional resources such as technical assistance, upskilling, and digital literacy.
2. Establishing an Economic Mobility Initiative that develops a centralized network of resources, including lines of credit and other forms of finance, and commercial lease assistance and microloans for those accepted into the Entrepreneurship Academy. Financial support will be provided through microloans that can be used for start-up and expansion, as well as increased costs due to COVID-19 safety regulations.
3. A plan to develop an asset-building revolving loan fund for those participating in the Entrepreneurship Academy.
4. Resources needed to administer the Entrepreneurship Academy.

Plan and Framework for A County Entrepreneurship Academy

DCBA, in coordination with WDACS, LACDA, WGI, and CEO, developed the following plan and framework for the creation of a Countywide Community Impact Entrepreneurship Academy. The framework was informed by a market analysis of existing programs and current business needs, as well as the ongoing work of your Board to ensure equitable investment of American Rescue Plan Act (ARPA) funds in populations disproportionately impacted by COVID-19.

DCBA interviewed both internal and external partners to understand how an Entrepreneurship Academy could best support our business community in the present landscape. Additionally, DCBA examined the effectiveness of the County's existing Entrepreneur Center. Building upon this foundation, DCBA identified the following minimum components:

1. *Flexible and COVID-Responsive Learning Model*

In order to ensure student success and improve completion rates, the learning model will require scheduling flexibility for entrepreneurs and multiple engagement points to support retention.

2. *Needs Assessment*

The program should include an initial assessment of the entrepreneur in order to identify their current capabilities and areas for growth, including digital acumen. This assessment will help determine the best triage strategies for the entrepreneur, including referrals to partners, development of an action plan based on actual needs, matchmaking opportunities, appropriate level of technical assistance and additional resources.

3. *Access to Technical Assistance and Mentorship*

As part of the program, entrepreneurs should receive additional support to apply new concepts and obtain access to other resources.

4. *Access to Capital*

Research shows that startups have a difficult time obtaining funding due to the impact personal finances has on the initial growth phases. New and existing resources should focus on educating entrepreneurs on available resources, how to access these resources and expanding grants and loans to underserved communities.

DCBA has drafted a proposed framework (Attachment I) and implementation plan, tentative timeline, action items, and designated department leads to further develop and implement, to the extent possible, the recommended strategies. This framework is intended to act as a reference for the Anti-Racism, Diversity, and Inclusion Initiative (ARDI) design process and allows for the incorporation of feedback as the design is finalized and approved by CEO.

New Economic and Workforce Development Department

On April 20, 2021, your Board adopted a motion that directed CEO, in consultation with WDACS, DCBA, LACDA, and any other relevant departments, to implement a phased plan towards

establishing a new EWDD. As outlined in CEO's September 30, 2021, proposed transition plan¹, DCBA's Office of Small Business was moved to WDACS on October 18th as part of the initial phase of creating an economic and workforce development branch. The transfer of the Office of Small Business included the following programs:

1. East LA Entrepreneur Center;
2. Small Business Concierge Program;
3. LA County Procurement Technical Assistance Center; and
4. Administration of the County's various business certification programs.

CEO is working closely with all impacted departments to transfer funding and programs during the next phases of implementation. ARP-funded programs, including the Economic Mobility Initiative, are among those scheduled to be transitioned to the new EWDD. DCBA will continue to provide support to WDACS to transition the Economic Mobility Initiative to the County's new EWDD, which recently appointed an Executive Director. This transition will allow the design team to optimize a framework to achieve economic mobility in alignment with the new department head's vision.

NEXT STEPS

Given the recent establishment of the EWDD within the WDACS structure, future updates to your board on the developments related to this report back will be led by WDACS. Nonetheless, DCBA will continue working with WDACS on this initiative as it moves forward with the ARDI process.

UNMET NEEDS AND BACKGROUND

On January 20, 2020, the Department of Consumer and Business Affairs (DCBA), in partnership with the Department of Workforce Development, Aging and Community Services (WDACS), launched the East Los Angeles Entrepreneur Center (Center). The Center serves as a central point of contact for local entrepreneurs through strategic partner resources, successfully helping them navigate the complexity of the permit process and the nuances of opening and maintaining a business within the Los Angeles County. Since the launch, the Center has made considerable progress in providing local entrepreneurs with a variety of support services including access to capital, business assistance, mentoring, one-on-one counseling, workshops, and seminars. Although the program model of the singular physical location has proven to be successful in helping entrepreneurs expedite processes and open and operate a business, the COVID-19 pandemic highlighted the need for flexible engagement models that can shift to remote-based interactions.

The County of Los Angeles is home to more than 244,000 businesses with more women-owned and minority-owned businesses than any other county in the nation. The economic impacts of the COVID-19 pandemic have not been equally distributed across constituent groups. Small businesses and vulnerable households have been disproportionately financially impacted due to barriers to aid and existing disparities. In particular, the pandemic severely impacted businesses that were unable to transition their operations to a remote model. According to LAEDC's Pathways for Economic Resiliency report², low-income jobs performed on location such as hospitality, food service and personal care were most likely unable to make this transition. Additionally, employees in these occupations faced reduced hours, furloughs, and layoffs due to their non-essential status as defined by the Los Angeles County Department of Public Health. Many of these industries are also women-dominated which resulted in disproportionately high unemployment rates among women and women of color; women of color already exit the workforce at higher rates than any other demographic group. According to a UCLA Latino Policy and Politics Initiative study³, drivers for this exit include lack of training, higher wage opportunities, and reliable childcare options, as well as pandemic-related closures. Conversely, unemployment from more traditional worksites has also been a driver to increased entrepreneurship. In California, in July 2020, the number of applications to start a business reached an all-time high of 51,117, a 53 percent increase compared to the same period in 2019, according to the Census Bureau⁴.

Moreover, by 2030, it is expected that one in every five U.S. residents will be of retirement age. Yet there have been few reports on older adults' participation in the workforce and their financial standing. It has been well established that women over 50, a growing subset of the population, experience financial vulnerability at higher rates than other demographics. They face a unique set of challenges that range from carrying a greater

burden of family responsibilities — including childcare — to earning lower incomes and experiencing a higher unemployment rate. They are also more vulnerable to financial insecurity and when employed, are more likely to have part-time jobs with fewer benefits. Moreover, as a result of widowhood, women over 50 are less likely to be married and, therefore, less likely to benefit from being part of a dual-income household. It is important to note that even though women earn less than men, they have a higher life expectancy, which means they need to be particularly attuned to saving for retirement. While a number of studies have explored gender disparities across all age groups, fewer resources have been devoted specifically to studying how older women are impacted by structural inequality. As baby boomers and Generation X age, exploring this disparity has become increasingly important.

Ensuring that more women-owned businesses are launched or connected to resources to recover is good for aggregate economic growth and community development.

FRAMEWORK FOR AN ENTREPRENEURSHIP ACADEMY

As directed by your Board's June 2021 motion, DCBA set out to identify the feasibility of developing and implementing an Academy to stabilize and grow women-owned businesses and businesses of color, including those that have been adversely impacted by the pandemic. The Academy should incorporate additional resources to support training opportunities for small businesses and micro-entrepreneurs in targeted industries including personal care, retail and early childcare and education industries. These resources and training opportunities should include technical assistance, legal assistance, capacity building, upskilling, contracting opportunities and digital literacy to transition small business services to an online platform, as well as identify the resources needed to administer the program.

After conducting research and holding discussions with the County of Los Angeles and community partners, DCBA has developed an Academy framework with in-person cohorts and an online curriculum that both supports entrepreneurs during the critical business design phase through a strategic plan as well as opportunities for established businesses to grow. Additionally, the cohort of participating entrepreneurs should also include representatives from the above targeted industries. Due to the varying needs of these entrepreneurs and their sectors, the County of Los Angeles should build on existing informational frameworks that can create more robust mentoring and networking opportunities, which are often lacking in niche groups.

DCBA recommends the following framework for a County of Los Angeles Entrepreneurship Academy:

Two-track Model

DCBA recommends a two-track model that supports either entry-level entrepreneurs or established businesses across various industries. Interested businesses can apply to participate in a 10-week cohort in either track and would complete various courses on general business concepts, finances, funding, and administration of their business based

on their respective industries. These courses would support economic recovery, resiliency, and growth. For a list of sample courses please see Table I.

Post Cohort Technical Assistance and Mentorship

DCBA recommends guaranteed robust technical assistance, mentorship, and networking for six (6) to twelve (12) months post-cohort completion. The cohort networking sessions and monthly individualized or group check-ins should be moderated by industry or business expert(s) to provide a platform of continual support to ensure that barriers, which may arise, are addressed timely. This component would both increase resiliency for newly established businesses and provide additional opportunities for established businesses to improve operations, identify other sources of funding, increase networking, and learn best practices. The County should also explore opportunities to provide incentives such as set asides or stipends to entrepreneurs and businesses participating in the academy.

Eligibility Requirements

DCBA recommends the following eligibility requirements⁵ for participation in the Entrepreneurship Academy:

An Online Entrepreneurship Program Component

Creating flexible options for learning will be particularly important to women entrepreneurs as they often need to balance professional and in-home responsibilities. Additionally, online offerings have grown increasingly popular for organizations and institutions in recent years -- especially during the pandemic. Organizations that were able to quickly pivot to a virtual operation model were able to provide timely critical resources and services to businesses impacted by the pandemic. Since entrepreneurs' time is often limited, students may benefit from an opportunity to take both in-person trainings from community partners at a pre-determined location or complete the coursework through an online program.

DCBA recommends including a user-friendly online and mobile entrepreneurship portal where classes and coursework are available to interested entrepreneurs and businesses

and allows for administrative tracking to help track user engagement, course completions, user feedback, skill development and outcomes. The online portal should include robust ready-made multilingual (subtitles and audio) coursework available to students on various entrepreneurship and business development subjects, including but not limited to digital literacy, marketing, management, recruitment, disaster preparedness and resiliency, pricing strategy, and financial accounting. Completion of the courses should also include certificates of completion which increase the value for professionals. Furthermore, online programs should include various methodologies and course options to best suit the needs of the entrepreneurs. The key to an online curriculum is the flexibility to offer approaches that best suit the entrepreneur and their specific needs and challenges, as opposed to a prescriptive module.

Physical Location for an Entrepreneur Academy

Identifying a physical location to house the Academy for in-person training and classes presents challenges. The County can probe possible locations such as the Vermont-Manchester mixed use development that is currently being explored by the Second Supervisorial District to be used as some type of incubator space. However, the lack of available spaces in the county that can serve as an incubator space is a challenge and those that may be available will require improvements. The Vermont-Manchester mixed use project, for example, may not be available until sometime in 2024. There is an opportunity to utilize County facilities that have large meeting rooms or auditoriums to hold cohort in-person classes such as WDACS' community centers and network of America's Job Centers, as well as County libraries. Additionally, we will need to work in coordination with the Anti-Racism, Diversity, and Inclusion Initiative (ARDI) to ensure that any location will cater to the most in-need communities to align with the American Rescue Plan requirements.

Supporting the Child Care Industry

Early childcare providers have been impacted by both the pandemic and pre-existing disparities. Providers are predominantly women, who face social and systemic barriers to equity, and immigrants of varying linguistic abilities. In addition, providers are often part of the same socio-economic groups they serve, and absorb necessary costs such as CPR certification, licensing fees, site improvements, classroom and building materials, fencing, shade, outdoor safety, and other costs set at the local or municipal level. DCBA convened meetings with the Office for the Advancement of Early Care and Education (OAECE) and the Child Care Alliance of Los Angeles to understand how an Entrepreneurship Academy could best support childcare entrepreneurs and businesses. The Child Care Alliance of Los Angeles assists family childcare providers, including those seeking a license to begin their business and those newly licensed, with training, coaching, information, resources, and support. Our discussions confirmed that the best solution to support this industry is to work with the County of Los Angeles State funded Resource and Referral (R&R) provider network directly. The eight R&Rs provide nuanced training opportunities to family childcare providers. This network strives to build childcare capacity, specifically family

childcare, which are those who run childcare out of their homes. The network has two primary goals:

1. To increase the number of providers and their capacity to serve children, specifically infants and toddlers.
2. To increase their capacity to go from small to large.

R&R trainings focus on assisting new (0-12 months) providers that need help on such things as understanding licensing regulations, dealing with health and safety, how many children and of what ages they can have, and how to recruit children and families. Business related courses may include establishing a legal structure, entity or DBA, tracking/planning expenses, marketing, and pricing structure. DCBA recommends helping the R&R expand their current trainings to not only support the network by building their capacity but also leverage their interested clients and partnership for content development. OAECE supports this recommendation and has included this as part of their recommendations in their most recent report back to the Board⁶. OAECE is also working on a program to provide stipends to providers to help cover initial costs by completing training and licensing requirements, anywhere from \$100-650. Additionally, LACDA has received an allocation of \$20M in ARPA funding to provide childcare grants and to develop an incubation program. Whereas WDACS' Office of Small Business (OSB) is planning on expanding their existing training efforts, which are funded through the State, to provide business development training and technical assistance to childcare providers.

DCBA is currently scheduling follow up meetings with LACDA and OAECE to identify needed resources.

Supporting Women and People of Color-Owned Businesses

DCBA is currently working with the WGI to understand what supportive resources are being underutilized by women and how they can connect to the Economic Mobility Initiative. DCBA has commenced discussions with WGI about how the ARDI process can be inclusive of a gender equity lens to ensure that the intention of the motion remains and is reflected in the data collected. This will help us create key performance indicators and goals for success. Targeted communities, informed by ARDI, will be built into the scope of work. Additionally, outreach and delivery strategies will center around equity principles.

Next Steps

In order to successfully implement the Academy framework and its various components, DCBA has drafted a matrix identifying program needs, department leads, and potential funding sources (Table II). Additionally, DCBA will need to work with WDACS' OSB on

the following:

1. Complete the ARDI design process, including defining equity principles, reporting elements, which will inform the development of a scope of work. Based on initial discussions with ARDI, there will be a need for multiple ARDI design submissions due to the multiple components of the framework.
2. Identify and execute a contract with a technical assistance provider and online platform host.
3. Transition the project to WDACS at which point, additional staffing needs will be defined to provide adequate project management and expansion at different phases.

Track 1 Proposed Coursework- Phase I – Beginner and Intermediate Business	
This phase offers step-by-step direction to entrepreneurs to learn what is needed to develop the entrepreneur mindset, business basics, and the development of a personalized business plan to effectively launch a business. The phase I curriculum could include, but is not limited to:	
a.	Exploring your business idea in greater detail, including how to conduct market research to identify potential customers and competitors.
b.	Laws, regulations, and required permits/licenses relevant to your business.

d.	How to pitch your idea to effectively communicate the value of your product or service to potential customers. Lessons will focus on teaching entrepreneurs how to identify their target market and learn about the importance of positioning and branding.

f.	Managing the different areas of a business to organize and make a profit. This includes hiring, training, and managing employees, including the value of customer service and employees as a seller.
g.	How to track your business, including bookkeeping and accounting terms and processes, such as Accounts Payable, Accounts Receivable, the use of a Balance Sheet and Cash Flow Projections.
h.	Funding or raising capital.
i.	Legal considerations including contracts and legal structures.
j.	Developing an action plan and timeline for success.
Track 1 Proposed Coursework- Intermediate Business	
For entrepreneurs with mature business ideas. The program can assist in creating a funding model and action plan. This curriculum could include, but is not limited to:	
a.	How to determine how much funding a business needs and about the different types of capital available, such as the costs and characteristics of each.
b.	Equity, what it takes to give up ownership and the different types of investors, including negotiation techniques.
c.	Action plan development.

d. Helping students understand credit and debt.
Track II Proposed Coursework – Advanced Business
a. Advanced: This tier would be industry specific to those most impacted due to the pandemic (i.e. personal care, retail, and childcare and education). Cohort would be broken into small groups by industry
b. Industry specific regulatory requirements: Permits, licenses, certifications and other industry specific requirements needed to launch and annually
c. Making the numbers work: Deeper dive into costing/pricing
d. Funding: Loans, grants, raising capital (i.e. crowd funding, venture capitalist, investors, other)
e. Contracts: Leasing, purchase agreements, and other contractual related guidance, and negotiations
f. Human Resources: Hiring, training, labor laws
g. Local, State and Federal government contracting and subcontracting opportunities

On June 22, 2021, the Board of Supervisors directed the Chief Executive Office (CEO), in consultation with, the Directors of Department of Consumer and Business Affairs, Los Angeles County Development Authority, and the Department of Regional Planning to identify County-owned and leased properties, as well as vacant property offered by the faith-based community, that could serve as future childcare facilities and report back in 90 days with recommendations.

- 257 FBOs did not respond to the calls
- 183 FBOs were not contacted as we were unable to find contact information
- 157 FBOs were not interested
- 59 FBOs expressed an interest in the opportunity

REPORT BACK ON PATHWAYS TO ECONOMIC RECOVERY FOR WOMEN, COMMUNITIES OF COLOR, AND THE CARE ECONOMY (ITEM NO. 34, AGENDA OF JUNE 22, 2021)

On June 22, 2021, the Board of Supervisors directed the Chief Executive Office, in consultation with the Directors of Department of Consumer and Business Affairs (DCBA), Los Angeles County Development Authority, and the Department of Regional Planning to identify County-owned and leased properties, as well as vacant property offered by the faith-based community, that could serve as future childcare facilities and report back in 90 days with recommendations.

A report back dated October 13, 2021, included two lists of properties. The second list included 450 faith-based community owned properties, which the Chief Executive Office committed to begin contacting to determine if ownership was interested in offering a childcare care facility. Subsequently, the Department of Public Health provided a list of 206 additional faith-based organizations (FBOs) that helped with or expressed an interest in helping with vaccination clinics. The 206 FBOs were added to the original list and efforts were made to contact them.

A report back dated January 20, 2022, provided an update on the outreach efforts and requested a 60-day extension to reach out to departments to obtain contact information for those FBOs with missing contact information. Below is an update that was performed with the additional contact information received.

- 258 FBOs did not respond to the calls
- 170 FBOs were not contacted as we were unable to find contact information
- 168 FBOs were not interested
- 62 FBOs expressed an interest in the opportunity

Please note that we followed up weekly with the 258 FBOs who have not responded to our calls or emails. Please see the attached list of the 62 FBOs that expressed an interest in this opportunity. We have provided this information to the Department of Workforce Development, Aging and Community Services and to the Office for the Advancement of Early Care and Education and recommend that both agencies incorporate working with the interested FBOs into their respective efforts to increase the availability of private childcare facilities in the County. We will continue to work with both agencies to evaluate partnership with FBOs.
