LAHSA JPA



Themes

- JPA Agreement does not answer all questions concerning governance
 - Ex. Continuum of Care ("CoC") is not addressed
 - JPA predates CoC
- JPA Agreement is confusing, perhaps by design
- Conflicting language on authority: broad and narrow, particularly on funding
 - Authority may exercise "powers common" to each party to agreement
 - BUT City and County ultimately determine funding and use of funds independent of each other



Creation

- Created in 1993, not modified since 2001
- Arguably, changes in 2001 deemphasized partnership between County and City
 - Observation made by City of Los Angeles Report (Chief Legislative Analyst)
- Changes included:
 - Removed language requiring
 - The "review and approval by the County and City" for "new programs and policies which are significant . . . [and] added to the Authority's jurisdiction"
 - Removed -
 - "[I]nnovative programs" matching funds program



Purpose

Conceived as independent body

- A "public entity *separate* and apart" from the City and County
- "Capable of exercising independent powers"

(JPA § 1)

New Services

 "[T]o design, fund and operate other homeless and related social services to assist those who are eligible for those services"

(JPA § 1)

Maintain Services (Existing Prior to LAHSA)

"Coordinate the *operation of existing services* for
 the homeless which the
 parties operated separately
 prior to forming [LAHSA]"

(JPA § 1)



Membership in JPA

- "Additional separate *political entities may become associated parties* . . . on such terms and conditions as the [City and County] may require" (JPA § 3(d))
 - Based on state law, "political entity" could be construed as:
 - Other cities
 - COGs if organized as JPA
 - Non-profits providing services to homeless
- "Associated parties" are *subject to restricted rights*:
 - Not entitled to added seat on LAHSA Commission
 - Not entitled to modify or terminate JPA
 - Changes to restricted rights requires amendments to JPA (and agreement of parties)



Authority of LAHSA

"[P]owers common to the Parties to this Agreement to provide homeless programs and services and other related social services to assist those persons in the community who are eligible to receive those services" (JPA § 4(b))

LAHSA "shall undertake such acts in furtherance of the programs and goals of County and City under this Agreement" (JPA § 4(b))



Funding Obligations

Administrative Funds

Must contribute of "administrative overhead base" of at least \$1,166,570 from the City and \$912,000 from the County

Program Funds

Must contribute "[t]he full amount of the *Emergency* Shelter Grant (ESG) program funds as allocated to the City and County annually by [HUD]" (JPA § 11(a)(1))

Other Funds

- Either party *may*, but is not required to, provide additional funds (JPA § 11(a)(2))
- City-contributed funds
 "shall be used to fund services only within the City" (JPA § 11(c))



Tension between Stated Authority and Funding

"[P]owers common to the Parties to this Agreement to provide homeless programs and services and other related social services to assist those persons in the community who are eligible to receive those services"

- (1) "The Commission shall annually . . submit a proposed budget to the Parties"
- (2) "The annual *approved budget by each Party* shall constitute the combined approved budget of the Authority . . ."
- (3) **Program funds**, i.e., HUD, Measure H, City funds for specific purposes **undergo** federal, county, or city **governance prior to distribution to LAHSA**

"Many interviewees pointed to *overlapping or unclear lines of authority* for various governing bodies as a challenge. This *lack of clarity exists even for members of these bodies* – they are unsure when they are the final decision-makers versus when they are acting in an advisory capacity." (A. Oliva, p. 7)



LAHSA Commission

Authority

- LAHSA "shall be governed" by a commission
- Hires Executive Director
 - Executive Director "shall serve at the will of the Commission
 - "[B]e subject to policies, rules, regulations and instruction"
- Delegate powers including: (i)
 "assist" in "development of
 policy"" and (ii) "Administer[]
 the business and activities of
 LAHSA in organizing and
 executing its programs"

Membership

- *10 members* "serve at the pleasure of their respective appointing powers"
 - 5 appointed by BOS
 - 5 appointed by Mayor
 - No term limits
 - 3-year terms
- JPA amendment needed to increase seats
- No required qualifications for member selection

- *May establish "Advisory Board"* to "advise . . . on matters related to policy and planning for any of the purposes for which [LAHSA] was formed"
- May establish standing and ad hoc committees with members or non-members of Commission



Authority

- CoC created after LAHSA
- CoC Board "must act on behalf of the Continuum"
 - HUD requires formation of CoCs as a condition of obtaining certain federal CoC funds (appx. \$32 mil. in 2020-21)
- Oversees collaborative application for CoC funds
- Selects *HMIS* lead and oversees HMIS management

Membership

- 17 members
 - "No more than eight (8) SPA representatives"
 - "No more than nine (9) atlarge representatives"
 - At least 1 member with lived experience
 - No term limits
 - 2-year terms
- LAHSA Commission could be CoC Board subject to amendment of governing documents

- According to LAHSA, the CoC Board is "advisory" to LAHSA Commission (see LAHSA Presentation, 10/6/21)
 - Existence of LAHSA
 Commission is unique
- CoC governed by CoC Charter
 - Charter may be amended by a majority vote quorum of "Representative Membership" of CoC (Charter, Art. 6)
 - "Representative Membership" is
 55-member Regional
 Homelessness Advisory Council,
 which is currently suspended



CES Policy Council

Authority

- CoC designated the CES Policy Council as the "policy oversight entity for CES" (CoC Charter Art. 4(B))
- LAHSA advertises the Council as "the governing body" of CES (CES Policy Process)
 - "[G]uiding strategic policy development"
 - "Supporting implementation through alignment of practice and resources"
 - "Monitoring"

23 members

- Service Providers (6x)
- Local CoCs (4x)
- Lived Experience (2x)
- County DCFS, DMH, DPSS
- City Housing Dept.
- Dept. of Veteran Affairs
- Public Housing Author. (3x)
- Other: Domestic Violence
 Rep.; Housing Developer;
 Philanthropy (1x); United Way

- According to LAHSA, the CES
 Policy Council is "advisory"
 to the LAHSA Commission (see
 LAHSA Presentation, 10/6/21)
- CES Policy Council not required by federal law and unique to Los Angeles
- Established under CoC Charter



Other LAHSA Committees

- Lived Experience Advisory Board (LEAB)
- Homeless Youth Forum of Los Angeles (HYFLA)

"To provide advice and counsel to the Los Angeles Homeless Services Authority (LAHSA) and its partners in support of efforts that strive to end homelessness, as well as **to ensure that the unique voice of those with the lived experience of homelessness is incorporated** throughout the Los Angeles homeless crisis response system"

"HYFLA is a group of young people with lived experience convened by LAHSA in 2017 to jumpstart authentic collaboration between youth and the homeless services system."

Selection of members: Sanitation Districts

Cities

- Presiding officer of each city in the sanitation district
 - Alternates may be selected
 - Selected by governing body in cities under
 2.5M people
 - Selected by presiding officer in cities over
 2.5M people
- Cities may sit on multiple sanitation districts

Unincorporated County

- Presiding officer of the county board of supervisors
 - Alternates may be selected
 - In districts with only 1 city and no sanitary district, an additional member of the county board of supervisors

Other

 A member of the governing body of each sanitary district in the sanitation district



Selection of members: Metro

LA County & City of LA

- 5 BOS members
- Mayor of the City of L.A.
- 2 members appointed by the Mayor
 - 1 member required to be
 City Councilmember
 - 1 member can be member of the public

Other Cities

- 4 members, either a mayor or city council, from:
 - North County/SFV (1x)
 - Southwest Corridor (1x)
 - San Gabriel Valley (1x)
 - Southeast Long Beach (1x)
- Members selected by City Selection Committee
 - Requires vote of committee members representing a majority of the population, except City of Los Angeles

Other

1 nonvoting member appointed by the Governor



Selection of members: SCAQMD

Counties & City of LA

- 4 members, with one appointed by L.A., Orange, Riverside, and San Bernardino counties respectively
 - Members include BOS members, mayor, or city council member
- 1 member of the Los Angeles City Council, appointed by Mayor

Cities

- 1 member, Orange County city
- 1 member, Riverside County city
- 1 member, San Bernardino Cnty.
 city
- 1 member, W. L.A. Cnty. cities
- 1 member, E. L.A. Cnty. cities
- Members determined by city selection committee
 - By majority vote of all cities in SCAQMD, based on population
 - Members include mayor or city council member of each city

- 1 member appointed by the Governor, with the advice and consent of the Senate
- 1 member appointed by the Senate Committee on Rules
- 1 member appointed by the Speaker of the Assembly
