**Authorize Joint Application(s) to and Participation in the Homekey Round 2 Program**

In July 2020, the California Governor Gavin Newsom announced the Homekey Program (Homekey), which made \$500 million available for local jurisdictions to purchase hotels and other properties to be used as interim and permanent housing for people experiencing homelessness (PEH) who are impacted by COVID-19, and \$50 million for operating subsidies. Later in 2020, Governor Newsom announced the addition of another \$250 million in funding for Homekey. Through Homekey, the County of Los Angeles (County) was awarded \$108 million to acquire 10 properties for use as housing for PEH who are impacted by COVID-19, and to temporarily subsidize operations. Nine of the 10 properties are currently operating as interim housing and will be converted to permanent supportive housing (PSH) beginning in 2023. One of the properties is currently operating as PSH. To date, nearly 1,500 PEH have been served at the County's Homekey sites.

In September 2021, the California Department of Housing and Community Development (HCD) announced the availability of approximately \$1.45 billion of Homekey grant funding through its Round 2 Notice of Funding Availability (NOFA). Through the NOFA, HCD established a four-month priority application period from the release date of the Homekey application (Application) in late September through January 31, 2022.

During this prioritization period, HCD will group Applications into one of the eight geographic regions laid out within the NOFA, unless the Application is prioritized for Homeless Youth or Tribal Entity set-asides. HCD has set aside nearly \$360 million for jurisdictions within the County that apply within the priority Application period. HCD has also set aside funding of \$116 million for Homeless Youth and \$72.5 million for projects serving Tribal Entities statewide. To further encourage the timely submission of Applications, HCD will also award a bonus of \$10,000 per assisted unit to Applications submitted by January 31, 2022.

In late October 2021, the County's Chief Executive Office (CEO) released a Request for Statement of Interest (RFSI) for the identification of nonprofit or for-profit entities (Corporations) to apply jointly with the County for the Homekey Round 2 NOFA. Selected Corporations would own and, in some cases, operate properties acquired through Homekey Round 2. The RFSI identifies the threshold criteria for entities wishing to apply jointly with the County for Homekey Round 2 funding, which largely reflects the criteria established by HCD in the NOFA. In addition, based on consultation with individual Board of Supervisors' (Board) offices and the CEO's partners in the homeless services system who are familiar with Countywide needs and best practices, the RFSI established preferred property features for respondents proposing acquisition or development of specific properties. The County received more than 30 responses to the RFSI, which were reviewed by a panel of experts. After this review, the County identified 11 Corporations with which to submit Application(s) to HCD by January 31, 2022 for Homekey Round 2 funding. Joint Application(s) with these or other Corporations targeting a submission date after January 31, 2022 may be considered at a later date.

Selected Corporations have performed due diligence on the properties to ensure the properties are appropriate for use as interim or PSH for PEH, and to support a fair market purchase price for the properties. Corporations conducted negotiations with the property owners so that the properties can be acquired on appropriate terms and conditions. Due diligence and other property information have been reviewed by the CEO and its consultants, who are experts in affordable housing development.

The State's Homekey Round 2 funds will be used to pay for the cost to acquire,

develop, and/or rehabilitate each property. In some cases, a local match will be required to acquire, develop, and/or rehabilitate each property. In such cases, the County will utilize its American Rescue Plan Act Tranche 1 funding, as indicated in the spending plan approved by the Board on November 30, 2021.

Based on the results of due diligence and the Corporations' successful negotiations with the property owners, the CEO recommends jointly applying for the 19 properties listed on Attachment 1 (collectively, "Properties" and singularly, a "Property") with selected Corporations for the purchase price stated therein.

If the Application(s) are approved, the County and Corporations must enter into agreements to facilitate the funding and development of the properties for their intended use consistent with the requirements of Homekey Round 2 and other funding sources.

Assembly Bill 140 establishes a statutory exemption from the California Environmental Quality Act for activities meeting certain conditions that receive funding through the Homekey Round 2 NOFA, but other exemptions are also applicable to the proposed projects. Project descriptions of the proposed Homekey Round 2 projects are included in Attachment 1.

**I THEREFORE MOVE THAT THE BOARD OF SUPERVISORS:**

1. Find that the 19 "Projects," which include the proposed acquisition and renovation or development, as applicable, of the properties listed on Attachment 1, are exempt from the California Environmental Quality Act (CEQA) pursuant to Health and Safety Code Section 50675.1.4, to the extent the proposed activities utilize Homekey funds allocated pursuant to Health and Safety Code Section 50675.1.3 and meet the applicable conditions contained in Health and Safety Code Section 50675.1.4, pursuant to Government Code Section 65650 et seq., to the extent they are by right supportive housing developments, pursuant to Government Code Section 65660 et seq., to the extent they are by right low barrier navigation center developments, pursuant to Public Resources Code Section 21080.27, to the extent they are emergency shelter or supportive housing developments within the City of Los Angeles, and pursuant to Public Resources Code Section 21080.50, to the extent they are

- interim motel housing conversions. Further, find that the Projects are statutorily exempt from CEQA pursuant to Section 21080(b)(4) of the Public Resources Code and Section 15269(c) of the State CEQA Guidelines, which exempts specific actions necessary to prevent or mitigate an emergency and also categorically exempt pursuant to Sections 15301 (Existing Facilities), 15302 (Replacement or Reconstruction), 15303 (New Construction or Conversion of Small Structures), 15304 (Minor Alterations to Land), 15311 (Accessory Structures), and 15332 (Infill Development) of the State CEQA Guidelines, and Classes 1, 2, 3, 4, and 11 of the County's Environmental Document Reporting Procedures and Guidelines, Appendix G, because the Projects are within certain classes of projects that have been determined not to have a significant effect on the environment. In addition, based on the records of the proposed Projects, they will comply with all applicable regulations, and are not in a sensitive environment and there are no cumulative impacts, unusual circumstances, damage to scenic highways, listing on hazardous waste site lists compiled pursuant to Government Code Section 65962.5, or indication that they may cause a substantial adverse change in the significance of a historical resource that would make the exemptions inapplicable. Upon approval of these actions, the Chief Executive Officer (CEO) will file Notices of Exemption (Notices) with the County Clerk pursuant to Section 21152 of the Public Resources Code and will post the Notices to the County's website pursuant to Section 20192.2 of the Public Resources Code.
2. Approve the attached authorizing resolution(s), authorizing and directing the CEO, Chief Operating Officer (COO), Assistant CEO, or Director of the Los Angeles County Homeless Initiative, or their designees, to submit joint Application(s) to Housing and Community Development (HCD) in response to the Notice of Funding Availability, and to jointly apply for Homekey grant funds in the amounts indicated in each authorizing resolution; and approve the Projects.
  3. If the Application(s) is/are approved, the CEO, COO, Assistant CEO, or Director

of the Los Angeles County Homeless Initiative, or their designees, is/are hereby authorized and directed to enter into, execute, and deliver Standard Agreement(s) in a total amount not to exceed the amounts specified in each authorizing resolution, and any and all other documents required or deemed necessary or appropriate to secure the Homekey funds from HCD and to participate in the Homekey Program, and all amendments thereto.

**\*Project Type Descriptions**

**Motel Conversion to Interim Housing:** Corporation will rehabilitate motel property. Rehabilitation may include renovations to ensure the property is compliant with all applicable health and safety standards and is in compliance with accessibility requirements; upgrades to common areas; replacement of some appliances, flooring, window coverings, etc.; filling of swimming pools; installation of security features; and other activities that utilize existing structures.

**Motel Conversion to Permanent Supportive Housing:** Corporation will rehabilitate motel property. Rehabilitation may include renovations to ensure the property is compliant with all applicable health and safety standards and is in compliance with accessibility requirements; addition of kitchenettes where they are not present; upgrades to common areas; replacement of some appliances, flooring, window coverings, etc.; filling of swimming pools; installation of security features; and other activities that primarily utilize existing structures.

**New Construction Infill for Interim Housing:** Corporation owns a property that currently has 476 permanent housing units on site. Corporation owns this property, and currently operates 476 units of permanent affordable housing at this location. The plan is to develop 100 new apartment units on the grounds to be used to provide interim housing. The additional units will be integrated with existing units.

**New Construction, Modular, for Permanent Supportive Housing:** Corporation will construct a modular housing development on land it already owns. The project utilizes single-use recycled shipping containers, which will be prefabricated off-site modular units.

**Acquisition of Rehabilitated Multifamily Building for Interim Housing:** Corporation will acquire the multifamily building once all renovations are complete.

**Acquisition of Newly Constructed Multifamily Building for Permanent Supportive Housing:** Corporation will acquire the newly constructed multifamily building once construction is complete.
