Re: OPPOSE AB 957

Dear Senate Judiciary Committee Members,

We write on behalf of thousands of California Parents Union members to express opposition to AB957. I, Tracy Henderson, also write as a licensed California attorney personally. As you know the purpose of the bill is to “..require the court to strongly consider that affirming the minor’s gender identity is in the best interest of the child if a nonconsenting parent objects to a name change to conform to the minor’s gender identity.” The bill is legally offensive for several reasons.

The most important issue is that this bill will encourage Judges to violate their canons of ethics. As found in the California Rules of Court, it is mandatory that a Judge do the following:

- 1) *Uphold the Integrity and **Independence** of the Judiciary*; Cal Rules of Court, Canon 1
- 2) *Avoid impropriety and **appearance of impropriety***; Cal Rules of Court, Canon 2
- 3) *Perform the Duties of the Judicial Office **Impartially***; Cal Rules of Court, Canon 3

Each of these canons are requisites for every Judge. They are also self-explanatory. Pointedly, no Judge can be dictated to - by the legislature - as to how to rule on a case. The Judge’s are required to rule based on the law and the facts before them objectively and *without* bias. I would submit this is especially important when a ruling is based on a very dangerous issue that could result in a permanent life altering decision. The undisputed fact is that participating in changing “genders” of a minor child is extremely controversial and medically dangerous. Judges cannot be told to favor one side or the other ethically. The Advisory Committee commentary on the first canon aptly makes the point:

ADVISORY COMMITTEE COMMENTARY: Canon I

Deference to the judgments and rulings of courts depends upon public confidence in the integrity and independence* of judges. The integrity* and independence* of judges depend in turn upon their acting without fear or favor. Although judges should be independent, they must comply with the law * and the provisions of this code. Public confidence in the impartiality* of the judiciary is maintained by the adherence of each judge to this responsibility. Conversely, violations of this code diminish public confidence in the judiciary and thereby do injury to the system of government under law.*

*The basic function of an independent, impartial, * and honorable judiciary is to maintain the utmost integrity* in decision-making, and this code should be read and interpreted with that function in mind.*

It must be said even more directly – this bill essentially is telling a Judge to rule in favor of a name change for a minor based on “gender identity” and against a parent who does not support their child’s name being changed. This “directive” violates the separation of powers doctrine on its face which will also likely subject it to serious legal challenges.

Finally, the current law in the context of family law courts requires a Judge to rule in favor of the *best interest of the child*. If the intent behind this bill is to truly help children, then it should mandate a Court to instead order a series of visits to a psychotherapist before *any* outward physical manifestation of change of “gender” occurs. The fact is that any child who wants to change their name from boy to girl or girl to boy suffers from the mental condition of gender dysphoria¹, that they typically grow out of. What they need is professional help.²
