REPORT BACK ON PREPARING LOS ANGELES COUNTY IN ADVANCE OF THE 2026 MEN'S FIFA WORLD CUP AND 2028 OLYMPIC AND PARALYMPIC GAMES (ITEM NO. 9, AGENDA OF JULY 11, 2023)

On July 11, 2023, the Board of Supervisors (Board) directed the Chief Executive Officer to convene a County inter-departmental working group to review the 2028 Olympic and Paralympic Games Agreement (Games Agreement) between the City of Los Angeles (City) and the Los Angeles Organizing Committee for the Olympic and Paralympic Games (LA28) and to report back in 120 days on LA28 and City commitments and goals in the Games Agreement, identify and analyze the commitments and goals that align with County priorities, and describe LA28 and City plans to fulfill these commitments and goals.

Similarly, the Board directed the Chief Executive Officer to identify and review public benefit plans, agreements, or commitments made by FIFA or the World Cup Host Committee in anticipation of the FIFA World Cup in 2026. Despite County requests, public benefit plans or agreements for the FIFA World Cup have not been made available. We will continue to meet with the Los Angeles Sports and Entertainment Commission and provide the Board with a separate report on the FIFA World Cup when additional information is received. The remainder of this report addresses the 2028 Olympic and Paralympic Games (2028 Games).

It should be noted that although the County is not part of the Games Agreement for the 2028 Games, the impact of the 2028 Games will be Countywide. This will require the County to collaborate with the City and LA28 in planning for the

delivery of public services during the 2028 Games. As directed by your Board, the Chief Executive Office (CEO) has created an inter-departmental working group and reviewed the Games Agreement in line with corresponding County service priorities.

County Inter-departmental Working Group

In July 2023, the CEO convened County departments, and gathered input related to service areas in which the County plays a critical role, and where County involvement is essential for the greatest benefit to Los Angeles County residents. The CEO shared an initial working group structure and obtained feedback from meeting participants. As a result of the feedback received at this meeting, the County Service Priorities were developed (Attachment I). This structure organizes the County's inter-departmental working group into five (5) focus areas – Equitable Access, Economic Empowerment, Operations and Logistical Coordination, Public Safety, and Lasting Impact. The working group structure will report to the CEO with the CEO serving in an oversight and advisory role, including Countywide coordination and County representation with external organizations.

Since July, the CEO has met with the County department leads that will facilitate the inter-departmental working group meetings for each of the focus areas and further refined the County Service Priorities. As subject matter experts, the department leads will represent their respective departments within the focus areas and will collaborate with supporting departments in each area over the subsequent months to continue review of the Games Agreement and relevant plans; expand on County priorities; form part of LA28 planning committees, where feasible; assess challenges and opportunities; and advise on needed resources and support.

Games Agreement and Alignment to County Service Priorities

Our review of the Games Agreement and discussions with the City and LA28 also helped to shape the County Service Priorities as these represent significant areas associated with the legacy and impact of the 2028 Games, as well as an organizational framework for partnership with the City and LA28. The County Service Priorities align with the commitments of LA28 and the City to advance accessibility, human rights, community access, community business and workforce development, sustainability, arts and culture, mobility and transportation, and public safety.

The County Service Priorities focus on benefits to communities Countywide. Specifically, as the County provides municipal services to unincorporated areas and contracted services to cities throughout Los Angeles County, the 2028 Games will likely affect the provision of County services in these areas. The County will need to assess the potential impacts of the 2028 Games within these communities and ensure that all services are continuously and efficiently provided to residents at the appropriate service levels to prevent limitations or disruptions in services. The map in Attachment II shows unincorporated areas and contract cities with Sheriff and Fire Department services within one (1) mile of 2028 Games venues, identified to date. Though other contract services are provided in these areas, Sheriff and Fire

services coincide with most services. (Note that LA28 has not finalized venue locations.) Therefore, the map showing service impacts may change.

Countywide coordination and communication between the City, LA 28, and the County are critical as planning efforts for the 2028 Games advance. The County is also responsible for the management of homelessness, health, public health, and other essential services in Los Angeles County. Accordingly, the County's regional role and expertise can help efficiently leverage resources and serve as a valuable and strategic partner during the 2028 Games.

Next Steps

As directed by your Board, the CEO will return in 12 months from your Board's July 11, 2023, motion with recommendations on County resources requirements, programming and costs, and proposed strategies to mitigate anticipated impacts. In the interim, the CEO will continue collaborating with Board offices, LA28, the City, and the Los Angeles Metropolitan Transportation Authority. Additionally, the CEO and inter-departmental working group will review the impacts to County and contract city services and identify strategies to support the 2028 Games in the Los Angeles County region.

As a valued partner, the County can effectively coordinate County operations to complement the 2028 Games activities while offering a seamless Olympics and Paralympics Games experience for all Los Angeles County residents and visitors.


