We are writing to express our support for your bill, the Local 988 Response Act of 2023 (H.R. 4974), because it presents a much-needed solution to one of the challenges that has faced 988 in the first year of its implementation. Our Board approved a motion on August 8, 2023, in support of this bill that would require the federal government to implement georouting for 988 and ensure that callers get access to their local 988 call center while also protecting their privacy by concealing their exact location.

Since the enactment of the National Suicide Hotline Act in 2020 (S. 2661), Los Angeles County (County) has worked with our local, state, and federal partners to implement 988 and connect it to mobile crisis response services. Prior to the 988 launch date, the County contracted with Didi Hirsch to run our local 988 call center and included as part of the contract the capability to transfer calls as needed to the Department of Mental Health (DMH) to dispatch mobile response teams. Additionally, the County has sponsored and supported state and federal legislation to provide funding for 988 call centers and crisis mobile response teams.

The federal legislation that created 988, designed the number for calls to be routed to call centers based on the area code of the caller's phone number. This means that no matter where in the country someone is when they dial 988, their call will be routed based on their area code. As such, people who live in Los Angeles County but have an out-of-County area code will not be routed to the County's call center when using 988. This becomes a significant problem when the person calling needs an in-person mobile crisis response team because only the County's call center is set up to connect with DMH to dispatch teams. It has led to some confusion and frustration across the County when people have called 988 and requested an in-person response team but have reached a call center outside of the County, unbeknownst to them. It has also limited DMH's ability to advertise 988 and encourage Los Angeles County residents to dial 988 when they need a mental health crisis response.

The County has been consistently advocating for the federal government to implement georouting for 988, as it would route a 988 call to the call center geographically nearest to the caller instead of through their area code. This option would ensure that a caller gets access to their local 988 call center while also protecting their privacy, which has been a concern for many mental health advocates. For example, 911 calls use "geolocation" technology to find the precise location of the caller. Georouting is different from geolocation because it would not identify someone's exact location but would route their phone call to the nearest call center, which is ideal for 988.

Implementing georouting for 988 will help ensure a quicker response by mental health professionals. This is especially important in our County, since approximately 15 percent of calls made annually to our DMH Help Line come from out-of-county area codes. H.R. 4974 will ensure that anyone who calls 988 from within Los Angeles County will be routed to the County's call center, making sure they get the response they need, including in-person mobile crisis teams when appropriate. In addition, H.R. 4974 will require carriers to allow calls and texts to 988 even if the plan is inactive or the carrier is experiencing service interruptions or failures, and it will require multi-line systems like hotel and office phones to support the direct dialing of 988.

For these reasons, we support H.R. 4974, to help address a critical need for one of the challenges that has faced 988 during the first year of its implementation.
