			Katherine Gardner	There is a hate group operating in greater Los Angeles. Since June 2023, Leave Our Kids Alone or LOKA, the so-called "parental rights" group that accuses the LGBTQ community and its allies of "indoctrinating" or "grooming" children, has targeted queer people at school board meetings, schools, public events like Pride celebrations, and public libraries across Southern California.  A shameful incident on 10/26/23 at the San Fernando Library saw drag queen Pickles and LA County Supervisor Lindsay Horvath chased to their cars while the hate group was allowed by police to remain and claim victory for their cause.  According to social media accounts (some of them belonging to LOKA), members of the group wore shirts with slogans like "Kill Your Local Pedophile." Other LOKAs pointed to the library and screamed, "They're molesting children in there!" to passersby. The LOKA's actions were less a demonstration of free speech and more akin to yelling "fire" in a crowded theater. This was an updated Pizzagate, an incitement of violence towards
				LGBTQ folks and their allies.  The San Fernando Library is only the latest in a series of events that allowed this group to claim public space while displacing LA's queer community. LA County and our city governments have fallen down on the job of protecting our LGBTQ citizens each and every LOKA appears.  At Saticoy Elementary on 6/2/23, police allowed the LOKA coalition to surround LGBTQ counter-protestors, at which point an unhoused man was beaten by men in LOKA shirts to the point of unconsciousness.
				At Glendale Unified School District's 6/6/23 board meeting, police allowed LOKA to cross police lines and surround LGBTQ counter-protestors. Men associated with the LOKA coalition were filmed mace-ing a member of the

	clergy and sucker punching a woman in the head.
	On 8/20/23 in downtown Los Angeles, LAPD faced away from several hundred LOKA members hurling anti-LGBTQ slurs and faced towards a handful of LGBTQ counter-protestors. LAPD then escorted the LOKA group to their chosen destination: LAUSD Headquarters.
	Outside LAUSD, LGBTQ counter-protestors, including SEIU and UTLA members, stood united to stop LOKA's advance. LAPD arrested LGBTQ activists, once again allowing the LOKAs to remain.
	These events, taken as a whole, form a pattern of systemic discrimination towards LGBTQ folks and allies.
	The government agencies in charge of LAPD, Glendale PD, LASD, and the San Fernando PD need to acknowledge that there is a pattern of police treating the hate groups with the utmost deference while targeting the LGBT side.
	The city needs to both investigate why police have consistently faced off towards LGBTQ folks and targeted them first for arrest at Saticoy, Glendale USD, and downtown LA while not protecting them from groups that want to physically hurt them. There seems to be an assumption that progressives pose a danger. It is as though anyone with grey hair, a rainbow flag, or an NPR tote bag constitutes a threat. It would appear there is a disproportionate focus on the dangers posed by "Antifa" (a term so broad it now means "anyone who voted for Biden"). Meanwhile, members of the greater LOKA coalition have been documented carrying bear mace and knives. Multiple journalists have identified Proud Boys and Capitol rioters in their midst.
	It's the same people attacking queer people again and again, making public life unsafe for one small minority group, and our police and local government are allowing this to happen.
	Our city and county governments must hold our police departments responsible for their failure to protect our LGBTQ community. A thorough investigation along with a plan to remedy these failures is overdue. Otherwis their silence amounts to tacit approval for government-sanctioned queer bashing.
Kelly Stuart	I have been a witness to two separate incidents by the same hate group LOKA, one at the Pasadena Courthouse, one at the San Fernando Library. The attackers were not legally held accountable and this has emboldened them to continue. We are in a dangerous time where LGBTQ people are
