Proposed Solutions: Enhance Compensation and Benefits: We must offer competitive compensation packages, including incentives such as MegaFlex benefits, and more equitable pay to attract and retain skilled physicians. Our community's health is at stake, and we cannot afford to delay action any longer. If that wasn't appalling enough, the two tiered bacefits structure of non-megaflex was megaflex has created a large disparity that is not equitable. Non-megaflex means no short term disability (e.g. maternity/paternity leave), less money for retirement, less money in our pocket. Please fight for equity. Please fight for more competitive pay and benefits for our physicians. Because if we want to recruit the best, we need to at least pay them what they are worth. To whom it concerns,

In April 2019, I took a full-time position at OV-UCLA. I had delayed getting pregnant due to demanding schedules during medical school, residency and fellowship, but decided it was time to start trying because I likely only had a few fertile years left. In May 2019 I became pregnant. When I asked colleagues what they did to pay for maternity leave, I was told to use my accrued overtime and vacation time. New parents are required to save accrued time and vacation for maternity leave, while other employees can use it for actual vacations or needed days off. Additionally, because I was new, I did not have any accrued time or vacation time. I worked longer hours during my pregnancy so that I could pay for my time off during maternity leave. Additionally, I purchased 3rd party short-term disability insurance, which paid for a portion of my leave, but required a significant amount of extra paperwork since it was not a standard county benefit and I paid for it out of pocket. Being a physician and not having short-term disability felt wrong and inequitable, but I was told, "that is how it is at the county". I'm glad this topic is being discussed, if you have any further guestions regarding my experience, I am more than happy to share.

I wrote the above letter in 2021. I had another baby in 2022. This time I had been at the county for 3 years, but still needed to drain all my vacation and holiday hours and it still did not cover my full maternity leave. Meanwhile, all my friends and family who live in California get some payment from the state for maternity leave, but we do not, because we work for the county. It almost feels like I'm being punished for working for the county. I love my patients and the service we do, but I don't deserve less because I care to serve. I'm now a mother of a 1-year-old and a 4-year-old, which is exhausting! I would LOVE to take vacation, but I must be very careful about how I use my time in case I choose to have another child. Additionally, my children and I are regularly ill due to daycare exposures, but I cannot take days off when I am sick because I literally drained all my hours for maternity leave. Does the county care about equity? Employees should not have to worry about making rent while they're on maternity leave or taking a sick day when their child has the flu. We should at least provide what CA state provides to the rest of the population in California.

Lastly, the delays in DHS coming to a deal on our benefits is exhausting. We work tirelessly in a broken healthcare system for the most marginalized patients. My co-workers and I are mission-driven, self-motivated, hard-working people, but it is starting to feel like we are being taken advantage of. These negotiations, or lack thereof, are a burden that is beginning to weigh on us. As the older generation with good benefits begins to retire, we are left asking ourselves, is it worth it? Does anyone see our work as worthwhile? I know my patients do and they are the only reason I stay, but burnout is very real, especially after the pandemic. We, healthcare workers, experienced a very traumatic few years and kept our heads up and kept on working, but the lack of negotiations for equitable benefits is a real kick to the gut. We are

At Harbor, I have seen the increasing wait times for our patients to get appointments with doctors and needed procedures and treatments all due to lack of physician staffing. We discharge patients who should see a psychiatrist in 7-10 days, but are told that the mental health clinic cannot give them an appointment to see one for months. We have patients who need to start cancer treatments as soon as possible, but who face unacceptable delays due to a lack of specialists. We need to have a contract that provides benefits and pay competitive enough to attract and retain physicians to work with us and serve the underserved. It's difficult when the pay and benefits differential between the County and HMOs/private practice is so huge we don't even have short- term disability that provides paid maternity leave! We worked through the unprecedented COVID-19 pandemic without a new contract and have not even received a cost of living adjustment to salary, which makes working for the County even less appealing for the doctors we need to hire. Negotiations between the County and UAPD seem to be going nowhere and it's the patients we serve who are suffering. Please do the right thing and ensure that our County hospitals and clinics can once again be competitive in hiring the medical professionals your constituents depend upon.

I am writing in my capacity as an Emergency Physician at a safety net hospital that is part of DHS. I have been with the County for 12 years, and I have been appalled by the negotiating tactics thus far in our (lack of) contract.

I am a Professor at UCLA. I love caring for our underserved patients. I am not in this for the money, as evidenced by the non-market pay scale that I have accepted despite constant higher paying offers in the local community. I love my job. Historically, DHS had been able to recruit the best, academically-minded, pedigreed physicians, to provide excellent care for our community. That is no longer the case.

UAPD has requested BASIC, REASONABLE and frankly affordable *benefits* in order to recruit and retain new caring physicians like myself. I have seen a deterioration in the quality of physicians we can recruit, and the shortage of physicians, due to a deficit in basic benefits. I am reasonable. We have been patient. It has been YEARS. And the current negotiation strategy is honestly disrespectful. We are at out wit's end.

I am convinced that nothing will make the County negotiators see reason except you. I am counting on you to put pressure on them to do what is right. I only care about my patients, and for the future of LA County DHS. When we have critical vacancies in DHS physician items, it puts dangerous pressure on the emergency room. We are at that point. Please help.

I am writing in support of improving the benefits for physicians at the county hospitals. Currently, poor salaries and benefits packages are leading to the health crises in LA.

At this time, people wait 3-6 months to see a psychiatrist and a year for basic specialty care like a colonoscopy. They wait 6-12 months to see medical specialists. The mental health areas of the jail system (which is the largest inpatient mental health hospital in the country) has a psychiatrist vacancy rate of 70%.

Our patients are being failed by the system. It is inhumane to ask people to wait this long for basic medical care just because they don't qualify for private insurance and use county services. People deserve health care regardless of their income, immigration status, or employment.

Healthcare can improve if the vacant physician positions are filled in the county, but to do that, the jobs need to be more attractive and competitive.

Dear Board of Supervisors,

Please allow me to introduce myself and state my concerns regarding the ongoing UAPD Unit 324 mediation and negotiations with the "bargaining team" for the physicians and surgeons at Harbor-UCLA Medical Center.

My name is Mark Volpicelli, M.D. and I have been practicing in California for almost 40 years as a board-certified ophthalmologist. I have been working at Harbor-UCLA Medical Center for the last 10 years after leaving private practice and teaching part-time in Stanford University's Department of Ophthalmology for almost 25 years.

I know you have numerous agenda items on your plate so I will make this as brief as possible, and I will apologize in advance if I come across as being less than subtle. However, after listening and learning what our UAPD representatives and your mediation team have been discussing, I cannot understand how your "accounting experts" have produced such an unorthodox, contrived and manipulated set of budget numbers that do not match reality. As you may already know, about 35% of the physicians' and surgeons' openings in the Department of Public Health are unfilled. For your experts to present a budget based on "full employment" and for outstanding COLA dollar amounts due for almost 880 unfilled positions is reprehensible.

I cannot speak for primary care or other surgical specialties, but I can speak to the ophthalmology workforce physician shortage at Harbor-UCLA. We perform about one thousand surgeries a year with a staff of only three full-time, board-certified ophthalmologists and three consulting part-time surgeons from UCLA.

All those cases are complex and are performed on patients in underserved populations within Los Angeles County who are referred to Harbor-UCLA since they have nowhere else to go.

Approximately one-third of those (one thousand) cases are in potentially blinding conditions of advanced glaucoma, severe diabetic retinopathy, and ocular trauma cases. Dozens of those cases are emergencies where a delay in evaluation and treatment of 24 hours alone can make the difference between "keeping the lights on" and total and permanent blindness.

Currently, we have a waiting list of two or three months for clinic appointments due to the backlog of available clinic time and available surgery time for our ever-increasing patient load.

To make matters worse, our Ophthalmology Department Chairperson, who was a retinal specialist, was recruited to The Stein Eye Institute at UCLA to head up their retinal trauma and fellowship program 6-months ago. Hence, we are even more backlogged with severe retinal pathology cases with no potential appointments or opportunity to see these unfortunate patients.

Our only remaining retina specialist is in the clinic and operating room for up to 12 hours a day three days a week and we are unable to recruit another retinal specialist due to the poor pay and benefit package being offered by the County. In fact, we have been actively searching and recruiting and have interviewed over a half dozen candidates. However, once the retina surgeon candidate hears about the pay being 50% of what they could make elsewhere in the community with a significantly more competitive benefit package they politely decline any employment offer and look elsewhere.

Recruitment and retention are the name of the game for all of us who are working in the County system. It is not just about more money and better benefits, but it is about being able to offer our patients the care they need and deserve in a timely and appropriate manner. I am sure you have heard about physician burn-out and how physicians are leaving medicine entirely. Well, our physicians are definitely burning out and they know they can get better pay, more respect and take care of their patients in a more expeditious fashion elsewhere. Ultimately, they vote with their feet and leave. Hence, the retention conundrum continues.

I think I can speak to this inequity without rose-colored glasses. I completed my Internship at Harbor General Hospital 39 years ago and my father completed his Internal Medicine residency at Harbor General Hospital back in 1961. I am at a place in my life and career now where I have already funded my retirement, put my children through college and I am looking forward to spending more time with my three grandchildren. However, if you want to recruit and keep talented, well-trained physicians and surgeons to take care of the ever-increasing backlog of patients within the County and DPH system, something must change. Your accounting experts' interpretation of the numbers are ridiculous. I think you should consider asking your experts how much it costs to care for a young twenty- or thirty-year-old patient who was permanently blinded from severe diabetic retinopathy that could have been prevented by obtaining care sooner. Ask them how much it costs to take care of someone permanently blinded by glaucoma at the age of forty or fifty years-old because of no access to the DPH clinic system due to the backlog of patients waiting for an appointment? Those patients become a chronic lifetime drain on all the resources within the County forever unless they move elsewhere or die from the complications of their diseases.

I am sorry for the rant and to be so blunt, but I wanted to share the day and life of an "oldtimer" who has seen and worked on both sides of the healthcare system, private practice, and the County's publicly provided system. We can do better; we must do better. Please step up to the plate and make a respectful and reasonable offer to our physicians and surgeons at the board meeting this week.
