Public Comment		Other	Annie Chang	Our neighbors, a caucasian couple, tenants of 1148 S Crofter Dr., Diamond Bar, CA 91789, moved in to our townhomes community on 11/15/2020. A week after, we discovered that they are not only heavy smokers, they manufacture illegal drugs inside their own townhouse. Since we share a common wall, chemicals would leak into our home as well, creating a very dangerous, unhealthy, and uncomfortable living environment. We would feel constant wooziness inside our own home. This couple are related to a well known gang. Maybe due to that they are Caucasian and we are Asian, unusual muted of our voices, even if we reported the situation many times to the Walnut/ Diamond Bar Sheriffs Department, we were rejected of our report request the first time by Deputy Lopez, and other times deputies would only come inside our home, then brushed off as there's no problem in our home. Still, the wooziness exists, to a point that our own home became uninhabitable. We're in hotels, motels, rented a studio apartment, and rented a room in a 5-bedroom house. We're even living on the streets on and off for a year. Nothing worked out. We were being gang stalked. We kept on reporting the situation to the local police and would be referred back to Walnut/ Diamond Bar Sheriff's Department. Eventually, I received an email in June 2023 stating that our community is the safest around our area, they did not find anything inside the neighbors home. However, I've never witnessed that they went to their home for investigation; we installed motion and sound sensor cameras inside and outside of our home. We should have been alerted when the cameras pick up unusual sounds as the common wall is never properly acoustically insulated from the manufacturer. But nothing triggered recordings indicating that investigations were conducted. As of to this date, February 24, 2024, I am still feeling wooziness from of gassing of this neighbor's manufacturing of drugs. These could be meth or fentanyl, I'm not able to tell as I've never taken these drugs. All I know is

During the last BSCC meeting Los Padrinos and BJN were deemed unsuitable due to the basic rights and needs of our youth inside these facilities being unmet. Within the time that we were in Sacramento giving public comment at 4pm on Thursday, two kids overdosed on fentanyl in BJN, further proving why these facilities need to be shut down and why the BOS needs to issue a state of emergency. When youth are dying at the hands of probation why was Probation given an additional \$6.6 million to increase their salaries? BOS, instead of giving Probation the funds to spend \$833,600 per year to incarcerate one young person, we should be investing in Youth Justice Reimagined, we should be investing in spaces like YJC. Despite being new to the space, I can tell you that our community is in need of places like this who provide our youth with the necessary resources that are essential to their survival. Just last week I was able to help one of our students navigate the legal system to avoid being deported and have a path towards citizenship. This is the work our community needs, not reopening inhumane facilities that are a death trap for our young. I urge the Board to declare a state of emergency, free all eligible youth in LA facilities, and fund what works, Youth Justice Reimagined. Thank you.

There is a simple solution that makes physicians feel better valued, increase recruitment success, and decrease desparity between physician benefit. It's called megaflex for all physicians. Yes, it is a monetary cost. But the benefit is worth the cost. In an environment with increasing physician shortages across specialties, dragging this out and continuing to deny COLA increases risks losing good physicians, increasing shortages and attracting inferior physicians going forward. Let's make megaflex and the cola happen and move forward.

			Kathy Cady	Victims Unite LA is a coalition of agencies and individuals dedicated to empowering crime victims and their families who have been impacted by crimes committed in Los Angeles County. We promote putting the needs of crime victims first. Victims Unite LA is writing to inform you and highlight that the parole grant
				rate for Los Angeles County is 7-8 % higher than other counties, victims' rights are being violated, and that crime victims who want to assert their right to attend these hearings must do so by themselves.
				Victims Unite LA asks that you demand that the District Attorney's Office (1) cease the "pilot" program and once again send documents to the Parole Board; (2) assist with notifying victims; (3) provide relevant information to victims to assist them in preparing for parole hearings; and (4) attend parole hearings to ensure that public safety is not jeopardized.
				Each month there are between 150-200 lifer parole hearings for inmates with commitment crimes from Los Angeles County. Defendants who are convicted of murder, attempted murder or aggravated sexual assault crimes can be sentenced to a "life" sentence. Before these lifer inmates can be released, they go through a hearing in front of the Parole Board who determines whether the inmate poses a current unreasonable risk to public safety or if he or she is "suitable" for release.

Victims/Survivors of rape, child molestation and families of murder victims have a right to attend and speak at these parole hearings. Since December 8, 2020 Los Angeles County prosecutors are no longer allowed to attend parole hearings. Victims who attend parole hearings of the person who raped them or murdered their child must do so alone.

In preparation for a parole hearing, the Board of Parole Hearings (BPH) provides the inmate's prison file to the district attorney's office that prosecuted that inmate. Prosecutors throughout the state then provide information to victims and surviving family members of murder victims to help prepare emotionally and mentally for a possible parole grant, or conversely gives them information on why the inmate continues to pose an unreasonable risk to public safety. Since July 2021, Los Angeles County prosecutors have been precluded from providing any information to victims to help them prepare for their offender's parole hearing.

Prosecutors in other counties routinely send records to the state prison to the parole board to assist them in this important task. As of July 2022, Los Angeles County, however, started a "pilot" program and no longer sends any records to the parole board. This "pilot" program, however, is "pilot" in name only as it has no parameters, measures of success or time frame for review. The result is that the parole board does not have police reports, probation reports, transcripts of the defendant's statements to police, the trial prosecutor's Statement of View, or any other information about the underlying crime with which to evaluate the inmate's credibility and recounting of the crime itself to decide whether the inmate is minimizing, denying, changing, or otherwise misrepresenting the facts of his crime or his role in the crime.

Victims, including rape victims or murder victims' family members, can register with California Department of Correction and Rehabilitation (CDCR) to get notice of parole hearings through BPH. However, only 25% of victims of crimes in Los Angeles have registered to receive notice of parole hearings. Many victims haven't registered, however, because they never thought the defendant would come up for parole. But the laws have changed.

• Prisoners who are over 50 years old and have served 20 years in custody are now entitled to an Elder Parole hearing regardless of their sentence. (Penal Code 3055).

• Anyone who was 25 years or younger at the time they committed a crime can be eligible for a youthful parole hearing after 15, 20 or 25 years. (Penal Code 3051).

• Anyone who was under 18 years old when they committed a crime and sentenced to life without the possibility of parole is eligible for parole hearing after 25 years (Penal Code 3051).

Some examples of the new parole laws include: • In a case where a 30-year-old murderer was sentenced to 60 years to life, when the inmate turns 50 years old, he is eligible for an elder parole hearing.

	<ul> <li>In a case where a 25-year-old was convicted of multiple kidnap-for-rape and rape counts and sentenced to 300 years to life, the rapist is eligible for a parole hearing after serving 25 years.</li> <li>A 17-year-old who committed multiple gang murders and was sentenced to life without the possibility of parole is eligible for a parole hearing after 25 years in custody.</li> </ul>
	Most victims, however, do not know that the parole laws have changed and that the person who raped them or killed their family member is getting a parole hearing. The District Attorney's Office was helping to notify the 75% of victims that never registered with CDCR. Although the written policy of the District Attorney's Office was that "this Office will continue to meet its obligation to notify and advise victims under California law," that changed in October 2022. The District Attorney's Office is no longer notifying victims of upcoming parole hearings. Victims who thought the person who raped them or murdered their loved one would never get a parole hearing will not be notified that a parole hearing has now been set. They have a right to attend and speak but because they don't know about the hearing, their voice will remain silent.
	Not surprisingly, not having a prosecutor at parole hearings has resulted in a substantially higher grant rate. In 2021, the grant rate was 31% when a prosecutor attended a parole hearing and 38% when a prosecutor was absent. In 2022, the grant rate was 25% when a prosecutor participated in the parole hearing but jumped to 33% without a prosecutor. What that means is hundreds of inmates serving a life sentence have been released into Los Angeles neighborhoods because a prosecutor wasn't there to represent the People, advocate for public safety or ask clarifying questions.
	The absence of a prosecutor puts the public at risk. Not providing records to the parole board endangers public safety. Victims of crime committed in Los Angeles County are treated differently from victims in every other county. Not providing victims with information on how an inmate has behaved in prison causes them unnecessary trauma and additional anxiety before the hearing.
	Victims Unite LA hopes to raise awareness of victims' concerns and provide relevant input and anecdotal evidence on topics related to crime victims and criminal justice. We are available to respond to questions or requests for information on these important issues as we have several subject matter experts with decades of experience working with victims and survivors. February 16, 2023 Regarding: Opposition to HR 6859- San Gabriel Band of Mission Indians

Executive Office of BOS,

I am writing to you on behalf of the San Gabriel Band of Mission Indians to express our strong opposition to bill HR 6859. HR6859 is a bill proposed by Congresswoman Sydney Kamlager-Dove to provide Federal Recognition to the Gabrieleno/Tongva Nation.

The Gabrieleno/Tongva Nation being represented in this bill, is **NOT** our tribe. The Gabrieleno/Tongva Nation's primary objective appears to be the pursuit of profit through gambling. Our efforts are focused on education, cultural preservation, and community development.

As the Chairman of our tribe, it is my duty to advocate for the best interests of our community, and this bill presents a significant threat to our tribe's well-being and sovereignty.

First and foremost, it is essential to understand the historical context of our tribe. The San Gabriel Band of Mission Indians has been an integral part of the Los Angeles community since time immemorial. Our tribe has a long-standing presence in this region, and we have worked tirelessly to preserve our culture, support our community, and maintain our heritage. We have established meaningful relationships with local schools, government officials, and community organizations, actively contributing to the fabric of Los Angeles. However, we are now facing a challenge from a newly formed group known as the Gabrieleno/Tongva Nation. This organization, which lacks the historical lineage and cultural ties that define our tribe, is attempting to bypass the federal process to establish a casino in Los Angeles. It is evident that this group is backed by special interest money and is solely motivated by the prospect of financial gain through the establishment of a casino.

Our tribe strongly opposes bill HR 6859 because it would enable this newly formed group to circumvent the established federal process for tribal recognition and casino development. By allowing this bill to proceed, the state would be endorsing a process that undermines the sovereignty of recognized tribes like ours and disregards the principles of fairness and equity.

In conclusion, I urge you to stand with our tribe in preserving our sovereignty, heritage, and community ties and oppose HR6859. By supporting our tribe, you are upholding the values of fairness, equity, and respect for indigenous communities. We are committed to continuing our efforts to engage with the community, support local initiatives, and preserve our cultural heritage for future generations.

Thank you for considering our concerns, and I hope to have the opportunity to discuss this matter further with you.

Victims Unite LA is a coalition of agencies and individuals dedicated to empowering crime victims and their families who have been impacted by crimes committed in Los Angeles County. We promote putting the needs of crime victims *first*.

Victims Unite LA is writing to inform you and highlight that the parole grant rate for Los Angeles County is 7-8 % higher than other counties, victims' rights are being violated, and that crime victims who want to assert their right to attend these hearings must do so by themselves.

Victims Unite LA asks that you demand that the District Attorney's Office (1) cease the "pilot" program and once again send documents to the Parole Board; (2) assist with notifying victims; (3) provide relevant information to victims to assist them in preparing for parole hearings; and (4) attend parole hearings to ensure that public safety is not jeopardized.

Each month there are between 150-200 lifer parole hearings for inmates with commitment crimes from Los Angeles County. Defendants who are convicted of murder, attempted murder or aggravated sexual assault crimes can be sentenced to a "life" sentence. Before these lifer inmates can be released, they go through a hearing in front of the Parole Board who determines whether the inmate poses a current unreasonable risk to public safety or if he or she is "suitable" for release.

Victims/Survivors of rape, child molestation and families of murder victims have a right to attend and speak at these parole hearings. **Since December 8, 2020 Los Angeles County prosecutors are no longer allowed to attend parole hearings.** Victims who attend parole hearings of the person who raped them or murdered their child must do so alone.

In preparation for a parole hearing, the Board of Parole Hearings (BPH) provides the inmate's prison file to the district attorney's office that prosecuted that inmate. Prosecutors throughout the state then provide *information* to victims and surviving family members of murder victims to help prepare emotionally and mentally for a possible parole grant, or conversely gives them information on why the inmate continues to pose an unreasonable risk to public safety. **Since July 2021, Los Angeles County prosecutors have been precluded from providing any information to victims to help them prepare for their offender's parole hearing.** 

Prosecutors in other counties routinely send records to the state prison to the parole board to assist them in this important task. As of July 2022, Los Angeles County, however, started a "pilot" program and no longer sends any records to the parole board. This "pilot" program, however, is "pilot" in name only as it has no parameters, measures of success or time frame for review. The result is that the parole board does not have police reports, probation reports, transcripts of the defendant's statements to police, the trial prosecutor's Statement of View, or any other information about the underlying crime with which to evaluate the inmate's credibility



and recounting of the crime itself to decide whether the inmate is minimizing, denying, changing, or otherwise misrepresenting the facts of his crime or his role in the crime.

Victims, including rape victims or murder victims' family members, can register with California Department of Correction and Rehabilitation (CDCR) to get notice of parole hearings through BPH. However, only 25% of victims of crimes in Los Angeles have registered to receive notice of parole hearings. Many victims haven't registered, however, because they never thought the defendant would come up for parole. But the laws have changed.

- Prisoners who are over 50 years old and have served 20 years in custody are now entitled to an Elder Parole hearing regardless of their sentence. (Penal Code 3055).
- Anyone who was 25 years or younger at the time they committed a crime can be eligible for a youthful parole hearing after 15, 20 or 25 years. (Penal Code 3051).
- Anyone who was under 18 years old when they committed a crime and sentenced to life without the possibility of parole is eligible for parole hearing after 25 years (Penal Code 3051).

Some examples of the new parole laws include:

- In a case where a 30-year-old murderer was sentenced to 60 years to life, when the inmate turns 50 years old, he is eligible for an elder parole hearing.
- In a case where a 25-year-old was convicted of multiple kidnap-for-rape and rape counts and sentenced to 300 years to life, the rapist is eligible for a parole hearing after serving 25 years.
- A 17-year-old who committed multiple gang murders and was sentenced to life without the possibility of parole is eligible for a parole hearing after 25 years in custody.

Most victims, however, do not know that the parole laws have changed and that the person who raped them or killed their family member is getting a parole hearing. The District Attorney's Office was helping to notify the 75% of victims that never registered with CDCR. Although the written policy of the District Attorney's Office was that "this Office will continue to meet its obligation to notify and advise victims under California law," that changed **in October 2022. The District Attorney's Office is no longer notifying victims of upcoming parole hearings.** Victims who thought the person who raped them or murdered their loved one would never get a parole hearing will not be notified that a parole hearing has now been set. They have a right to attend and speak but because they don't know about the hearing, their voice will remain silent.

Not surprisingly, not having a prosecutor at parole hearings has resulted in a substantially higher grant rate. In 2021, the grant rate was 31% when a prosecutor attended a parole hearing and 38% when a prosecutor was absent. In 2022, the grant rate was 25% when a prosecutor participated in the parole hearing but jumped to 33% without a prosecutor. What that means is hundreds of inmates serving a life sentence have been released into Los Angeles neighborhoods *because* a prosecutor wasn't there to represent the People, advocate for public safety or ask clarifying questions.

The absence of a prosecutor puts the public at risk. Not providing records to the parole board endangers public safety. Victims of crime committed in Los Angeles County are treated differently from victims in every other county. Not providing victims with information on how an inmate has behaved in prison causes them unnecessary trauma and additional anxiety before the hearing.

Victims Unite LA hopes to raise awareness of victims' concerns and provide relevant input and anecdotal evidence on topics related to crime victims and criminal justice. We are available to respond to questions or requests for information on these important issues as we have several subject matter experts with decades of experience working with victims and survivors.

# **Comments by Zulfiqar Ali**

# Los Angeles County Association of Environmental Health Specialists Chairperson

On Tuesday, Feb. 27, members of the Los Angeles County Association of Environmental Health Specialists plan to hold a vigil outside the Kenneth Hahn Hall of Administration, where the Los Angeles County Board of Supervisors will be meeting that morning.

The vigil will be an opportunity to grieve and honor the life and memory of our colleague Heather Hughes, an environmental health specialist II. Heather died Feb. 8 after jumping from the roof of the Koreatown building at 3530 Wilshire Boulevard, where she worked for the Los Angeles County Department of Public Health's Environmental Health Division.

As the chairperson of the Los Angeles County Association of Environmental Health Specialists, I speak for all of us in expressing our deepest condolences to her family and friends as they mourn this heartbreaking loss.

While we cannot know for certain the reasons for Heather's decision to end her life, we do know that there is deep dissatisfaction among her colleagues at the Environmental Health Division. That has been the case for nearly five years, and Heather's death has moved us to speak up to avoid another tragedy at the Environmental Health Division.

We urge the Los Angeles County Board of Supervisors to conduct its own investigation of Heather's death and the workplace conditions that have created so much stress for all of us who are working on the frontlines of our County's environmental health system.

We have shared our concerns about workplace management with the Environmental Health Division in the past. Our members previously issued a vote of <u>"no confidence"</u> in the division's management, and we have renewed this vote in the wake of Heather's death.

In 2023, an <u>employee morale survey</u> of employees in the Environmental Health Division found more than 3 out of every 4 employees had considered leaving their job because of the stress. Two out of three said they wouldn't recommend working at the Environmental Health Division.

Today, as management has acknowledged, the department is short-staffed. Its workforce is down by at least 38%, according to Dr. Barbara Ferrer. And many of us regularly work overtime. We have also seen that some of the County's restaurants have gone without an environmental health inspection for up to a year, placing the public's health at risk. Protecting the health of the County's workforce at the Environmental Health Division and the public's health requires an investigation of Heather's death and the Division's workplace conditions. We call on the Board of Supervisors to please act now and launch an investigation. To the LA County Board of Supervisors,

I am writing today, as a community member of Val Verde. As a community we are greatly affected by the decisions, members of this board made, in renewing the conditional use permit and continuing to allow Chiguita Canyon landfill to operate. The odors and toxic leachate coming from this landfill is affecting our air, water, use of our land and homes, our physical and mental health. How can you sit on this board knowing you can change the lives of residents suffering, physically, mentally & financially. The only relief residents have seen in over 10 months, was the \$2,000 max for a few electrical bills. We are paying taxes, mortgages, high electrical bills and so much more to continue to live in our homes that are making us sick. I call on this board to take bigger action to support and bring relief to the communities affected by this landfill. Yes the landfill needs to step up and support and give relief as well, but members of this board gave, and continue to allow the landfill to operate. Clearly all this board seems to care about is the money this landfill is making them. Well I for one think it is time to pay your dues to residents affected by this landfill and fast. As residents we were the ones who suggested and pushed for the little relief we have gotten. At this point, it is not our jobs to figure how to support this community, that is an administrative burden we do not need to carry. The county needs to step up and do the work and quickly to support the emotional, physical and financial burden that has been placed on this community, due to the landfill.

To the Los Angeles County Board of Supervisors: It's Time to Stand with Our County Doctors

Honorable Supervisors,

As a concerned resident of Los Angeles County, I am deeply troubled by the ongoing mistreatment of our dedicated county physicians. I've learned that these frontline heroes, who tirelessly serve our most vulnerable communities, are being undermined by those in positions of power. This is an injustice that we cannot afford to ignore.

It's a matter of basic human decency that doctors who devote themselves to public health be treated with respect and receive fair compensation. Yet, reports of understaffing, overwhelming workloads, and inadequate pay paint a picture of a system that disregards the very people it relies on. If this continues, I fear our county healthcare system designed to protect the most vulnerable will crumble.

Think of the consequences:

\* Longer waits, poorer care: Fewer doctors forced to manage more patients means delayed diagnoses, less personal attention, and a decline in the quality of care for those who need it most.

\* Exodus of talent: Why would a skilled physician put up with these conditions when they could earn more and work in a less stressful environment elsewhere? This risks creating a dangerous shortage of good doctors right here in our county.

\* A failing safety net: Our county doctors are the backbone of the healthcare system for those without insurance or with limited resources. If they leave, who will fill that void?

Supervisors, the people of Los Angeles County are depending on you. You have the power to turn this situation around. I urge you to support a fair contract for our county physicians – a contract that provides:

\* Competitive pay: These doctors shouldn't be penalized for choosing to serve our communities. Their salaries need to be in line with their skills and experience.

\* Manageable workloads: No one benefits when doctors are rushed and overstretched. Ensure they have the time to give each patient proper attention.

\* A voice in decision-making: County doctors understand the challenges firsthand. Include them in discussions about resource allocation and policy changes.

I stand firmly with our county physicians. They deserve our unwavering support, and it's critical that you champion their cause. Please, stand in solidarity with the doctors who safeguard the health of our most vulnerable, and fight for a system that truly values their essential work.

# WILL SPEED CAMERAS INFRINGE ON MY PRIVACY?

The system would be heavily regulated under the city's Digital Privacy program. Cameras would capture images of the rear license plate of vehicles traveling 11 miles per hour or more over the posted speed limit. Speed camera images would only be collected by the City and not be shared with any outside parties. If a violation were issued, images would be kept for 60 days. Otherwise, the City would delete images after five days.

I would like to see a fully revised or new ordinance/policy/legislative be presented for LA County to regulate and enforce these illegal takeovers, by ensuring education/awareness on traffic safety for youth, and acknowledging Street Takeovers is a PUBLIC HEALTH crisis. To The Los Angeles Board of Supervisors,

I am a registered nurse, I work long hours to provide life saving measures for members of my community. Yet I come home, and am subjected to the lack of protection from actions of this board. For months we have been experiencing suffocating landfill gases. And now it has come to light that the landfill has tried to illegally dispose of toxic leachate, which ironically Chiquita Canyon, a non-hazardous landfill is producing, into another landfill, which the Department of Toxic Substances Control has issued Chiquita Canyon Landfill a violation, due to the high concentration of benzene found in the leachate. The landfill and the county have acknowledged that during recent rain storms, this toxic leachate seeped into the Santa Clara River, which supplies water to millions of Californias, and feeds into the ocean. The EPA has stated that the landfill and I quote "poses an imminent danger" to the communities surrounding the landfill AND the county, to support residents both physically, mentally and financially, as this has placed extreme stress, illness and financial burdens on residents in the surrounding areas.

Honorable Supervisors,

My name is Hector Dela Cruz. I am a Chief Environmental Health Specialist in the Department of Public Health, Environmental Health and a SEIU Local 721 steward. It is my responsibility to oversee the enforcement of health regulations related food safety, housing, and public swimming pools, and to supervise the Environmental Health Specialist that execute the enforcement activities. Today, I am standing in solidarity with all Los Angeles County (LAC) Environmental Health Specialists in grieving the loss of our fellow colleague Heather Hughes. This unfortunate tragedy has amplified our concerns about the culture of the department and its impact on the workforce who provide critical services to protect the health of LAC Communities. The combination of a toxic work environment, short staffing, and the resulting burnout from heavy workloads has resulted in morale across the division to plummet to the lowest point I have ever seen and experienced in my 27 years with Environmental Health.

With an understanding the morale crisis did not occur overnight, we hope to be a part of the solution in fostering a healthy and safe work environment for ourselves and the employees we supervise. It is in this spirit that we stand in alignment with our labor siblings in asking for an investigation to be conducted by this board regarding the culture and work environment within the Department of Public Health, Environmental Health. A fresh perspective from outside of the department is the best solution in changing the culture from within. Thank you.
