LA County Holiday Events at The Music Center Fee Waiver

For decades, the County of Los Angeles (County) has hosted the Annual Tree Lighting Ceremony and the Annual Holiday Celebration at The Music Center in Downtown Los Angeles. On November 27, 2023, the annual Tree Lighting Ceremony was held on Jerry Moss Plaza at The Music Center; and on December 24, 2023, the annual Holiday Celebration was held in the Dorothy Chandler Pavilion. The event, in its 64th year, reached thousands of live audience members and tens of thousands of at-home viewers. As in the past, parking waivers were requested for both events including the mandatory rehearsals.

I, THEREFORE, MOVE that the Board of Supervisors:

- 1) Rescind Board Order No.60-E of the November 21, 2023 Board meeting agenda;
and
- 2) Waive the following parking fees for the dates listed below in Lot 14 (The Music Center Garage), excluding the cost of liability insurance, to accommodate artists,

crew and VIPs performing and participating in the Annual Tree Lighting Ceremony on Monday, November 27, 2023, from 12:00 p.m. to 8 p.m.:

- a. Waive the \$10 per vehicle parking fee for 10 vehicles for a total of \$100, on November 26, 2023;
- b. Waive the \$20 per vehicle parking fee for 75 vehicles for a total of \$1,500, on November 27, 2023, and;

3) Waive the following parking fees for the dates listed below in Lot 14 (The Music Center Garage), and Lot 16, if necessary, excluding the cost of liability insurance, for the 64th Annual Los Angeles County Holiday Celebration in the Dorothy Chandler Pavilion:

- a. Waive the \$10 per vehicle parking fee for 600 vehicles for a total of \$6,000, on December 2, 2023;
- b. Waive the \$10 per vehicle parking fee for 50 vehicles per day for a total of \$500, on December 17, 2023;
- c. Waive the \$20 per vehicle parking fee for 200 vehicles per day for a total of \$4,000, on December 20-21, 2023;
- d. Waive the \$20 per vehicle parking fee for 200 vehicles per day for a total of \$4,000, on December 22, 2023;
- e. Waive the \$10 per vehicle parking fee for 200 vehicles per day for a total of \$2,000, on December 23, 2023;
- f. Waive the \$10 per vehicle parking fee for the entire Lot 14 (The Music Center Garage) and Lot 16 if necessary, and 20 ADA valet at the main valet (AP14) for a total of \$17,460, on December 24, 2023.

- g. Waive the \$20 per vehicle parking fee for 50 vehicles per day for a total of \$1,000, on December 27, 2023; and
- h. Waive the \$20 per vehicle parking fee for 12 vehicles per day for a total of \$240, on December 28-29, 2023.
- i. Waive the \$10 per vehicle parking fee for 1 vehicle per day for a total of \$10 on December 30, 2023.
