The emissions are above the threshold's that our Federal Government has set. The work by the landfill to mitigate the impact to our health is negligently tepid, at best. In researching the landfill I stumbled across information that the Landfill received Toxic Waste from the Santa Clara Waste Water Treatment facility in Santa Paula (37 treated after 'bizarre' chemical explosion in Santa Paula - Los Angeles Times (latimes.com)) (SCVNews.com Grand Jury, Feds Say Hazardous Materials Shipped to Chiquita Landfill 08-05-2019).</p> <p>How is it possible that AFTER this EPA violation the Chiquita Landfill use WAS EXTENDED IN APRIL OF 2017? Once the Grand jury's report was available in 2019 why was the Landfill not forced to close.</p> <p>The Chiquita Landfill's toxic gas emissions have forced me to cancel my life out of doors. On the days when the VOC's (as recorded by the Purple Air Monitors (Val Verde Air Monitoring Program, a Nonprofit Citizen Science Group Val Verde, Castaic, Valencia (vvamp.org)) are above 75 my wife (a two time cancer survivor) is unable to work outside because her asthma is too bad. After the VOC's reach above the 100 to 125 the odor from the toxic gases are too much. If I wanted to live at a dump site I would be a hog farmer. I worry that the toxic gases will have consequences on my life, both physical, mental, and financial. My wife is in daily fear that her cancer will reemerge – causing her panic and stress. My 26 year old son is showing signs of Asthma – problems he did not have until early last summer. There are some days when my boys cannot walk the family dog. And I am sure that the value of my home is decreasing daily.</p> <p>I would ask "Why is the Landfill still accepting waste? When will you actually protect the people that you are sworn to protect? When will you work for the people and NOT THE CORPORATIONS?"</p> <p>I understand that you need donations to thrive in a political environment, but there is a time and a place, this is the TIME to take care of your constituents.</p> <p>Somewhat respectfully Thomas Frohling</p>

Leaving doors or windows open, to allow fresh air into our house, is no longer an option for us.</p> <p>We have mistakenly placed our trust in the BOS, to protect our health, safety and the quality of life for our families and fellow residents. Pleas for help and support have gone unanswered for months, if not years.</p> <p>CCL has been issued several citations from various government agencies, such as the AQMD and The Department of Toxic Substances Control. CCL has been issued no less than five "Class 1" citations for shipping mislabeled hazardous waste to a non hazardous waste disposal site. One would think that these five citations, along with the thousands of citizen's complaints to the AQMD, as well as the numerous Notices of Violation (NOV's), issued by the AQMD to CCL, would be ample evidence to compel The County to shut down the CCL. Were this any other business, which did not contribute to the coffers of The County Government, such business would certainly be shut down, post haste.</p> <p>Most recently, a CCL employee was injured, and sent to the local emergency hospital, while working, after hours, in the dark of night, in an attempt to pump toxic "leachate", from on-site storage containers, into a tanker truck. It seems strange that such an important part of remedying this situation can only be performed in the dead of night.</p> <p>The communities trust in CCL and the BOS has been completely lost. For the BOS to allow the CCL to continue to operate business as usual, further demonstrates the lack of concern, if not utter contempt, felt by the BOS towards this community. The Chiquita Canyon Landfill, its toxic gasses, Leachate, and dilapidated facilities have destroyed my community. We are forced to keep our windows closed in a desperate attempt to block out the volatile organic gasses; we've seen our health deteriorate, and our homes devalued to devastating lows. Chiquita Canyon Landfill has failed to maintain their facilities and follow the regulations to protect their neighbors, my community.

According to the EPA, there have been multiple times when Benzene gas levels have exceeded what is considered safe. They have found gas wells that were in disrepair or fixed with duct tape. They also found toxic, hazardous levels of Leachate escaping from Chiquita Canyon Landfill's property. Recently, a hose filled with Hydrogen Peroxide burst, severely harming an employee and causing community concerns that their might be an explosion. Fear was rampant in our community because we have learned not to trust our not so good neighbor, Chiquita Canyon Landfill.

This is a real harm to the health of the Val Verde, Castaic, and surrounding communities. Our children, who's lungs are still developing, study and play outside in these toxic VOCs. Chiquita is not taking proper care of their equipment and facilities to prevent this from happening.

I request you close Chiquita Canyon Landfill. It is your job to protect our health. As per the EPA'S report, our community, and our children are in imminent danger. You have the power to close the dump. It is literally it is your job to protect our health!

I'm a resident of Hasley Hills and have been bedridden with debilitating headaches, nausea, vertigo, and ear pressure for over a year straight.

I have voiced my concern, frustration and need for immediate help to the BOS office many times and I've yet to see anything come of it.

I am sick, my pets are sick. We are prisoners in our own home and terrified of what's to come.

Doctors don't know what to diagnose or to prescribe. They've never seen my conditions before and can only offer sympathy and well wishes. No prescribed medication has helped. It's evident the medical professionals are aware there is a local health issue but have no clue as to how to treat it.

I've only received insincere sympathy from the BOS office and La County entities, tons of excuses and too many pointing of fingers in another direction.

It's been a cat and mouse game since I made the connection btwn my sudden illnesses and the Chiquita Canyon Landfill.

Since receiving their letter on my door step in August 2023, I have been painfully made aware that my basic human right to live and breathe in my own home was being denied.

The letter admitted to a Toxic Leak and verified my home address qualified for a free air purifier issued by the landfill.

The letter demanded a full address, name and phone number for registration. I found this to be intrusive and with a possible hidden agenda. Why had they not delivered the air purifier with the letter?

Earlier that morning (before seeing the letter) for the first time ever, I smelled it. I abruptly woke just before sunrise to the most foul chemically induced odor I've ever experienced in my life. We had slept every night with the bedroom windows wide open since purchasing our forever home and this day, the smell was so strong that I instinctively knew to get up and close the windows and patio door immediately.

While my family slept peacefully, I worried about what it could be but later shrugged it off as a one off event.

That day I learned of an entity called SCAQMD. Neighbors from all over had posted a phone number to call in the odor complaint. I was in shock!

The next day I drove all the way to West La just to get to the closest Dyson store. I purchased a carbon air filter unit which cost me over \$1300.00. The largest size they had only covered half my house.

Days later, barely able to breathe and certainly not well enough to drive to work, I crawled my way out of the house and headed down the hill to the fire station for the “free” air filter.

I was disappointed they were so tiny and only were meant for 300 sqft of enclosed space.

I have an open concept home @3400 sqft of living space. Why and how would I decide whose bedroom or bathroom would get it?

I asked for additional units and was denied.

“One per household”, is what I was told.

I placed my name on a list for the notification of the second wave.

Never received another notification from the landfill.

I did call the landfill myself several times and always got an out of state message taker. Never a call back.

Recently, through the advice of other community members, I decided to call the landfill again. I was extremely ill, I couldn't sleep and was at my wits end. I demanded a call back this time and I believe because I was in tears and had nothing to lose, I did get that call back.

I had a lengthy conversation with a woman named Nicole who stated she had no knowledge of anyone getting sick from the landfill, no employees were sick, and she repeatedly stressed “we are doing all things we were told to do”. The conversation wasn't going anywhere and actually taking a turn for the worse. It became evident to me that she had been coached into what and what not to say. I ended that call and vowed never to waste my time in calling back again.

Fast forward to today, I am reflecting on everything I've done or could've done.

I recycle, I reuse, I don't support fast fashion, I even compost!

I've been composting way before the city mandate and the issue of those hideous bins!

I am reflecting on the hundreds of hours of my precious life spent curled up in bed in tears thinking what have I done to deserve this?

“I just need to rest”, “tomorrow I will feel better”,

“I overdid it today in the garden”, “why did I think I could cut my own grass?”

“I shouldn't have eaten that salad, that must be why I have stomach pains and diarrhea every day?”

Every day for the past 2 years or more??! I've lost track of the last time I felt well.

The last time I smiled, laughed, was genuinely happy. I'm in a prison. It's very beautiful inside, but a prison nonetheless.

I've spent thousands of dollars on tests, medical professionals and medical bills, lotions and holistic approaches, herbs, home remedies, otc allergy meds, food eliminations, strict diets and insane limitations. My skin is inflamed. My blood is dirty.

Most days, I feel like I need to be on respirator, in a wheelchair, and a calming bath all at once.

It's criminal to find out I have been being poisoned by the landfill the entire time I thought I was "resting" at my home.

Not even during the mandatory lock down of the pandemic did I feel so trapped. My husband and I spent our entire life's savings to buy this home. I love it and the day we viewed it I told my husband, "If we buy this house, I will never ever ask you for anything ever again, not even a vacation!". Boy did I put my money where my mouth was. The irony.

I've never had any intention of leaving it until I found out about this landfill. Everything and everyone I love is inside my home already.

Now, leaving is the only thing I can think of.

I am forced to leave my home every single day just to breathe.

I must pack up my family including my pups and for a minimum of (5) hours a day, I have to ensure we are out of the immediate area.

Otherwise, we suffer from great physical consequences. My symptoms include: vomiting, coughing, burning eyes, blurred vision, excruciating ear pressure, nausea, bloody nose, skin irritation, hair loss, muscle weakness, disorientation, ringing in ears, swelling, weight gain, tremors, internal vibrations, teeth grinding, jaw locking, misalignment of jaw, sensation of being on a rocking boat, diarrhea, stomach cramping, chest pain, heart palpitations, trouble breathing, etc. I could go on forever.

My dogs suffer daily as well. I've seen the tremors so bad that their entire body lifts off the floor. The vertigo so bad they randomly walk sideways. There is also the obvious, not being able to be dogs! Their time outside is limited to 2 minutes per day. They are randomly vomiting out of nowhere and constantly have stomach issues no matter what they eat. In fact the vomiting is just clear liquid. They have difficulty breathing at night especially and the sneezing which is constant (day and night) is quite scary to observe. The violent sneezing is gives whip lash and averages between 5-8 in a row. My dogs weigh a combination of 11 lbs. combined; I have to rush to secure their necks during the sneezing attacks. They are 12 and 13 years old and lived with us for the same. Each day I fear may be the last. Every 52 days equals a full year in a dog's life. How many more years are you robbing from us? The vet that they've been going to since they were pups can't figure it out and all we get are expensive rounds of antibiotics that do not work.

I've run out places to go.

I've run out of money to get there.

I am suffering now from the anxiety of having to come back home every day.

I want my bed and the comforts of everything that makes my house a beautiful home BUT, I want it without the toxic air that hovers over it!

Katheryn Barger's office has received hundreds if not thousands of health reports and complaints from local residents over the years and she has done nothing about it. I know for a fact there are dozens just from me!

What alarms me the most about her is finding out that instead of shutting this landfill down when it was contracted to close, she approved for the expansion of it. She has done nothing to prevent unsuspecting young families from moving into this mess either.

This whole disaster could have been avoided if she and the other powers that be just obeyed the law.

There is no way Los Angeles County approved the expansion of the landfill or the massive amount of new building permits surrounding the landfill without her signature.

We now have an environmental disaster, and many people are now stuck with million dollar mortgages and astronomical property tax bills for a property they can't even be in.

You can't put a price on your health.

Our health is our wealth and putting us in the middle of a known toxic environment, she is an accomplice of crime. Whether I paid \$200.00 or \$2 million for my property, I deserve to be able to breathe in it!

Never in my wildest dreams would I have imagined I'd have to decide between my health, safety, well-being and the American dream.

Close the landfill. No more need for data checks or updates. We have enough sick people and those reports trump any other data reports you could doctor and water down. Chiquita will not take immediate action to fix the issues if they are operating at full capacity. Close it down at least temporarily until my headaches, nausea, tinnitus, tremors, fatigue and sicknesses stop!!!! Stop abusing your constituents and stop abusing our rights to breathe!

I need to get back to living my life, I need to get back to my work and I need to sleep peacefully in my own home.

Kathryn Barger is advocating for the landfill to remain open. Why? The residents of Val Verde are suffering! Why is a big corporation more important than the residents who live here? Stop choosing profit over people! I fear for my children's lives on a daily basis. Will they get sick again today? Will they be safe at school? Are we safe in our own home? Will there be long term health effects? Will the landfill explode or catch fire and take us out with it? These are real concerns that my neighbors and I worry about every single day.

Barger has requested that the landfill issue air filters to the residents. We have received those air filters and they do not help, not even a little. We do not breathe any easier and our symptoms still persist. The air quality continues to get worse and we still do not have answers or any type of solution.

Barger has requested that more testing be done for toxins in the air and potential health concerns. We do not need more testing. We do not need more data. That does not help the people NOW. We are the data. We do have health concerns, they are not potential. My children and I are experiencing frequent headaches, burning eyes, nose bleeds, hives all over our bodies that cannot be explained. And that's just the tip of the iceberg. For a year this has continued! This is not living. This is abuse!

Barger has asked that the residents be reimbursed for their electric bills, which included only a few months out of the year of 2023. While this gesture was welcomed and appreciated, it isn't enough. We are running our AC 24/7 to filter out the toxic air. This issue has been going on for almost a year, with no end in sight. Our house runs on solar. We normally get money back from the energy

we produce with our solar panels. That did not happen this year. We are paying out of pocket because all of the solar energy was used up to run our AC. Nobody is reimbursing us for our solar energy. Not to mention, any money that residents are given for reimbursement, they are taxed on. Why are we being taxed on money that was ours to begin with, that we were already taxed on?!

Barger called on the landfill to relocate residents. Why now? We've been asking for this from the beginning. Is it because elections are coming out and she hopes we will vote for her? The damage is already done. People are already sick. My children have already been put at risk.

Also, why should we have to move? Why are we paying for the landfill's mistakes? Relocation may remove us from the toxic gasses, which I welcome, but what about the stresses of uprooting my family? What about my children who attend school here, are involved in sports and dance, have friends here? What about my animals? Where are we supposed to go? And for how long? My husband and I moved here because Val Verde is unique. You can actually see the stars at night because this town isn't polluted with light. It's hidden between giant hills. There's wildlife and trees, the people are friendly and truly care about each other. It's peaceful. The schools are great and highly rated. You're far enough from the main town to feel like you're out in the country, yet we have access to stores and restaurants and entertainment within a 10 minute drive. You can't find anywhere else like it in Los Angeles. The landfill has taken all of this away from us. We thought we were making a better life for our children, but instead we have all been put in harms way and nobody is protecting us! This is a nightmare situation!

The landfill should have never been approved to have their contract extended. They should have closed down years ago. It is very clear that Chiquita Canyon Landfill has been mismanaged for a very long time. Kathryn Barger should have never approved to extend the landfill's contract, but she did. Kathryn Barger, LA county, and Chiquita Canyon Landfill have shown negligence and disregard for human life. The Chiquita Canyon Landfill should be shut down and cleaned up immediately, so that the beautiful town of Val Verde can begin to heal and move forward.
