I fully support the recommendations:</p> <ol style="list-style-type: none"> 1. To undertake a needs assessment of both individuals with Cerebral Palsy and their caregivers to understand how the County can better serve them; 2. To identify County resources available both to individuals with Cerebral Palsy and to their caregivers; 3. To evaluate existing County programs for the purpose of improving outreach and awareness efforts; and, 4. To gather demographic data and rates of incidence among various categories of County residents for the purpose of developing a resource guide. <p>As a Chicano raised by monolingual Mexican immigrant parents and as an individual with multiple disabilities myself, I fully understand and appreciate the need for equitable access to critical services that support people with disabilities and their families.</p> <p>And, as a father of two young adult sons with disabilities and chronic medical conditions, I have first-hand experience struggling to navigate multiple systems of care without the assistance of caring and informed individuals, particularly those in the public sector.</p> <p>As such, I firmly believe the County has a moral imperative and legal obligation to work proactively with key community-based, faith-based and other non-governmental organizations to assess and address challenging issues.</p> <p>Moreover, I would ask that the Board consider, at a later date, a more comprehensive motion (based on the findings of this preliminary report) that explores providing robust employment and training opportunities, affordable healthcare, long-term services and supports, and transition services for individuals with Cerebral Palsy and other neuromuscular diseases.</p>
