failures and assistance of Criminals.**

To Whom It May Concern at [County's Name] County Public Comment,

I am a resident of Rosemead, served by the Temple City Sheriff's Department, reaching out to express grave concerns and seek urgent assistance regarding the multiple failures of the Sheriff's Department, District Attorney's Office, LA Court, and other related agencies in handling a series of criminal acts committed against my family and me since 2019 and continuing into 2023.

Since 2019, my family has been subjected to unlawful home invasions, vandalism, robbery, and even kidnapping perpetrated by known individuals, Joseph Brandstetter and Sara Stark. Despite providing substantial evidence, including video footage and documentation, to the Temple City Sheriff's Department, our pleas for justice have been met with consistent inaction and negligence.

In January 2023, these issues were exacerbated when Joseph and Sara unlawfully invaded our home again, utilizing forged documents to claim residency. The Sheriff's Department's response to these crimes was characterized by a disturbing lack of action

and accountability. Their failure to file charges, combined with the loss of crucial evidence and refusal to acknowledge our reports, has not only endangered my family's safety but also underscored a systemic failure within the department to protect the community it serves.

Moreover, the LA County District Attorney's Office has failed to prosecute Joseph and Sara, despite the overwhelming evidence presented. This lack of prosecution has facilitated further victimization and perpetuated our nightmare. The LA Court and other agencies have similarly failed in their duties, contributing to a justice system that appears to protect criminals rather than victims.

These cumulative failures have left my family living in constant fear, eroding our trust in local law enforcement and the justice system at large. It is unacceptable for residents to fear for their safety within their own homes, especially due to the inaction of the very agencies entrusted with our protection.

I am therefore submitting this comment to request a comprehensive review and immediate action to address these failures. We seek accountability for the negligence shown by the Temple City Sheriff's Department, the LA County District Attorney's Office, the LA Court, and other involved agencies. It is imperative that steps are taken to rectify these injustices, ensure the prosecution of Joseph Brandstetter and Sara Stark, and implement systemic reforms to prevent such failures from recurring.

Our family, and indeed all residents of [County's Name] County, deserve to live in a community where safety and justice are upheld by those sworn to protect us. We look forward to your prompt attention to these matters and to seeing meaningful changes that restore our faith in our local justice system.
