If it didn't take a crisis team 8 hours to come to my home February 18, 2021 perhaps I wouldn't have needed to call 911 the following day when my son's meltdown exacerbated, and I wouldn't be typing this sitting in a hotel room that is trafficking children because i've lost EVERYTHING fighting for my son and STILL the county, state, and country ignores the very severe issues that need IMMEDIATE attention. The lack of oversight within Child Protective Services where they allow their workers to physically abuse children with video proof and do nothing allowing the workers to continue, where they lie to the courts and steal children without warrants. The clear and insanely concerning mental health crisis, the absolute homelessness emergency, the covid crisis and housing funds millions have yet to receive and are living in tents because it appears these tax dollars have unjustly enriched our public servants rather than assist with ensuring our community was able to move forward after the unconstitutional lockdowns. That there is a chain of hotels with the worst reviews, massive lawsuits, failed compliance with health and building codes that are trafficking children, cooking drugs, and instigating crime in cities across the county. In fact, Extended Stay America in Long Beach has been reported to over 20 agencies, I know because i've done the reporting. Not a single entity has stepped in. I sat in my room as a TEENAGER shot himself in the head in front of his three younger brothers hearing the gun go off..watching the sirens flood the parking lot, and then the coroner. The teenager had been being molested by staff for years. It had been reported a multitude of times, instead this county did nothing and allowed this poor little boys mental health to decline to the extend of needing to end his life in front of his three young brothers. Every board of supervisor knows exactly who is writing this public comment. I anticipate this not even being public because that's the amount of transparency we have in this county. You're public servants working for the people. I have a copy of every single one of your oaths of office and surety bonds. It appears you have all violated your oaths to the United States Constitution . No one needs "employee wellness through arts day".
