Our neighborhood has had many vehicles stolen and dumped in our streets, and the sheriff has come out and taken them. The only thing a public works employee will do is ticket the vehicle, and that will only create a bigger problem. Public works are unreliable, and it takes weeks to get other problems solved. We have had 6 or 7 RV's parked in Athens Park, and many neighbors reported it, including myself, and nothing has been done. It's been over a month! We do not know who these people living in these RVs are. It's dangerous because many kids at the park are exposed, and we don't know if they are pedophiles. The issue with parking inforcement is not one that we can wait on, especially with stolen or abandoned vehicles. So no! Public works should not take over parking enforcement. This will be a nightmare for our communities.
