SPECIFICATIONS OF THE ELECTION ORDER

The election shall be held on Tuesday, November 5, 2024. The polling hours shall be from 7:00 a.m. to 8:00 p.m on multiple days at the Voting Centers leading up to Election Day.

Trustee Area 1 and Trustee Area 3

The purpose of the election is to submit to the voters of the district the question of whether 2 members shall be elected to the Governing Board of the Antelope Valley Community College District.

The Los Angeles County Registrar-Recorder/County Clerk (Registrar-Recorder) will perform all the duties incident to the preparation for and holding of the above-mentioned election. The <u>Antelope Valley Community College</u> District will pay the costs of the election. If any agency holds an election on November 5, 2024, the **Antelope Valley Community College** District shall pay its pro rata share pertaining to the conduct of this election and shall be under the provisions of the appropriate sections of the Education and Election Codes.
