TO ORDER A SPECIAL GOVERNING BOARD ELECTION**

Order of Special Election of Lancaster School District of Los Angeles County, California

RESOLUTION ORDERING A SPECIAL GOVERNING BOARD MEMBER ELECTION

RESOLVED that pursuant to Education Code (EC) §§5000-5030, the Los Angeles County Superintendent of Schools (County Superintendent) is hereby ORDERED to call a consolidated special election for the purpose, and in accordance with the designations contained in the following specifications of the Election Order made under the authority of EC Sections §5093, §5302, §5304, and §5322.

SPECIFICATIONS OF THE ELECTION ORDER

The election shall be held on Tuesday, November 5, 2024. The polling hours shall be from 7:00 a.m. to 8:00 p.m. on multiple days at the Voting Centers leading up to Election Day.

The purpose of the election is to submit to the voters of the District the question of whether one (1) member shall be elected to the Governing Board of the Lancaster School District, in trustee voting area four (4) for a two-year term until Nov. 2026 at which time a new four-year term will be filled at its regular scheduled election.


The Los Angeles County Registrar-Recorder/County Clerk (Registrar-Recorder) will perform all the duties incident to the preparation for and holding of the above-mentioned election. The Lancaster School District will pay the costs of the election. If any agency holds an election on November 5, 2024, the Lancaster School District shall pay its pro rata share pertaining to the conduct of this election and shall be consolidated under the provisions of the appropriate sections of the Education and Election Codes.

IT IS FURTHER ORDERED that the Clerk of the District is hereby directed to furnish two copies of this order to the County Superintendent of Schools not less than 130 days prior to the date set for the election.


