I am writing to express my strong support for the motion submitted by Supervisor Horvath regarding the development of a **Zero-Emission (ZEV) Vehicle Master Plan for Los Angeles County**. As a Clean Transportation for All Senior Field Organizer with the Sierra Club, I believe that transitioning to a zero-emission fleet and expanding electric vehicle (EV) charger infrastructure is crucial for both environmental and economic justice.

In order to ensure environmental justice, it is essential that the ZEV Plan includes strategies to promote EV ownership in low-income communities and ensure equitable access to infrastructure.
