**RESOLUTION NO. 2023/24-19
TO ORDER BIENNIAL GOVERNING BOARD ELECTION**

Order of Election for the **Santa Clarita Community District** of Los Angeles County, California.

RESOLUTION ORDERING GOVERNING BOARD MEMBER ELECTION

RESOLVED that pursuant to Education Code (EC) §§5000-5030, the Los Angeles County Superintendent of Schools (County Superintendent) is hereby **ORDERED** to call an election for the purpose, and in accordance with the designations contained in the following specifications of the Election Order made under the authority of EC §5302, §5304, and §5322.

SPECIFICATIONS OF THE ELECTION ORDER

The election shall be held on Tuesday, November 5, 2024. The polling hours shall be from 7:00 a.m. to 8:00 p.m. on multiple days at the Voting Centers leading up to Election Day.

The purpose of the election is to submit to the voters of the district the question of whether **three** members shall be elected to the Governing Board of the **Santa Clarita Community College District**.

AREA 2 TRUSTEE 2024-2028 SANTA CLARITA COMMUNITY COLLEGE DISTRICT (Trustee Alonso)

AREA 3 TRUSTEE 2024-2028 SANTA CLARITA COMMUNITY COLLEGE DISTRICT (Trustee Cazares)

AREA 4 TRUSTEE 2024-2028 SANTA CLARITA COMMUNITY COLLEGE DISTRICT (Trustee Danielsen)

The Los Angeles County Registrar-Recorder/County Clerk (Registrar-Recorder) will perform all the duties incident to the preparation for and holding of the above-mentioned election. The **Santa Clarita Community College District** will pay the costs of the election. If any agency holds an election on November 5, 2024, the **Santa Clarita Community College District** shall pay its pro rata share pertaining to the conduct of this election and shall be under the provisions of the appropriate sections of the Education and Election Codes.

IT IS RESOLVED THAT, pursuant to Elections Code Section 13307, candidates requesting a Candidate's Statement, limited to 200 words, printed and mailed to the voters, shall be required to pay the actual prorated cost thereof, except that the District shall pay any costs of translating such Candidate's Statement into Spanish.


IT IS FURTHER ORDERED that the Clerk of the district is hereby directed to furnish two copies of this order to the County Superintendent not less than 130 days prior to the date set for the election.
