LA can then turn these buildings into affordable housing once the Olympics are over. One issue that can stem from the Olympics are housing being turned into short term rentals. This would exacerbate our County's housing shortage even further. We are already seeing thousands of units of housing being converted to short-term rentals throughout the County. We have some strict ordinances, but the issue is enforcement. We do not have a strong County-wide enforcement mechanism to prevent illegal short term rentals.
