RESOLUTION NO. 23-24/019

Policy on Filing of Candidate Statements for District Elections

WHEREAS, a governing board election is scheduled to be held in the Centinela Valley Union High School District on November 5, 2024; and that two members, **Trustee Area 3** and **Trustee Area 4**, of the Governing Board are nominated by the district and elected at large; and,

WHEREAS, Elections Code Section 13307 permits a local agency to require payments in advance of each candidate's pro rata share of the printing, handling, and mailing costs of their candidate statement as a condition of having it included in the voter's sample ballot pamphlet; and,

WHEREAS, the district also has the option of increasing the word limit for these statements from 200 to 400 and that this decision may not be revoked or modified after July 5, 2024 for the upcoming November 5, 2024 General Election; and,

WHEREAS, if the district determines payment is required in advance, the County of Los Angeles Registrar-Recorder/County Clerk's office will estimate the cost and will collect the fee at the time the candidate statement is filed; and,

WHEREAS, should the district elect not to have candidates pay in advance, cost of the statement will be considered an election cost and charged to the district pursuant to Section 5420, et seq. of the Education Code. The district may then, pursuant to the governing board's policy, collect from the candidate or bear the cost, if not reimbursed.

NOW, THEREFORE, BE IT RESOLVED that the governing board of the Centinela Valley Union High School District adopts the following policies regarding filing of Candidate Statements for district elections (indicated by an X mark).

Number of Words Allowed: 200 or 2 400

A Payment of the estimated cost must be made by the candidate at time of filing. □ School District will bear the cost for all statements.

□ School District will bill candidate after the elections.


