The Los Angeles County Registrar-Recorder/County Clerk (Registrar-Recorder) will perform all the duties incident to the **Palmdale School District** preparation for and holding of the above-mentioned election. The **Palmdale School District** will pay the costs of the election. If any agency holds an election on November 5, 2024, the **Palmdale School District** shall pay its pro rata share pertaining to the conduct of this election and shall be under the provisions of the appropriate sections of the Education and Election Codes.

IT IS FURTHER ORDERED that the Clerk of the district is hereby directed to furnish two copies of this order to the County Superintendent not less than 130 days prior to the date set for the election.
