The members of that TTECAC</p> <p>Chairs a transitional executive committee formally made by staff during the Emergency COVID-19 regulations on in person meetings have all met their tenure years ago however only 3 chairs got ripped from their seats and told since they moved out of the region they represented the seat they represented had to be taken away and a exclusive election of only those 3 chairs had to be carried out excluding all other chairs who met their tenure. As one of those co-chairs I don't disagree and as residential Stakholder member but, I do feel a formal election for all chairs should have been carried out and the emergency exclusion of all public meetings throughout the county should rightfully be given back by the staff and they should be able to vote on all changes that effect them. But, they were openly denied with no Roberts Rule of order practiced. Budget spending in the county and due to the county's new Covid 19 non-emergency regulations the fiscal years budget will not be rolled over so the money will be completely taken away and we are starting with a smaller 2024-2025 fiscal year budget.
