## A DEMAND FOR THE TRANS WELLNESS AND EQUITY CARE INITIATIVE

Re: Trans Wellness and Equity Care Initiative

Trans Rescue Action is a social welfare non profit in West Hollywood; our mission is to help TGI siblings relocate to Southern California to flee dangerous living conditions in their home states brought on by over 600 anti-trans bills across the nation in the first six months of this year alone. **The overwhelming amount of anti-trans bills has increased physical violence and the murders of TGI siblings**.

The state of California has been a sanctuary state for trans youth since 2022. Among cities within LA County, West Hollywood declared itself as a trans sanctuary city in April 2023. According to the National Alliance to End Homelessness, 50% of all trans Americans who are unhoused live in California, and LA County has the highest concentration. It is disgraceful that West Hollywood currently has no programs to substantiate its claim as a trans sanctuary city. With the median annual income of \$91,000, West Hollywood is not affordable for most trans people who as a group have an alarmingly high rate of poverty and unemployment.

The Trans Wellness and Equity Care initiative has been long overdue to save TGI lives. **We demand** the County Board of Supervisors work with the community to develop and implement programs that reflect the needs of the most underrepresented and underserved, and make sure that the money goes to where it's needed.
