Supervisors,

SEIU Local 721 appreciates the County's willingness to collaborate with our union during the initial phases of the Centennial Development Project ("the Project"). The Project has an opportunity to provide hundreds of sustainable, dignified career opportunities to an area of Los Angeles County historically devoid of such opportunities. Our union supports modifying the Exclusive Negotiating Agreement to ensure enough time is allotted to maximize the economic and social well-being of the surrounding community. This letter serves to reaffirm our union's support and willingness to partner with the County and the development team throughout the development of the Project to ensure its ultimate success.

SEIU Local 721 and our more than 55,000 Los Angeles County members strongly encourage the County to adopt the following recommendations for the development and ultimate construction of the Project.

1. Respect the future workforce's right and ability to unionize under fair conditions by requiring any future contractor, subcontractor, operator, or lessee to enter into Labor Peace agreements with any labor organization(s) representing or seeking to represent their employees.
2. Utilize County employees to provide services at any future facilities or programs created as a result of the Centennial Development Project.
3. Establish regular meetings with Local 721's leadership, staff, and members to ensure that planning incorporates robust input from frontline employees.

We acknowledge and appreciate your commitment to ongoing collaboration to ensure that LA County provides the highest quality and most comprehensive continuum of care to the County's most vulnerable residents.
