The purpose of the election is to submit to the voters of the district the question of whether <u>2</u> members shall be elected to the Governing Board of the <u>Wiseburn Unified School District</u>.

The Los Angeles County Registrar-Recorder/County Clerk (Registrar-Recorder) will perform all the duties incident to the preparation for and holding of the above-mentioned election. The <u>Wiseburn Unified School District</u> will pay the costs of the election. If any agency holds an election on November 5, 2024, the <u>Wiseburn Unified School District</u> shall pay its pro rata share pertaining to the conduct of this election and shall be under the provisions of the appropriate sections of the Education and Election Codes.
