RESOLUTION 23-21 TO ORDER BIENNIAL GOVERNING BOARD MEMBER ELECTION

Order of Election of ABC Unified School District of Los Angeles County, California

RESOLVED that pursuant to Education Codes (EC) §5000-5030, the Los Angeles County Superintendent of Schools (County Superintendent) is hereby ORDERED to call an election for the purpose, and in accordance with the designations contained in the following specifications of the Election Order made under the authority of EC §5302, §5304, and §5322.

SPECIFICATIONS OF THE ELECTION ORDER

The election shall be held on Tuesday, November 5, 2024. The polling hours shall be from 7:00 a.m. to 8:00 p.m. on multiple days at the Voting Centers leading up to Election Day.

• The purpose of the election is to submit to the voters of the district the question of whether four members shall be elected to the Governing Board of the ABC Unified School District.

The Los Angeles County Registrar-Recorder/County Clerk (Registrar-Recorder) will perform all the duties incident to the preparation for and holding of the above-mentioned election. The ABC Unified School District will pay the costs of the election. If any agency holds an election on November 5, 2024, the ABC Unified School District shall pay its pro rata share pertaining to the conduct of this election and shall be under the provisions of the appropriate sections of the Education and Election Codes.

IT IS FURTHER ORDERED that the Clerk of the District is hereby directed to furnish two copies of this order to the County Superintendent not less than 130 days prior to the date set for the election.

<u>BACKGROUND INFORMATION</u>: Pursuant to Education Code Sections §5000-5030, elections will be held on November 5, 2024 to elect members to governing boards in most of the school districts in Los Angeles County. School boards are required to take action to initiate a regular biennial governing board election by the adoption of a resolution ordering the board member election.

<u>SPECIFICATIONS OF THE ELECTION ORDER:</u> The election shall be held on Tuesday, November 5, 2024. The polling hours shall be from 7:00 a.m. to 8:00 p.m. on multiple days at the Voting Centers leading up to Election Day.

 The purpose of the election is to submit to the voters of the district the question of whether four members shall be elected to the Governing Board of the ABC Unified School District.

The election on November 5, 2024, will be held to fill the expired terms of Trustee Area 1: Dr. Michael Eugenio, Trustee Area 4: Brad Beach, Trustee Area 5: Sophia Tse, and Trustee Area 7: Francisco Noyola.

Each candidate will pay in advance his/her pro rata share of printing, handling, and mailing costs of the candidate's statement of qualifications included in the voter's pamphlet (Education Codes §5000-5030.)
