I have received two parking tickets in the last two years for legally parking my vehicle using a handicapped placard. Each time, I have appealed the ticket. I won the first one in court and expect to win the second one in the near future. Both tickets should have been reversed during the administrative appeals process, but whomever judges these matters in that process just rubber stamps the tickets as justified. I should not have to pay the fine plus the \$25 appeal fee and spend time appearing in court, to get someone to realize bad tickets are being issued. The County needs to reform this Department and look hard at the types of tickets it is writing so that the public is not further harmed by its actions.

This has been an ongoing issue since 2020. Several residents in the area have contacted parking enforcement and were told "since they are occupied by homeless people they cannot be towed. We are also aware this is not a city or county ordinance. On August 13th some of the residents had a meeting with Holly J. Mitchell's representatives April Johnson and Bennie Williams to address these issues about the RVs but have not seen any results. We also reached out via emails regarding any follow-up meeting but still no meetings have been set. We would like to have our voices heard on the upcoming agenda meeting September 24,2024.
