Oppose	Monisha Parker	<p>Dear Board of Supervisors,</p> <p>I am writing to express my deep concern regarding the exorbitant prices charged for commissary items in the Los Angeles County Jail system. The current pricing structure imposes an undue hardship on inmates and their families.</p> <p>Access to affordable commissary items is essential for the health and well-being of inmates. These items supplement the inadequate food provided by the jail, allowing inmates to meet their nutritional needs. Additionally, commissary items provide a sense of comfort and connection to the outside world.</p> <p>However, the current pricing is simply unaffordable. Basic items, such as ramen noodles, toothpaste, and deodorant, cost multiple times their retail value. This forces inmates to make difficult choices between basic necessities and hygiene.
