People Over Profit: Fairness and Equity in Commissary Prices for the Los

Angeles County Jails

The Los Angeles County (County) Board of Supervisors (Board) have taken a strong stance on equity, fairness, and accessibility for the most marginalized communities and acknowledging the inequities that surround mass incarceration and the tremendous fiscal burden of incarceration on families. Over the course of two years, multiple motions were unanimously supported by the Board, and last year, LA County became one of the largest jail systems in the country to move forward with providing free phone calls in the jails. Alongside these moves, the Board also denounced fiscal inequities with the overpriced commissary items, doing so as far back as May of 2021, which parents and incarcerated people are forced to pay to supplement meals and clothing and access better hygiene items.

Though changes to contracts with Keefe Commissary Network (KCN) were instituted to ensure fairness and no profit mark-ups, the most recent prices listed in the

“Los Angeles County General Population Housing Menu” from December 2023, which is attached, says otherwise. Examples of the overpriced food and drink items include: 3-ounce, Beef Ramen pack for \$1.60; 12 ounces of Water for \$1.43; 8-ounce package of Flour Tortillas for \$6.05; 4.23-ounce pouch of FC Chunk Light Tuna for \$8.58; 12.5-ounces of Keebler Club Crackers for \$10.95; 8-ounce bag of Cheetos Flamin’ Hot for \$6.46. The same for hygiene items, such as: 3.5-ounce bar of Neutrogena Soap for \$5.53; 12-ounce container of Pantene Classic Clean Condition for \$10.28; and 10-ounce container of Vaseline Cocoa Butter Lotion for \$9.50. Alongside the prices, there is a weekly spending limit of \$195, which includes a limit of \$40 in vending cards plus an unknown additional handling fees and the 9.5% tax.

Just as it was the Board’s intent to stop profiting from families and incarcerated people when it made phone calls in the jails free, the same should be true of the costs and fees attached to commissary items. Anecdotally, there are numerous complaints about the quality and quantity of foods regularly provided to those in custody, including those with special diets or religious diets, and many need to supplement their meals with commissary items because the meals received in the jails are lacking. This issue has been highlighted as a concern by the Office of Inspector General and other external oversight entities, people who are incarcerated and their families.

WE, THEREFORE, MOVE that the Board of Supervisors:

1. Request the LA Sheriff’s Department to provide the Board with a report back, in writing, in 45 days, with, at minimum:
 - a. Steps and actions LASD has taken in response to previous motions passed by the Board designed to address overpriced commissary

- items in the County jails, including eliminating profit mark-ups on items;
- b. Updates on how LASD continues, if at all, to ensure commissary prices are not overpriced;
 - c. An implementation plan, to ensure all commissary prices, especially food, drinks, and hygiene items are on par with grocers and retailers.
 - i. In collaboration with the Sybil Brand Commission, identifying items that are culturally competent and inclusive of different hygiene needs, including availability of gender-affirming products.
 - ii. In collaboration with the Chief Executive Office, provide a funding plan by Supplemental Budget Phase, including utilizing AB 109 funds and other available and appropriate funding sources to supplement any additional costs, if needed.
2. Direct the Office of Inspector General to review LASD's report back, as requested in Directive 1, within 30 days of issuance, and provide the Board with a report back, in writing, with an assessment and updates on LASD's progress on the removal of the profit mark ups and reduction of prices on commissary items in its quarterly report to the Board, until completion or further notice.
 3. Request the LA Sheriff's Department and direct the Office of Inspector General, to present to the Sheriff Civilian Oversight Commission at the next Sheriff Civilian Oversight Commission meeting, following the issuance of the report back from OIG, on the status of removing the profit mark ups and

reducing prices on the commissary items.

- Weekly Inmate spending limit is \$195.00. This includes a limit of \$40.00 in Vending cards plus handling fees.
- One Web Order allowed per week. Maximum spending limit is \$68.00. This spending limit is separate from commissary.
- Total cost of your order will be deducted from your trust account.
- The current 9.5% Sales Tax will be added to applicable items.
- We reserve the right to limit orders.
- Hygiene Maintenance Kits, Indigent Kits, Indigent eye glasses and Indigent haircuts received from KCN will be charged to your account if and when you have a balance in your trust fund account. Inmates will be considered indigent when their account balance reaches \$2.00 or less.

Storage of Inmate Personal Effects/County Property

All inmates within any Custody Division Facility **shall** store all personal and county issued property with the exception of a sheet and blanket, in an inmate property bag. **All property (excluding bedding) must fit inside one inmate property bag, any excess property will be considered contraband. The inmate shall be given the choice of which property they wish to dispose of without compensation.** The only exception applies to pro per inmates which may request additional bags to store their legal paperwork.
