Dear Supervisors:

I am writing on behalf of All Saints Church Foster Care Project in support of Housing Supports for Foster Youth (Item 12).

The Foster Care Project is a faith-based organization: a ministry of All Saints Church in Pasadena that recruits volunteers and provides resources for thirty-seven agencies serving foster, homeless, and justice-involved children and youth. Although our programs for in-person volunteers is slowly resuming after having been on hold during the pandemic, prior to 2020 we annually recruited more than 140 volunteers to serve as mentors, tutors, coach-monitors, special friends, or personal shoppers for more than 1,000 young people. Through our Birthday Club and Angel Tree Christmas Program with DCFS, we provided gifts to another 1,000. Our family reunification program, Family Connect, served as a model for the County. We had seven donated family visitation sites, and contracts with six part-time consultants.

For the past twenty years the Foster Care Project has worked very closely with the Department of Children and Family Services (DCS), primarily with the Pasadena Office. Several mentors have worked with Transition Age Youth (TAY) social workers in the Pasadena DCFS office, other faith-based organizations, and local community colleges; they are well aware that, as indicated in the Board motion, that around 50% of youth leaving foster care may experience homelessness or housing instability. We are also familiar with the challenges youth face in accessing the limited number of Foster Youth to Independence (FYI) Initiative and Family Unification Program (FUP) vouchers; in completing the labor intensive Public Housing Authority's application process, in and identifying property owners who will accept the vouchers. We are also aware of the fears of becoming homeless that haunt many high school and college aged students.

We commend the authors of the motion for envisioning an administrative structure which will not only coordinate the work of county departments and agencies serving TAY youth but will also identify financial support for these programs, improve training for DFS and probation staff, support the development of life skills relevant to housing stability, prioritize housing for parenting youth, and engage the philanthropic community. We urge you to support Housing Supports for Foster Youth (Item 12).

Dear Madam Chair Horvath & Honorable Supervisors Solis, Mitchell, Hahn & Barger,

We write as staff employed at UCLA, speaking on our own behalf, in reference to Item 12, authored by Supervisor Barger and co-authored by Chair Horvath.

As your honorable Board is aware, the FYI housing choice vouchers are currently underutilized across Los Angeles County and within the City of Los Angeles. As of November 2023, the Los Angeles County Development Authority (LACDA) managed 139 FYI vouchers with a 44.60% utilization rate, while the Housing Authority of the City of Los Angeles (HACLA) currently manages zero FYI vouchers.

In addition to underutilization, a UCLA Pritzker Center research study has also shown that even for young people who have a voucher, geographical limitations and lack of support to locate and lease apartments make using the voucher difficult, if not impossible. Moreover, the FYI process is characterized by delays and uncertainty, according to both young adults and case managers interviewed in our study. These challenges are compounded by other obstacles frequently experienced by foster youth, including discrimination based on race, gender or sexual orientation, limited familial support and minimal financial security.

The authors of the motion propose solutions that systemically address these challenges. We applaud this effort and thank Supervisor Barger and Chair Horvath for their targeted efforts to improve housing stability for youth impacted by foster care. Accordingly, we urge a unanimous vote of support for Item 12.
