I also want to thank Supervisors Solis and Horvath for supporting the motion to establish a Right to Counsel. As a renter, I strongly support a Right to Counsel ordinance. Please vote in favor.
			Karla Perez	As a renter, I strongly support a Right to Counsel ordinance. No one should EVER be evicted without legal representation. Right to Counsel is about reducing homelessness, access to equity and justice in court, and the benefits that everyone experiences when our communities have housing stability. An eviction case will never be equitable if landlords are almost always represented and less than 10% of tenants have legal representation. Right to Counsel paired with strong eviction protections levels the playing field for tenants and landlords in court, stabilizes our communities to provide better outcomes for all residents, and creates cost savings through the prevention of increased displacement and homelessness. 			Shantel Daniels	I vote in favor of renters having the right to access to public council.
			Silvia Marroquin	LA is facing an eviction crisis with nearly 50,000 eviction cases filed in Los Angeles in 2023, with cases continuing to increase this year. Without legal representation, tenants will wrongfully be evicted and the number of people who are homelessness will increase. Right to Counsel will save the County money. A 2019 report found that for every dollar invested in RTC, nearly \$4.53 will be saved by the County by preventing people from falling into homelessness and the costs associated: shelter costs, hospitalizations, school absences, healthcare, etc. Right to Counsel is about creating access to equity in courts. Landlords are nearly always represented while less than 10% of tenants receive legal representation. Right to Counsel is about racial justice and economic justice. A majority of tenants facing eviction are Black or People of Color, and Right to Counsel programs have been shown to improve racial justice outcomes of the eviction system. We applaud Supervisors Mitchell and Solis for introducing this motion and urge all Supervisors to vote in favor.
