Re: Item 17 -Safeguarding Older Adults from Scamming Practices and Financial Abuse

Dear Honorable Board of Supervisors:

We write with respect to Agenda Item No. 17 to urge the Board of Supervisors to fully adopt this recommendation for the empowerment and protection of the older adults, dependent adults, and their caregivers. For the past 50 years, Bet Tzedek has been at the frontlines of serving the legal needs of senior and dependent adults. When Bet Tzedek established the Elder Justice Unit in 2017 to combat the increasing prevalence of elder abuse it did so with a dedicated team member to elder abuse outreach and education. We did so because we understand that combatting the stark increase in elder abuse requires bringing visibility to nature and patterns of this insidious type of abuse. The power of education and community outreach should not be underestimated. Education programs take away the power from abusers by providing community members trustworthy information. Additionally, education programs go beyond providing information and connect community members with legal tools that will better insulate them for abuse. For example, through our elder abuse education programming "Safe and Savvy Seniors" Bet Tzedek has been able to connect seniors with estate planning tools that serve to better safeguard an individual's assets. Our recently launched Caregivers Empowerment campaign connects with support groups to dispel myths around Medi-Cal which bad actors use to prey upon the worries of older/dependent adults and their caregivers.

By adopting item 17, the county's education campaign will create an additional safety net for older/dependent adults and caregivers. We stand ready to offer technical assistance to support the objectives of this recommendation and applaud the county for their vison and proactive steps to combat elder abuse.
