So the youth stays in camp or juvenile hall pass their times. Some youth do follow the rules and want to go home. DPO's have recommended that youth go home early but can't because of the RFA process not complete. Sometimes up to months waiting time for the youth. That is incompetence and the only thing the Chief cares about is the BCSS reports allowing him to keep the juvenile halls open. Then you take our field DPO's and deploy them to juvenile hall. You are allowing the communities to suffer because you have someone in charge that does not know how to administer a probation program. How can he leave the communities without DPO's to report criminal activity by someone in probation when they are deployed. He has made DPO's stay home when they could be at juvenile hall doing desk or paperwork duties. The board should check the MOU's before and after the sending of the DPO's home. How can the Chief justify only having one person working to clear homes for the youth to come to. His incompetence is threaten a lawsuit by youth and families of Los Angeles County.

I am an Anonymous Deputy Probation Officer II. I would like to make a comment regarding agenda item 9, 10.

First of all, the Board of Supervisors have no clue regarding public safety. You have continuously put the public at risk. 95% of these youth in the juvenile detention facilities have committed violent crimes mostly for murder. The Board of Supervisors have used unsound executive decisions to tear the Probation Department down. Stop listening to these uneducated ex-convicts who just simply want a payday. Something must give. Programming implementation or movement of these youth can not BE ATTAINED WITHOUT OFFICER SAFETY. I was brutally attacked and almost murdered because I was attempting to implement the recreation schedule all while preventing an escape and making sure every child was fed a hot tray. After my brutal attack, not one manager called 911.

I do not appreciate the dangerous working conditions that management has allowed towards my Deputy Probation Officers who place their lives on the line every day, while maintaining some type of order at Los Padrinos. The Deputies are putting in the grunt work. If Officer safety is not at the forefront on these two agenda items, then they can not be passed. Stop ignoring the fact that hundreds of officers are on leave because they were violently and brutally attacked by criminal youth in our care. The best thing your friend Guillermo ever did was re-implement pepper spray and got rid of the bureau chiefs in the Probation department.

Now, our Chief is barely regaining his employees trust so you ladies need to really protect law enforcement or else some of you ladies will be voted out. The victims' families will speak for our communities. There are hundreds of victims who were murdered by the kids in our care, and I could have been murdered. I know firsthand how violent these "kids" can be. The racist gang-violence against officers and youth-on-youth violence must stop.

Here are some possible solutions to pass your agenda items.

1. Re-implement the Special Handling Unit.
2. Officer Training on self-defense such as jujitsu or kick boxing.
3. Re-implement Handcuffing training.
4. Hire more Detention Service Officers. (Stop calling us Staff. We are sworn Peace officers who keep the community safe).

5. Do not hand our dept off to DYD or fake CBO's. They have never put in the work.
6. Give credible messengers clearance for a pathway to employment into the Probation department. But the ARC credible messengers need to put in the work and will need medical insurance because they can get brutally assaulted especially since most of them have former gang ties.
