Indeed, never has the need been greater. Because of economic pressures, news media have had to cut back on coverage of local government. Social media does not provide much of a remedy. Citizens have to pick out nuggets of valid material from a slurry of misinformation. By definition, opponents and proponents of a measure do not provide impartial analysis: whatever they tell the public reflects their ideological, partisan, or material interests. 				I write to support the idea that ballot initiatives have a non-partisan statement of fiscal and programmatic impact. I am a Professor of Political Science and African American Studies at UCLA. I also serve as the Director of the Ralph J. Bunche Center for African American Studies. I am a resident of Culver City in Supervisor Holly J. Mitchell's Second District. My academic research focuses on racial/ethnic political behavior, African American politics, women and politics, immigrant political incorporation, and state and local politics.
				I believe that the placement of a nonpartisan fiscal statement during the ballot process may serve to inform voters from various backgrounds. This provides the information voters may need to make better informed decisions regarding their support or opposition to ballot initiatives.
				One of the most remarkable aspects of California politics is the number of ballot initiatives and the long history of these kinds of initiatives in the State. However, it is concerning that L.A. County ballot measures do not have impartial analysis and summaries of their fiscal impact, while statewide ballot measures do. The vast, well documented, literature in political science on California ballot initiatives, such as Prop 13 of 1978, has shown that such ballot measures have a significant and continued fiscal impact. If L.A. County allows voters to review a non-partial fiscal statement for its county initiatives, it may also lead to greater trust in the process, across various groups. ## **Statewide Ballot Title and Summary Process**

The Attorney General prepares the "Ballot Title and Summary" and the "Condensed Ballot Title and Summary" (which is combined with approved lists of supporters and opponents by the Secretary of State to create the official "Ballot Label" which appears on all ballots throughout the state) for each statewide ballot measure (proposition).

The fiscal statement included in both the Ballot Title and Summary and Condensed Ballot Title and Summary/Ballot Label is provided by the Legislative Analyst to the Attorney General prior to submission to the Secretary of State 123 days before the statewide election.

A sample of the Ballot Label and Ballot Title and Summary for Proposition 1 in the March 2024 Primary Election is below, followed by a sample of how the title and summary appeared in the State Voter Information Guide for Proposition 1.

Proposition 1 November 3, 2023 SB 326/AB 531

#### BALLOT LABEL

The Secretary of State has no position on the proposal, but after talking with the Initiative and Ballot Measure Coordinator in the Legislative Analyst's Office, I can share with you that the proposal mirrors the state process in a few critical areas:

- 1. Requires a fiscal analysis for all ballot measures
- Dissemination of information in all required languages
- 3. Provides a Yes/No vote summary on ballot measures, so that voters understand the practical effect of voting a measure up or down
- 4. Requires input from stakeholders which informs both the fiscal and the program analysis
