**RESOLUTION TO ORDER BIENNIAL GOVERNING BOARD ELECTION ON
NOVEMBER 5, 2024**

RESOLVED, that pursuant to Education Code (EC) §§5000-5030, the Los Angeles County Superintendent of Schools is hereby ORDERED to call an election for the purpose, and in accordance with the designations contained in the following specifications of the Election Order made under the authority of EC §5302, §5304, and §5322.

WHEREAS, the election shall be held on Tuesday, November 5, 2024. The polling hours shall be from 7:00 a.m. to 8:00 p.m. on multiple days at the Voting Centers leading up to the Election Day

WHEREAS, the purpose of the election is to submit to the voters of the district the question of whether two (2) members shall be elected to the Governing Board of the Bassett Unified School District; and


WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk (Registrar-Recorder) will perform all the duties incident to the preparation for and holding of the above-mentioned election. The Bassett Unified School District will pay the costs of the election. If any other agency or agencies hold an election on November 5, 2024, the Bassett Unified School District shall pay its pro rata share pertaining to the conduct this election and shall be under the provisions of the appropriate sections of the Education and Election Codes.

BE IT THEREFORE RESOLVED, that the Clerk of the district is hereby directed to furnish two copies of this order to the County Superintendent not less than 130 days prior to the date set for the election
